Happy Independence Day!

This month we start out with our big, patriotic holiday, the 4th of July, when we celebrate the signing of the Declaration of Independence! Except that members of the Continental Congress didn't start signing it until August 2nd. George Wythe signed it on August 27th. Richard Henry Lee, Elbridge Gerry, and



Oliver Wolcott signed it on September 4th. Matthew Thornton signed it on November 19th but Thomas McKean didn't get around to it until 1781. The document that we know as the Declaration of Independence didn't even exist in its current form until Congress directed that it be engrossed (formally handwritten) on parchment on July 19th. Are we celebrating Congress voting for independence? No, that process started on June 7th when Virginia representative Richard Henry Lee introduced a resolution calling for the colonies' independence from Great Brittan. That led to the drafting of the declaration, mostly by Thomas Jefferson with changes by Benjamin Franklin and John Adams between June 11th and July 1st. The actual vote for independence happened on July 2nd when the Lee Resolution was approved by 12 of the 13 colonies (thanks New York!). That led to John Adams writing to his wife Abigail on July 3rd to tell her,

"The Second Day of July 1776, will be the most memorable Epocha, in the History of America. I am apt to believe that it will be celebrated, by succeeding Generations, as the great anniversary Festival. It ought to be commemorated, as the Day of Deliverance by solemn Acts of Devotion to God Almighty. It ought to be solemnized with Pomp and Parade, with Shews, Games, Sports, Guns, Bells, Bonfires and Illuminations from one End of this Continent to the other from this Time forward forever more."

So what are we celebrating on the 4th? That's the day that congress adopted the final changes to the document and sent it to the printer. Consequently, July 4th is the date listed on the document. The printer, John Dunlap, printed about 200 copies with John Hancock's signature at the bottom as he was president of the Continental Congress. Known as the Dunlap Broadside (a broadside is printed on one side of a large sheet), those copies went by the catchy name of, "A Declaration by the Representatives of the United States of America, in General Congress assembled". The copy written on parchment on the 19th changed the title to," The Unanimous Declaration of the Thirteen United States of America" (New York got with the program on the 9th making it unanimous). As Bob Fields mentioned in the Bunker's 4th of July announcement, Independence Day would be considered Traitor's Day from the British perspective. While enjoying potato salad, fried chicken, fireworks and an abundance of adult beverages, it is easy to overlook the risky path that our founders took. They had far more at stake than being un-friended on King George's facebook page. They pledged, "their lives, fortunes and sacred honor" in pursuit of liberty. Of the 56 signers of the Declaration of Independence, five were captured by the British and brutally tortured as traitors. Nine fought in the Revolutionary War and either died of wounds or hardships. Two had sons killed in the war and two others had sons captured. At least a dozen had their homes pillaged and burned. It has been 248 years since then and, as was stated in the Constitution in 1790, we have been working to "form a more perfect union" ever since.








In our recent wars in Iraq and Afghanistan more women were in harms way than ever before in our conflicts. Here is the story of just one of these hero's.

Corporal Jennifer Parcell was killed on February 7, 2007 when a female suicide bomber entered her check point. Cpl Parcell's Dress Blue uniform, seen here, includes her posthumous Purple Heart medal." displayed at the National Museum of the Marine Corps

Marine Cpl. Parcell was assigned to Combat Logistics Regiment 3, 3rd Marine Logistics Group, III Marine Expeditionary Force, Okinawa, Japan. Parcell died while participating in the Corps' Lioness program. The Lioness program uses female Marines from different military occupational specialties to search Iraqi women at checkpoints. Parcell was killed when an Iraqi woman she was searching detonated an explosive vest she was wearing. Jennifer graduated from Fallston High School in 2004 where she excelled in math. A couple of years ago, she went to Parris Island and watched the Marine graduation services for her older brother, Joseph. That is when she decided she wanted to be a Marine. She joined the Corps in January 2005 and became a landing support specialist for combat operations. Jennifer was a petite dynamo and always on the go. Even in Iraq, she was taking a course at University of



Maryland and took yoga classes. Helping others was also something she always did. She sponsored an African child through a mission charity and when an earthquake devastated Pakistan last year, she and others in her unit were dispatched to the scene - she earned the Humanitarian Service Medal for her efforts. March 1 was when she was scheduled to leave Iraq and return to Okinawa. Jennifer always loved the water, including boating and scuba diving. She also liked yoga, music and spending time with family and friends. She planned to leave the Marines and attend college when her tour ended in 2009. The following is how Jennifer described herself –

About me:

"I think that I'm overall a pretty small person. I love to have fun doing nothing at all. Specially just chillen with good friends. I love Yoga! But mostly I lay around and watch movies. Yes I am in the Marine Corps, but its a lot of fun sometimes. I'm currently stationed at Okinawa, Japan Camp Foster. I hang out with Landing Support Company all the time, we always eat at CoCos and chill at Third Floor. Not much else to do in Oki before 12 o'clock."

Jury Nullification: A Hidden Power in the Justice System (submitted by Joe Filice)

You are sitting on a jury. The evidence is compelling, the defendant appears guilty but you don't feel that the law is fair, not properly applied under the circumstances or the penalty is too harsh. You have taken an oath to impartially consider the evidence and the law and the judge has issued instructions that seem to leave you no other options. In spite of all of your misgivings, you must render a guilty verdict... or must you? Meet Jury Nullification, which has also been called "Conscientious Acquittal". A 1996 article in LITI-GATION referred to it as the "Top Secret Constitutional Right" even though there is no mention of it in the constitution.

What is Jury Nullification?

Jury Nullification is when the Jury returns a Not Guilty verdict even though the jurors believe, beyond a reasonable doubt, that the defendant is guilty. If all jurors return a not guilty verdict, the defendant is acquitted and normally can't be tried again due to double jeopardy. If the jury is split then the judge can declare a mistrial and the defendant could be tried again.

A little history.

Jury Nullification can be traced back to English Common law and William Penn's trial of 1670. William Penn was accused of preaching Quakerism, which was illegal. There was clear evidence against William Penn but the jury voted to acquit, much to the dismay of the trial judge. That lead to the jurors being arrested and fined for contempt of court. One of the jurors, Edward Bushel refused to pay the fine. This led to the Bushel Case and a decision that jurors cannot be punished for their verdict. Individual jurors can still be held accountable for misconduct. Prior to the American Civil War, Jury Nullification was used by abolitionists to protest enforcement of the Fugitive Slave Act. During the 1920's, Jury Nullification was used for the somewhat less noble purpose of protesting prohibition by acquitting smugglers and bootleggers.

Why is it a secret?

In some jurisdictions the judge will inform the jurors about Jury Nullification but in many, they won't. It gives a power to the jury that some judges and lawyers are unwilling to share. Depending on the circumstances, informing an active juror about Jury Nullification could be seen as jury tampering.

A double-edged sword.

From DC Comic's Spiderman we have the proverb, "with great power comes great responsibility". If you prefer, there is also the 1817 quote from British Member of Parliament William Lamb, "the possession of great power necessarily implies great responsibility". In either case, Jury Nullification has the power to fight tyranny, right wrongs and assure justice but, used inappropriately, it could destroy the rule of law and usher in anarchy. Except in very special cases, the jury won't know about criminal history or other factors not—directly related to the current case. Before letting that nice looking Capone-fella off on those silly tax charges because you don't like taxes either, remember that there may have been information that the rules of evidence did not allow to be presented. Jury Nullification is a power that should be used cautiously but it is only a power if you know about it. Now you do.



Congress Establishes a Permanent USMC

The Marine Corps celebrates its birthday as 10 November, 1775 when two companies of Marines were authorized to be raised by the Continental Congress. Legend has it that Tuns Tavern in Philadelphia is venue where the first Marines were recruited (however, in all probability, it was the Conestoga Wagon Publick House).

The order to raise two companies of Marines was not a law that was established a permanent US Marine Corps. In fact, the Marines disbanded following the cessation of The Revolutionary War (1776-1783) hostilities with Britain.

On 27 March, 1794, President George Washington signed legislation authorizing the construction of six heavy frigates for the US Navy. Frigates were smaller than ships-of-the-line but larger than sloops. They represented a unique combination of power, speed, and tactical versatility. They were fast enough to outrun more heavily armed ships, but well-armed enough to mix it up with their opposite numbers in foreign navies, and overwhelm any smaller vessels. These were the first keel up built man-o-wars for the fledgling Navy. Four of these would be rated for 44 guns, and the remaining two would be rated for 36 guns. The long cannon were to be 24 pounders, making these vessels quite formidable. The ships were named *United States, President, Congress, Constitution, Constellation*, and *Chesapeake*.

It took several years to build these ships in such diverse places as Boston, NY, Portsmouth, Baltimore, Philadelphia, and Norfolk. Knowing that these vessels had to have a Marine contingent on board, on 11 July, 1798, President John Adams approved "An Act for Establishing and Organizing a Marine Corps", and it became law. The following day, the President appointed Major William Ward Burrows the Commandant of the new Corps. In August, Major Burrows opened his headquarters in Philadelphia, at that time still the capital of the new nation.

William Ward Burrows, second Commandant of the Marine Corps (the first was Major Samuel Nicholas), was born in Charleston, South Carolina, on 16 January, 1758. He served in the Revolutionary War with the state troops of South Carolina, but later become a resident of Philadelphia. On 12 July, 1798, the day following the approval of an act of Congress establishing a permanent United States Marine Corps, President Adams appointed Burrows as Commandant of the newly created organization which then consisted of 881 officers, noncommissioned officers, and privates.

The Marine Corps, as well as the Navy, had had its humble beginning a short time prior to its actual authorization as a Corps and both were formed to meet an impending national crisis. The first Marine units to be organized by Burrows were ship detachments for newly built six frigates of the American Navy, which were being built as quickly as possible placed in


commission, and hurried off to sea to fight warships and destroy commerce in an undeclared naval war with France that was flaring in the Caribbean. During the first several months that he was Commandant, Burrows' principal concern was the supplying and keeping up to strength the Marine detachments for the vessels of the Navy.

Headquarters of the Corps was in camp near Philadelphia until the national capital began its move to Washington in 1800. A small detachment of Marines was sent to the new capital in March of that year to protect the newly-established navy yard, while Burrows, with his staff and headquarters troops, moved to Washington in late July and set up their camp.

Major Burrows was promoted to lieutenant colonel on 1 May 1800. The Quasi-War with France continued until September of that year, when matters finally settled down. The insistence of Congress that the cost of the naval establishment (Navy and Marine Corps) be immediately reduced caused considerable embarrassment to Burrows in his effort to establish the Marine Corps on a peacetime basis. However, the wars with the north African Barbary States broke out soon afterwards and the Corps concentrated on supplying detachments to naval vessels for duty in the Mediterranean.

Lieutenant Colonel Burrows is credited with beginning many of the Corps' institutions, including the U.S. Marine Band, which he financed in part by levying contributions from his officers. He demanded high standards of professional performance and personal conduct of his officers, and these have become hallmarks of the Corps. Ill health forced his resignation on March 6, 1804.

Lieutenant Colonel Burrows died at the age of 47 in Washington, D.C., on March 6, 1805. He was buried in the Presbyterian Cemetery, Georgetown, in the District of Columbia. His remains were re-interred in Arlington National Cemetery on May 12, 1892.

Contrary to popular belief, the US Flag/USMC flag lapel pin is not authorized to wear on any MCL uniform, it never has been authorized to wear on any MCL uniform.

- 5. Kennel Devil Dog of The Year pin.
- 6. National Associate Member of The Year pin.
- 7. Past Department Commandant or Past Detachment Commandant pin.
- 8. Chapel of Four Chaplains pin.
- 9. MCL Membership pin (to include any anniversary MCL membership pins).
- 10. Retired Marine or Retired Navy pin.
- 11. MCL or MODD Life Member pin.
- 12. Ordained Minister or Ordained Chaplain symbol pin.
- 13. Vietnam War 50th Commemoration pin.
- 14. Gold Star Family pin.
- 15. Next of Kin Deceased Personnel pin.

At no time will the crossed US Flag/USMC flag pin be worn with any MCL uniform.

MARINE CORPS HISTORY IN JULY

4 July 1801: President Thomas Jefferson reviewed the Marines, led by the Commandant of the Marine Corps, LtCol William W. Burrows and the Marine Band, on the White House grounds. The smartly uniformed Marines performed drills and fired various salutes in observance of the new nation's 25th anniversary.

6 July 1990: One of the oldest and most versatile attack aircraft in Marine Corps history, the A-4 Skyhawk, retired from the Corps' active aviation structure after over 30 years of service. The last two Skyhawks from MAG-32 flew their initial flight from Cherry Point to NAS Patuxent River on this date.



- **7 July 1941:** The 1st Marine Aircraft Wing was activated at Quantico, Virginia. Within a year of activation, the Wing would participate in the Marine Corps offensive at Guadalcanal. That bitter campaign would be the first in a series of legendary battles in which the Wing would add luster to its reputation. The 1stMAW would earn five Presidential Unit Citations for gallantry in campaigns spanning World War II, Korea, and Vietnam.
- 11 July 1798: President John Adams approved "An Act for Establishing and Organizing a Marine Corps", and it became law. The following day, the President appointed William Ward Burrows the Major Commandant of the new Corps. In August, Major Burrows opened his headquarters in Philadelphia, at that time still the capital of the new nation.
- 14 July 1993: The USS IWO JIMA was decommissioned after over 30 years of service in a ceremony at Norfolk Naval Base, Virginia. The ship was named for the World War II battle during which three Marine divisions ousted 20,000 entrenched Japanese troops. The Iwo Jima was commissioned 26 August 1961, and it was the first ship specifically designed as an amphibious assault ship from the keel up.
- **18 July 1918:** The 4th Brigade of Marines began an attack near Soissons, France, as part of a three-division counterattack against the Germans. In the first two days of battle, the brigade sustained 1,972 casualties.
- **24 July 1944:** The V Amphibious Corps, commanded by Major General Harry Schmidt, landed on Tinian, in the Mariana Islands. The following morning, the 2d and 4th Marine Divisions began a shoulder-to-shoulder southward sweep of the island. Organized enemy resistance faded within a week, and on 1 August, MajGen Schmidt declared the island secure.
- **26 July 1947:** The National Security Act of 1947 became effective, reaffirming the status of the Marine Corps as a separate military service within the Department of the Navy. The Act Provided for Fleet Marine Forces, and confirmed the Corps' mission of seizing and defending advanced bases, as well as land operation incident to naval campaigns.
- **28 July 1918:** Brigadier General John A. Lejeune assumed command of the 2d Division, U.S. Army in France, and remained in that capacity until August 1919 when the unit was demobilized. He was the first Marine officer to hold an Army divisional command, and following the Armistice, he led his division in the march into Germany

The President of the United States takes pleasure in presenting the CONGRESSIONAL MEDAL OF HONOR posthumously to

STAFF SERGEANT WILLIAM J. BORDELON UNITED STATES MARINE CORPS

for service as set forth in the following CITATION:

For valorous and gallant conduct above and beyond the call of duty as a member of an Assault Engineer Platoon of the First Battalion, Eighteenth Marines, tactically attached to the Second Marines, Second Marine Division, in action against the Japanese-held Atoll of Tarawa in the Gilbert Islands on November 20, 1943. Landing in the assault waves under withering enemy fire which killed all but four of the men in his tractor, Staff Sergeant Bordelon hurriedly made demolition charges and personally put two pill boxes out of action. Hit by enemy machine-gun fire just as a charge exploded in his hand while assaulting a third position, he courageously remained in action and, although out of demolition, provided himself with a rifle and furnished fire coverage for a group of men scaling the seawall. Disregarding his own serious condition, he unhesitatingly went to the aid of one of his demolition men, wounded and calling for help in the water, rescuing this man and another who had been hit by enemy fire while attempting to make the rescue. Still refusing first aid for himself, he again made up demolition charges and single-handedly assaulted a fourth Japanese machine-gun position but was instantly killed when caught in a final burst of fire from the enemy. Staff Sergeant Bordelon's great personal valor during a critical phase of securing the limited beachhead was a contributing factor in the ultimate occupation of the island and his heroic determination reflects the highest credit upon the United States Naval Service. He gallantly gave his life for his country.
