The National Board of Trustees has the fiduciary responsibility for the operation and budget requirements of the Marine Corps League. The last time fees were adjusted was 19 years ago. The National Board of Trustees voted and approved the following:

Effective 1 July 2023, the Life Membership Fees will increase as per the following chart:

- \$1000.00 35 years of age and lower
- \$ 800.00 36-50 years of age
- \$ 600.00 51-64 years of age
- \$ 400.00 65-84 years of age
- \$ 100.00 85 years of age and higher

The above Fees are only available if the member's annual dues have been paid and the member is in good standing.

#### Marines and The Battle of Seattle, 1856

The Battle of Seattle was a 26 January, 1856 attack by Native Americans upon Seattle, a settlement in what was then known as the Washington Territory.

The clash of arms was an unqualified victory for the US military. Backed by shipborne artillery fire and supported by Marines from the United States Navy sloop-of-war Decatur, the battle lasted one day. Two settlers died. Native American casualties were believed to be 28 dead and 80 wounded. But why did the clash take place?

In the months leading up to the unrest, several local settlers were murdered, it was assumed by local Indians. Weeks later, with a large number of Indians congregating in the area of Seattle and rumor that there would be a large attack, the USS Decatur, with its' attachment of Marines, was dispatched to the area. The Decatur was a Sloop-of-War built in 1838-1839, assigned to the Pacific Squadron since 1854. She weighed 566 tons, had a length of 117' with a beam of 32', draft of 15'8" and a maximum speed of 10 knots in stiff wind. Her overall crew complement numbered approximately 150. Her armament consisted of 16 cannon: fourteen 32-pounders, and two 12-pounders. The ship was commanded by Guert Gansevoort.

Leading up to the engagement, the Marines, sailors and officers of the Decatur put a great deal of energy into preparing for the battle. Defensive revetments were constructed and the divisions of sailors and Marines, all skilled in battle, occupied shore posts at night, when it was anticipated the Indians would attack, and returned to the ship during the day for meals and sleep.

The settlement, approximately three-quarters of a mile wide, was defended by 119 men of the Navy and Marines: ninety-six sailors, eighteen marines (the Captain of the Decatur's personal guard), and five officers, leaving a small contingent of about 20 to guard the ship and man several of the cannon. The land defense force was augmented by about two dozen of the settlers acting as militia.

The night of 25 January was heavily overcast and misty. While uncomfortable for the crew and Marines on watch, the weather was calm and advantageous for detecting the furtive approach of the enemy.

At 2000, two Indians closely wrapped in their blankets, sauntered slowly by a main defensive position, apparently from the friendly Indian encampment in town. When a few paces away they were challenged by a militia member named T.S. Phelps to give their names and business. They replied, "We were at Lake Tillicum, and were [out] to visit friends..." They were ordered to keep within bounds, otherwise they were liable to be shot.

Within an hour an imitation of an owl's hooting was heard directly in front of the Marines and sailors, which immediately afterwards received responsive hoots from both right and left making known the enemy's proximity. A supposedly loyal Indian scout was sent beyond the settlement into the wilderness to collect information. Returning approximately two hours later, he reported that there were no warrior Indians present in the woods and that an attack that night was impossible.

Headquarters had been established at a home in the settlement, and while there, the Indian scout earlier sent into the woods displayed a marked change from his usual manner, giving an impression to one

observer that he was now beyond being trusted. Later, when the Indian scout went out to his own encampment he was followed. He set out quickly toward his camp, muttering and gesticulating wildly, and, when a dozen paces or more away, suddenly stopped, and, stamping violently on the ground, turned and swiftly vanished in the direction taken by the two Indians three hours before. Pondering over these matters, the night quietly passed away, and while the vigilant sentinels were mindful of the foe to their front, they little dreamed of the treachery that was being enacted in their rear.

At midnight, beginning 26 January, Indian leaders, along with the formerly loyal scout met to decide upon a plan of battle. The council decided upon an indiscriminate slaughter of all the people found in Seattle, including those belonging to the ship. They believed that if they struck suddenly in the rear of the settlement with great force, they would win an overwhelming victory against the defenders. The original plan was to begin the attack at 0200. But it was argued that was when they would be expected by the defenders. Better to hit them at mid-morning when the bulk of the sailors and Marines were back on board the ship for meals and sleep.

At 0700, the ship's company and Marines were in the process of moving back on board the Decatur to have their morning meal when they were suddenly summoned on deck and ordered to take their posts back at the settlement as quickly as possible.

"They are undoubtedly here at last," an officer told the Captain, "but probably will not show themselves till later." It turns out that an Indian, who was friends with a Dr. Williamson in the settlement, evaded the warriors and warned the good doctor that an attack was about to commence. He immediately related that to the Lieutenant who was in charge of a division of sailors who remained on shore.

The Captain being forewarned, ordered the men back to to their posts on the double, but told them to try and grab some sleep in order to be rested and ready when the Indians appeared.

The Captain then stated, "First, however, I will go to the south end and have the howitzer lodge a shell in Tom Pepper's house on the outskirts to see if they are there." At the same time there was a crash of muskets from the entire rear of the town, while a tempest of bullets swept through the village in unison with the deafening yells of an attacking force of Indians.

Leaving the third division of sailors (numbering 20 men) and the 18 Marines to hold the Indians in check, attentions were turned to the south, where large numbers were engaged, and neither party could approach the other without incurring certain casualties.

The roaring of an occasional gun from the ship, belching forth its shrieking shell, and its explosion in the woods, the sharp report of the howitzer, the incessant rattle of small-arms, and an uninterrupted whistling of bullets, mingled with the furious yells of the Indians, was a scene long remembered by those who were there.


The firing had reached a crescendo on the part of the Indians assembled on the hillsides and in the valley near a swamp. Desperate by blunders committed earlier, such as beginning the assault prematurely, the Indians now seemed bent upon remedying their errors by raining bullets upon the band of sailors and Marines holding them at bay.

1500 arrived, and with no sleep or food for almost a whole day, came exhaustion for the defenders. But the guns of the USS Decatur continued to fire solid shot, shells (which exploded after impact), grape

shot, and canister shot into the trees sheltering the attackers. This caused a great deal of casualties in the ranks of the attacking Indians.

Marine sharpshooter fire along with the Decatur's guns kept the Indians at a distance. Sporadic exchanges of fire continued until 1145, when the Indians apparently paused to eat. The settlers took advantage of the lull to evacuate over 50 women and children to the Decatur and another ship. When settlers attempted to retrieve arms and valuables from their abandoned homes, the Indians resumed firing. The engagement continued until 2200, when the last rifle was fired. The Battle of Seattle was over. The Indians had been defeated and turned back.

The number of Indians assembled before Seattle is not known but it is estimated that there were 200 to 500 warriors who participated in the attack. After the battle concluded, the settlers suffered no more attacks in Seattle. The ship's company of the Decatur prevented the settlers of Seattle from being overrun and slaughtered by the Indians. The sharpshooting Marines proved to be the backbone of the defense.

#### Remembering Iwo Jima

his month marks the 79th anniversary of the Battle of Iwo Jima. This 36-day struggle in 1945 remains one of the Corps' "touchstone battles." According to the National WWII Museum, in New Orleans, La., approximately 70,000 U.S. Marines and 18,000 Japanese soldiers took part in the battle. In the days of concentrated fighting on the small island, nearly 7,000 U.S. Marines were killed. Another 20,000 were wounded. Marines captured 216 Japanese soldiers; the rest were killed in action. The legacy of Iwo Jima stays with us to this day in sculpture, photographs, film and print. We mark this month's anniversary with three new articles: "Bloodbath at the Blockhouse: Marines Meet Massive Resistance on Iwo's Yellow Beach 2," by Steven McCloud, "Trapped: Marine Tankers come to the Rescue on Iwo Jima" by Colonel Robert D. Heinl Jr. Award-winning author Jonathan Bernstein, and "Crafting Fiction out of Real-Life War Tales" by Ray Elliott-a look at how firsthand anecdotes can be used to write historical fiction.

We recognize another "combat anniversary" this month with Leatherneck staff writer and Heinl award winner Kyle Watts' story "Enemy in the Wire: The Fight for Survival on LZ Russell." Also known as Firebase Russell, this fire support base and landing zone were first established by Marines in 1968 northwest of "The Rockpile" in Quang Tri Province, Vietnam. The official history notes that on Feb. 25, 1969, People's Army of Vietnam sappers attacked Russell, killing 27 Marines from the 2nd Bn, 4th Marines and 3rd Bn, 12th Marines plus two corpsmen. The Marines of 2/4 and 3/12 defended tenaciously, and the Marines would hold the firebase and LZ for seven months until ordered to dismantle it and evacuate in September 1969.

A final highlight this month is a feature on the Young Marines youth program. Author Abra Hogarth details the mission of the decades-old organization and presents the stories of several Young Marines who went on to join the Corps and continue to use the leadership lessons learned in the program to contribute to our service and the nation.




#### **MISSION AND PURPOSE**

#### MARINE CORPS HISTORY IN FEBRUARY

- 1 February 1967: Operation Prairie II was begun in Quang Tri province by elements of the 3d Marine Division. During the 46-day search-and-destroy operation which terminated 18 March, 93 Marines and 693 of the enemy were killed.
- 2 February 1944: The 4th Marine Division, as part of the first assault on islands controlled by the Japanese before the start of World War II, captured Namur and eight other islands in the Kwajalein Atoll.
- 6 February 1968: Two reduced Marine battalions, the 1st Battalion, 1st Marines with two companies, and 2d Battalion, 5th Marines with three, recaptured Hue's hospital, jail, and provincial headquarters. It would take three more weeks of intense house to house fighting, and nearly a thousand Marines killed and wounded, before the imperial city was secured.
- 11 February 1922: BGen John H. Russell was appointed U.S. High Commissioner and personal representative of the President to the government of Haiti. This nine-year assignment placed this future Commandant in supreme command of both the occupying American force and the Haitian Gendarmerie.
- 15 February 1998: One hundred years ago this date, 28 Marines and 232 seamen lost their lives when the battleship MAINE was mysteriously sunk by an explosion in the harbor of Havana, Cuba. Though no definitive evidence linked the Spanish with the sinking, the cry went up, "Remember the Maine!", and by late April the U.S. and Spain were at war.
- 17 February 1967: The first full day of Operation DECKHOUSE VI, which lasted until 3 March, was conducted near Quang Ngai city. The Special Landing Force (BLT Y4 and HMM-363) accounted for 280 enemy killed.
- 23 February 1945: Four days after the initial landings on Iwo Jima, 1stLt Harold G. Schrier led 40 men from Company E, 2d Battalion, 28th Marines, up Mt. Suribachi to secure the crest and raise the small American flag that battalion commander LtCol Chandler Johnson had given Schrier. Within an hour, the patrol reached the rim of the crater. After a short fire-fight with Japanese defenders emerging from several caves, the small American flag was attached to an iron pipe and raised over the island.
- 24 February 1991: The I Marine Expeditionary Force and coalition forces began a ground assault on Iraqi defenses in the final chapter of Operation Desert Storm. The 1st and 2d Marine Divisions stormed into the teeth of Iraqi defenses while heavily armored allied forces attacked the Iraqi defenses in Iraq from behind. In 100 hours, U.S. and allied forces defeated the Iraqi Army.
- 28 February 1991: Operation Desert Storm ended when the cease- fire declared by President George Bush went into effect. I Marine Expeditionary Force has a strength of more than 92,000 making Operation Desert Storm the largest Marine Corps operation in history .A total of 24 Marines were killed in action during the Gulf War.

## LANCE CORPORAL RICHARD A. ANDERSON UNITED STATES MARINE CORPS

#### **CITATION**:

For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty while serving as an Assistant Fire Team Leader with Company E, 3rd Reconnaissance Battalion, 3rd Marine Division, in connection with combat operations against an armed enemy in the Republic of Vietnam. While conducting a patrol during the early morning hours of 24 August 1969, Lance Corporal Anderson's reconnaissance team came under a heavy volume of automatic weapons and machine gun fire from a numerically superior and well-concealed enemy force. Although painfully wounded in both legs and knocked to the ground during the initial moments of the fierce fire fight, Lance Corporal Anderson assumed a prone position and continued to deliver intense suppressive fire in an attempt to repulse the attackers. Moments later he was wounded a second time by an enemy soldier who had approached to within eight feet of the team's position. Undaunted, he continued to pour a relentless stream of fire at the assaulting unit, even while a companion was treating his legs wounds. Observing an enemy hand grenade land between himself and the other Marine, Lance Corporal Anderson immediately rolled over and covered the lethal weapon with his body, absorbing the full effects of the detonation. By his indomitable courage, inspiring initiative, and selfless devotion to duty, Lance Corporal Anderson was instrumental in saving several Marines from serious injury or possible death. His actions were in keeping with the highest traditions of the Marine Corps and of the Department of the Navy. He gallantly gave his life in the service of his country.
