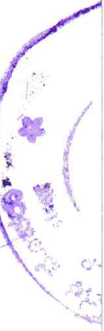

3. **SETTLEMENT:** In pursuance of the intent aforesaid, the Settlor does hereby irrevocably convey and entrust to and upon the First Trustees a sum of Rs. 21,000/- (Rupees Twenty one Thousand only) contributed by it as the Trust property and does hereby transfer, assign, convey, and deliver unto the Trustees the said sum in cash.(the receipt of which sum the trustees hereby acknowledge ) to HAVE, OWN, HOLD AND BE STAND POSSESSED of the same in trust as corpus of the Trust Fund ( which term shall mean and include not only the said sum of 21,000/-, declared as Trust property under these presents, but also legally permitted additions and accretions thereto and all investments for the time being representing the same) unto the Trustees absolutely and forever upon trust and with and subject to the powers, provisions and declarations hereinafter contained of and concerning the same and for the charitable objects specified herein.

**4. Name and office**

a. The name of the Trust shall be "SRI CHOWDESHWARI CHARITABLE AND EDUCATIONAL TRUST".

b. The Trust shall be an Educational Charitable Trust.

c. The Office of the Trust Shall be situated at Sy.No:172/\*/1, Bypass Station Road, Hosalli Road, Yadgir, 585202, Karnataka, INDIA and /or at such other place or places as the Trustees may decide from time to time. The Trustees shall be entitled to establish, run and maintain branch office/s at such place or places as may be determined by them from time to time.



xiii. Resulting in or creating any personal liability against the Board jointly or singly.

xiv. To commence, organize, further establish, support, financially or otherwise, donate or contribute, in cash or kind, to any person, group of persons, other Trust or other organization established for promotion of public good and /or charitable cause and/or for any other deserving cause approved by the board.

xv. To promote study in the field of Education, in its widest meaning and connotation, including the establishment of institutes, schools, colleges, research and development laboratories, training institutes and organizations, and therefore to enter into contracts with persons, entities, institutions, companies, in India and overseas, in order to achieve such object including the hiring of consultants specialized in the field of Education.

xvi. To organize, conduct, sponsor, participate in any activity in the fields of leadership, education, management, oratory, public speaking, extra-curricular activities, films, both nationally and internationally, and for and in pursuance thereof to organize, programs, previews, premiers, international exchange programs, youth exchange programs, group study exchange programs, seminars, cultural exchange programs, and all similar programs or events.

xvii. To carry on all or any of the activities, aims, objects, hereinbefore referred to, throughout the territory of India or any part thereof; or in any state in India or part thereof without hindrance or restriction as well as territories and countries outside the geographical boundaries of India.

xviii. To disseminate knowledge, and impart education with intent to create a positive awareness amongst citizens in and related to civic sense, responsibilities, civil rights, liberties, human rights, environment and for that purpose to participate in or conduct, organize seminars, events, programs, conferences or enter upon public education through the use of media in any form.

b) The Trustees shall be empowered to employ, retain or secure under contract the services of various Professionals, Skilled Personnel, Technical advisors, Legal and Financial consultants, as well as a managerial and administrative staff, workmen, gardeners, drivers, office boys, watchmen, servants and other personnel for the purpose of achieving the objects of the Trust on such terms as may be deemed appropriate.

c) To appeal, call for, request and receive donations in cash or kind from any person in pursuance and for the purpose of the activities of the trust and to make or give gift, contribute, donate amounts, money to other charitable causes, Institutions trusts, organizations, societies or persons. The term "Person" shall be deemed to include Companies, Societies, Trusts, Firm, Firms, Association of Persons, HUF, other clubs, both in India and abroad, subject to the prevailing laws in this regard.

d) Subject to the statutory provisions of the Income Tax Act, 1961 the Trustees shall also be empowered to utilize and invest the property of the Trust in such manner as they see fit, provided that, no portion of the property of the Trust is distributed among the Trustees as profits, dividends or bonus, However, the Trustees shall be entitled to reasonable remuneration for special jobs and works performed in furtherance of the objects of the trust.

e) The trustees shall be entitled to deal in any and all the property of the Trust whether moveable or immovable, whether through lease or sale or any other transfer of right title or interest therein upon such terms as they think fit and proper.

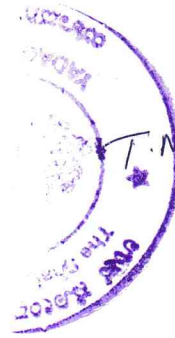
