## SPRING HAS ARRIVED! A FEW REMINDERS......

- \* 4 Wheelers Please be careful and be responsible! With the 4 wheeler accidents we are seeing in Harbor South we would like to remind everyone that the roads in Harbor South are county roads. Law enforcement could patrol the roads and take action by issuing tickets and possibly banning ATV's on these roads. If you are allowing your underage children to operate these vehicles you may or may not have insurance coverage in the event of an accident.
- \* Quiet Time Quiet time begins at 10:30 pm. Loud gatherings, 4 wheelers and barking dogs may be disturbing others. Please be considerate of your neighbors.
- \* Trash Check your trash bin to be sure that it is animal resistant. Trash pick up is for bagged household trash only. Items such as furniture, grills, lumber, etc. are not included. Contact the POA office for more information.
- \* Burning If you are burning please call the Mountain Harbor Lodge to report that you will be doing a controlled burn. Be aware of wind conditions and have a water hose nearby. When finished please be sure that the fire OUT by watering down the ashes. Fires can flare back up during the night when no one is around.
- \* Building Approval Have a project on your mind? Contact the POA office for a building approval. All plans for construction and improvements must be approved by the Building Committee.
