STATEMENT CHARGES: Attached you will find your first quarter POA dues & WWMF billing. For those of you connected to the wastewater system you will receive 2 separate emails from the POA. One is your POA dues statement and the second email is your wastewater statement. Separate checks should be made payable to Harbor South POA and Harbor South WWMF. Checks may be mailed together to:

WASTEWATER FEE INCREASE: (This only applies to those connected to the wastewater treatment system.) The Improvement District Commissioners have approved a two step rate increase effective on your January 1st statement. The rate increase effective January 1, 2023 is \$73.50 per quarter or \$294.00 a year. The second approved rate increase will be effective January 1, 2024 and will be \$100.00 per quarter or \$400.00 a year. The last increase in wastewater fee's was in 2002. With the rising costs of repairs, electrical, chemicals and possible upgrades to comply with new environmental regulations by ADEQ this increase in fee's is necessary to keep the Improvement District in a sound financial position moving forward.

If you have any questions regarding your POA or WWMF account, please contact the POA office. <u>SEPARATE CHECKS ARE REQUIRED FOR POA DUES AND WWMF</u> FEES.

A quarterly late fee of \$25.00 is applied to any outstanding amount of the next billing cycle. Payments will be applied to late fees first and then to fees. Late fees can be avoided by choosing the annual payment option. Any account past due four (4) consecutive quarters will have a lien placed upon the property and the POA Board and Commissioners will evaluate all legal remedies available to collect the amount past due.
