I Call the Meeting to Order

a. The Meeting was called to order at 7:00 pm by Chairman Jake Herfel.

a. The Pledge of Allegiance was recited.

III Approval of Agenda

a. Director Fedena motioned to approve the agenda. Director Thompson seconded the motion. All in favor – 4 ayes.

Open Business

VI Chief's Report: Suggested Action, Discussion and Action

- a. Incident report from previous month
 - Chief Makemson reported 68 calls for the month of October 2025. He states that call volume for this year has been lower and this will result in about a \$40,000 loss in Measure M funding next year.
- b. Volunteers and Coverage
 - i. Station 171 was staffed 2-0 for 30/31days.
 - ii. Chief Makemson reports that the new volunteers are doing well. Kristy Beckstead is being sponsored by the district for her firefighter academy. He also mentioned that Anthony Gonsalves will be doing live fire training in Modesto next week.
- c. Training Events
 - i. There will be active shooter training at Argonaut.
- d. Apparatus Updates
 - i. Chief Makemson said all Apparatus are in service.
- e. Grants
 - i. DOM Jo states that she is still working on procurement for the AFG grant and that she has heard nothing back from Sinise Grants for the Lucus Device. She asked Chief Makemson if he would like

her to complete the AFG grant this year and he stated that we would wait and see if the district gets funded for the Lucus Device through Sinise first.

f. Chief's Meeting

i. Chief Makemson said that at the last Chief's meeting they met with Firewise and discussed priority projects for next year. He said that there is about 6 acres on Lakeview that he would like to have mitigated for next fire season. He also mentioned "Green Waste" bins for the district. This item has been brought forth in the past but never came to fruition. Bins would be put on the district grounds for residents to dispose of green waste. The monitoring and methods of disposal need to be worked out, but the green waste bins would benefit the district if used appropriately and would limit escaped debris burns.

VII Financial Report: Suggested Action, Discussion and Action

- a. Payroll and Bills
 - i. DOM Jo reviewed the monthly bills. The biggest bill was payroll, \$45,950. She mentioned there were additional wages paid out for the Bridge Fire strike team due to underpayment. She states the district received \$10,404 from CSFA safer grant, and \$2910 from EBMUD. She states there is still \$69,324 outstanding from Gifford and Dillon Strike teams, as well as the AFG grant.
 - 1. Director Thompson made a motion to pay the October bills. Director Fedena seconded. All in favor, 4 ayes.
- b. Budget Expenditures FYTD 24/25
 - i. DOM Jo went over the FY expenditures spreadsheet. She states that the district budget is trending as expected.
