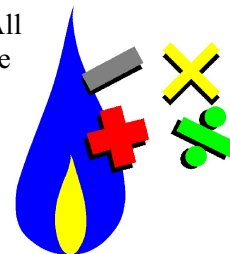


The GASCalc™ software is our popular suite of analytical tools. It is licensed on a subscription basis. All upgrades and updates are included in the subscription price and technical support (so long as the subscription “fee” is paid and up-to-date) - ensuring that you are always working with the latest reversion of our GASCalc software. Annual subscription licenses are purchased per User, with discounts applied for multiple (concurrent) Users.



When purchasing or upgrading to the GASCalc software, a subscription activation fee is due for the first year of use. An annual “Renewal Fee” based on the number of Users (licenses) is due by the anniversary date of the original activation of the license. If the Renewal Fee is not paid before the due date, the subscription will be suspended until paid. If the fees for a suspended subscription are not paid within three (3) years, the subscription is considered expired, and a new subscription must be purchased.

The GASCalc software is delivered by way of electronic download. The software requires a device configured to run Windows 7 through Windows 11. On the first execution of the software, the User’s device will need to be connected to the internet. After that, a license can be “checked-out” for up to 30 days of offline use, only requiring an internet connection to check for updates or to extend the offline license.
