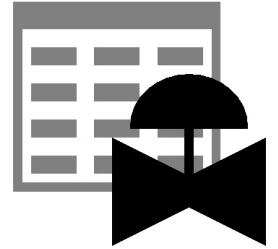


StationManager™ is sold on a per-license basis. Each purchased copy of the software represents one License. Discounted prices are available for multi-copy purchases.
