## GASWorkS 10 - Bundle A Model



It's been one year since we released GASWorkS 10.0, the newest version of our flagship software. And we still are not even close to getting through all the new [features](#) the program has to offer.

This month's tip is actually a throwback to a feature from past versions of GASWorkS. If you have ever contacted our technical support, you may have been asked to send us your model. Or maybe you would like to share your model with a colleague. If so, you may have noticed that GASWorkS models are made up of many different files.

Instead of trying to find and share each file individually, the Bundle feature streamlines the process. "Bundling" a model creates a single compressed ".zip" file from the model and support files. If the zip file is small enough, you can attach it to an email and send it.

To bundle a model in GASWorkS, go to the *File* menu, scroll down to the *Bundle* submenu, and click on the *Bundle A Model* item. The Bundle Specifications screen will present you with options for which files to include. If you are sending your model to our support staff, we recommend checking all options. Click the *Continue* command button. GASWorkS will display a message with the number of files bundled, and the location of the zip file.

If you are on the receiving end of a bundled model, simply save it to your computer, then go to *File, Bundle, and Unbundle A Model*. Use the File Selection screen to select the zip file, then click *Continue*. GASWorkS will automatically extract the model files and give you the option to open the model.
