



Notes

1. Contributions

FOLRM has three primary sources of donations: individuals, strategic organizational partners, and miscellaneous sources such as Amazon Smile. During the calendar year, there were a total of sixty-five donors that supported FOLRM's operation. The movement of funds from restricted to unrestricted reflects donations whose donor-specific instructions have been met. Below are key revenue metrics for the organization.

Loss Donors


reflects those donors who financially contributed last year but did not contribute to

2. Expenses

In addition to its regular programs supported in Liberia through the Liberia Renewal Ministries (LRM), FOLRM undertook the following projects during the year: Continuation of the construction of a school building, expected to be completed in 2023; Rice project, generator, and procurement of a computer to support LRM's administrative tasks. Below is a comparative analysis of expenditures in 2022 and 2021.



Fundraising Expenses

- reflect expenses relating to food, drinks, supplies, and FOLRM printed shirts used at our annual donors' luncheon.

Supporting Expenses

 relate to expenses such as accounting software charges, donation platform subscription, an independent contractor in Liberia to verify how funds are utilized in Liberia independently, and credit card/bank wire transfer-related charges.

Project Expenditures

during the year, the organization continued its support of the completion of a school-building project. In addition, a Rice Project and generator were undertaken due to the rising cost and shortage of rice in the country and electricity needs.

Program Expenditures

- Ladies Lounge, Mercy, LRM Education Training Program (Scholarship), and LRM General Operation are various programs FOLRM supports.
