Notes

1. Contributions

During the calendar year, 34 individual donors and four partners contributed to Friends of Liberia Renewal Ministries USA operations. Of the 34 individual donors, there were 14 recurring donors. The organization hopes to increase the number of recurring donors, allowing the organization to better plan its financial operations.

During its fundraising event for Project Food Shipment, five thousand four hundred and eighty-one dollars were donated specifically for this project. The movement from temporary-restricted income to unrestricted income is the result of this project. The remaining amount currently sitting in temporary-restricted income is specifically for a building project and ladies lounge.

2. Expenses

During the year, the organization shipped a 40ft container of food supplies to the Liberia Renewal Ministries in Liberia. The total cost incurred was seven thousand one hundred seventeen dollars. The organization remitted seven thousand eighty-five dollars to Liberia for general operations of the Liberia Renewal Ministries. More details of the operation in Liberia will be presented in the Liberia Renewal Ministries Annual Report.
