

WHAT YOU NEED TO KNOW ABOUT THIS TAX SEASON



We strongly urge you to get us your information as soon as possible, especially if we need to reconcile your accounts. If your business is not engaged for monthly bookkeeping with us, and you would like to be, please email Douglas@CPARejoyce.com to schedule a meeting to determine your needs.

If we are only providing tax preparation services, please ensure you have reconciled all bank accounts, credit cards accounts, and loan accounts before providing to us a trial balance of your business. You may also wish to reconcile your POS (point of sale system) and Payroll information to your accounting records. You will want to make sure your business expenses and revenues are completely entered for the year.

FEES

Our fees for tax preparation are based on the complexity of the return and the time it takes to prepare/file it. We did not increase our fees to you last year, however, our fees did increase. We are increasing our fees this year. The cost of software has increased, sadly leaving us no choice (having searched other options, we are still using the most cost-effective option).

The average increase over last year is \$100. Each engagement's price is tailored to your specific tax forms needed for your return.



We accept major credit cards, checks, and cash. Fees are collected 50% upfront when you sign your engagement letter and 50% upon completion of your return. We will not start work on your return until we have both a signed engagement letter and 50% of the tax preparation fee.

BENEFICIAL OWNERSHIP INFORMATION

The US Department of the Treasury, FINCEN, Financial Crimes Enforcement Network (www.fincen.gov) has mandated additional filing requirements for businesses in the US. If you would like me to file the information on your behalf, a separate engagement will need to be signed.

If you have complex ownership structures, it is recommended to seek out the assistance of a licensed attorney to complete this requirement.
