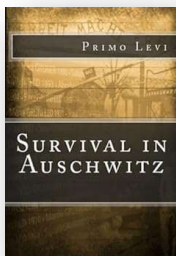

#### March Treasurer/Financial Report

- Cory Toth-LaPointe has agreed to stay in the Treasurer capacity, with quarterly meeting attendance. Thank you, Cory!
- Group reviewed financials (**MSC: Laurie/Josh**)
  - March Income: \$16,816
  - March Expenses: \$19,293
  - Discussions were had about Easter income not being included in March numbers due to banks being open.
  - April will have higher numbers due to Easter income being counted in April (see addendum in Council Meeting packet)
  - Council discussed bringing it up at the Town Hall meeting

#### Our Response to the Word

**Task Force Update/Synod Meeting/Cath Mode** [this is the group tasked with working directly with potential future church partners; members include Mike and Laurie Sturzenegger, Paul and JoAnn Grewe, Jennifer Holcomb, and Kay Walters]

- Laurie discussed the meeting and that GSLC is further along in the process than other congregations and we are doing a good job in being transparent in sharing information with our congregation. There are still opportunities out there for joint solutions among area churches that the task force is working through and will update everyone.
- Cath Mode – Synod assigned coach if we choose. She offered up a contract of four coaching sessions (GSLC pays for 1, Synod pays for 3), which Laurie sent to the taskforce and read to Council. Task Force agreed that it would be money well spent. Council discussed and proposed some further questions for Pastor Cath.

#### **President's Meeting**

- Was held at Immanuel recently. The biggest thing to come from it was a 'parade of churches' suggestion. It is being discussed to do something similar to last year's July 16<sup>th</sup> service but at a lesser scale.
- First English is interested in joining the shared confirmation program as they only have a few kids. Sounds like things will be put in motion to do so.

## Ecumenical Promotion Policy

Definition: Different denominations doing activities together.

There have been a couple events at Zion Lutheran, which has different theology than us (they are members of the LCMC (Lutheran Congregations in Mission for Christ) that have been advertised here at GSLC. GSLC Council discussed putting together some policies around making sure that all we share with our members is focused around our same beliefs. ## Good Shepherd Task Force Update...4-23-24

The Good Shepherd task force continues to meet on a regular basis with full agendas. As we direct our efforts in multiple areas, we continue to seek the congregation's input and prayers. On April 2, per the suggestion of the synod reps at the March 16, multi-congregation meeting, two members of Good Shepherd (Kay Walters and Paul Grewe) met with two reps from St Stephen as members of the communications teams to polish and formalize a covenant prayer, created and agreed upon at the synod led meeting. This prayer will be shared whenever two or more congregation teams meet as a reminder of our promises to one another.

### The Good Shepherd task force met on April 4; discussion topics included:

- the hiring of Pastor Cath Mode as a "coach" to help guide us through this time of transition and Good Shepherd's role as a leader in this process
- the possible re-structuring of committees as we re-organize our work, responsibilities and efforts
- several socially based events where Good Shepherd and St Stephen will be able to combine forces in a fun manner
- proposed shared worship events tentatively scheduled for this summer
- a new survey, included in the newsletter and available in the narthex
- further work on defining our vision and values
- a brief schedule update as the warmer months bring additional responsibilities and commitments.

The task force felt it appropriate to contact Pilgrim once again with an offer to share some of our experiences as we've been working through transition. And proving that God does indeed move in mysterious ways, Laurie and Mike Sturzenegger (council president and vice president and task force members) were planning to worship at Pilgrim on the same day that Pilgrim had a town hall meeting scheduled! They were able to share briefly with the Pilgrim congregation Good Shepherd's background and some of the things that we have learned on our journey.

The Good Shepherd task force will meet again on May 2, in part, to prepare for the May 7 joint meeting with St Stephen which will be held at Good Shepherd.

Once again, please keep all of the Wausau area ELCA congregations in your prayers as we work to understand what and where and how God might lead us...
