See the weekly chart below for a schedule of serving ministries. Our goal is to bring groups together to get to know each other through serving and fellowship! If you are able to help, reach out to the contact person below, to get connected for a specific date. Each ministry will then coordinate a menu, the specific volunteer roles needed and where or how you would like to direct that day's free will offering.

Each week we will provide lunch for approximately 25-40 lunch worshipers and 60-75 for the evening meal. Good Shepherd Task Force Update...February 2S, 202S

The Good Shepherd task force, partnered with the Church Council, once again met with congregation members during the town hall meeting time on February 16 to collect congregants' insights and ideas. These smaller and more intimate groups are reporting rewarding, fruitful gatherings. Thank you to those who have shared some time with the representatives of the congregation.

The GPS (<u>G</u>ood Shepherd/<u>P</u>ilgrim/<u>S</u>t Stephen) task force met on February 18; members were thrilled to learn developing details about planned shared ministry during the Lenten season, including midweek worship, special day worship (Ash Wednesday, Maundy Thursday, Good Friday), soup meals, musical offerings, Confirmation student involvement, a good steward project (think "social concerns") of collecting "40 items for 40 days". These activities fit perfectly into our Synod coach-assigned "homework" to:

share ministry * share leadership * build relationships

What does the phrase "my church," mean? The Good Shepherd building? The Good Shepherd congregation? "My church" is actually larger than that! Our church includes, at the least, all the ELCA Lutherans in our area, who can be God's hands together. In an effort to shift our thinking to a more unified understanding, we are using the term "congregation" to identify our "church families" who usually worship and work together in the same place, and "church" to indicate the ELCA in the greater Wausau area. So, Good Shepherd and St Stephen and Pilgrim are congregations, and we are all part of the same church in Wausau.

Additional shared ministry events are being planned - watch for those details, coming soon. As always, thank you for your thoughts and prayers as we navigate these complicated waters.

GPS (Good shepherd / Pilgrim / St. Stephen) Task Force PRESS RELEASE

GPS met February 18th at Pilgrim Lutheran Church to further the work of God that our Wausau area congregations do together. Discussion focused on our shared ministries such as the highlight of our all working together to offer meals, hospitality and a warm bed to some of our community's unhoused, working with Community on Call, during the recent week of bitter cold. Other examples discussed include a Lenten devotion booklet which collectively our congregants are authoring and plan to provide, and St. Stephen's Good Stewards sparked a shared collection of items needed by local non-profits titled '40 Days / 40 Items,' which is rolling out this Lenten season. GPS will also be seeking the vital and valuable insights and ideas of all of our GPS church family members. Please respond prayerfully and boldly. Our next GPS meeting will occur March 18th at St. Steven Lutheran Church.

Treasurer's Report January 2025 / Council Meeting / February 12, 2025

This is my first treasurer's report, so we'll see this goes. I reviewed prior reports from Cory and financial statements and I'm still learning but getting a much better idea of the finances of the church.

Contributions for January were \$15,485.51. Looking at the income statement that shows 'below budget' but that isn't really accurate. The budgeted amount of \$20,833.26 is the annual budgeted contributions divided by 12. Giving throughout the year fluctuates by month. I analyzed the past 3 years and looked at percent of giving by month in comparison to the whole year and January is typically about 7%. For next year's budgeted amount, it might be good to allocate the budgeted giving a little more accurately instead of just dividing by 12.

For comparison, giving in January the past 3 years were \$13,400, \$17,614 and \$17,043 so this month is fairly average it looks like.

Expenses for the month were \$19,722 showing a loss of \$3,653. After adding in the transfer of \$1511 to cover the mortgage payment the loss was \$2,142.





Paul is getting his footing on the status of financials and discussion occurred around updating future budget structure to ebb and flow with the reality of how our finances work (rather than dividing the totals per line item by 12).

Also discussed preferred method for paying our combined insurance premiums to Church Mutual (monthly, quarterly, annually) - motion to pay monthly (MSC: Walters/Krahn)

<u>Furnace Update</u>: we <u>are</u> able to fix the failing unit we have currently, for an estimated \$2,500; regardless, both units are nearing the end of their useful lives, so we will need to begin looking ahead. In talking with the heating company with whom we have been working for a number of years, furnace replacement would run in the vicinity of \$32,000 each (we have two); this price estimate does NOT include updating zoning systems. Property Committee recommendation is to implement the short-term fix for the estimated \$2,500 and begin gathering competitive quotes in anticipation of needing to replace in the future. **Motion to accept and implement Property Committee recommendation (MSC: Walters/Martell)**

<u>Kartika's Korner</u>: Lenten plans shared for St. Stephen/Pilgrim/Good Shepherd - more collaboration to help us meet and work with our neighbors! Also discussed potential summer worship experiences/ideas. More to come!

Annual Meeting Minutes Draft Approval for Distribution: minutes were draft-approved by Council for distribution in the March newsletter. Note that this is a draft version only, as the minutes must be approved at the 2026 annual meeting.

Task Force Update/Letter from Sister Congregation: Laurie shared a letter that GSLC (and four other local congregations) received from Immanuel Lutheran Church regarding their future; based on feedback from the GPS (Good Shepherd/Pilgrim/St Stephen) task force, Laurie presented a joint response letter and that was approved by Council. Laurie will send both letters to all Council members.

BUDGET PRESENTATION

Cory Toth-LaPointe, outgoing Treasurer, presented the 2025 proposed budget and answered questions from the floor.

Question was raised (planned for New Business discussion, but moved up in agenda) around the continued need for separate Building and General funds. Laurie Sturzenegger shared that with our new Treasurer, Paul Jauch, about to start, we will let him get his bearings for the job and then evaluate and make a recommendation for this question. Paul was introduced to those in attendance, and Cory Toth-LaPointe was thanked for her many years of service in the role of Treasurer!

Recent furnace failure situation was brought up by Angie Huckbody (also planned for New Business discussion). More to come on the status of this potential large-scale expense as the experts evaluate.

Recommendation to remove increase for payroll taxes due to having not spent all of what was budgeted in 2024. Also question of convention/seminar expense not budgeted for. \$975 was spent in 2024. The Synod Assembly for this year will not require overnight accommodations, which will reduce that overall cost. There is a planned Administrative personnel retreat/learning opportunity that Angie Huckbody will attend this year, adding to seminar expenses. Both recommendations were accepted and adopted into the proposed 2025 budget.

Question raised about earmarked funds for Damgaard Room. As was noted in 2024, work to make improvements in the Damgaard Room continues. Those funds shall remain restricted for future needs in that worship space; the most recent conversation has been around purchasing chairs for this intimate worship space.

1. Estimate of Giving (formerly known as a stewardship drive) was not done in 2024; discussion as to whether or not we should run this process this year. Overall pulse was in favor of, potentially in the fall, rather than now, since the budget is already set for 2025. Council will discuss and make a decision as well as create/implement a plan.
