

Nite Angel Acres Sales Agreement

Thank you for your interest in Nite Angel Acres Nigerian Dwarf Goats. Please email us or message us on Facebook to make a reservation on a kid. Kid reservations are free.

Once we notify you that your kid has been born you have 48 hours to put a half-down deposit on your kid. Kids must be paid for in full before leaving the farm.

If you are interested in an adult doe or buck, a half down deposit is required, and paid in full before leaving the farm.

Acceptable forms of payment currently include Check, money order, and cash.

Payment in check must be to Nite Angel Acres AT LEAST 2 weeks prior to transport. NO EXCEPTIONS.

Transport is the sole responsibility of the buyer and includes, but is not limited to any crates, tickets, and health certificates (CVI).

We can recommend several shippers, but it is the **buyers responsibility** to get in touch with them and arrange timely transport.

It is the **BUYERS responsibility** to find out what tests are needed for goats when entering their state. Some states have special requirements and tests needed to get a CVI for transport (animals over 6 months).

Nite Angel Acres reserves the right to retain any kid born.

Nite Angel Acres reserves the right to change any breeding plan at any given time.

Nite Angel Acres reserves the right to terminate any sale at any given time with a full refund of deposit or full purchase price if already paid in full.

There is no refund of deposit if buyer backs out of sale for any reason.

Kids must be picked up at 8-10 weeks of age or as discussed with Nite Angel Acres. After 10 weeks of age, a 3 dollar a day boarding fee will be added on to the purchase price of the animal until picked up.

Bottle babies must be picked up by 4 weeks of age or as discussed with Nite Angel Acres. A 5 dollar a day boarding fee will be added onto the purchase price if you go over transport/pickup date.

Breeding plans may change at any given time.
