

Privacy Policy Statement

Chell Aircraft Spares & Equipment Ltd is committed to protecting your privacy when using this website. This statement explains how **Chell Aircraft Spares & Equipment Ltd** uses any information you give to us and the ways in which we protect your privacy. We ask you to read it carefully. We may be required to change it from time to time, so we also ask you to check it occasionally to make sure you are aware of the latest version.

We treat any personal information (which means data from which you can be identified, including your name, address, e-mail address) that you provide us, or that we obtain from you, in accordance with the provisions of the Data Protection Act. Under this Act, we have a legal duty to protect any information we collect from you.

When we request information from you we will state what it is for and how long we are likely to retain it. The statement will appear near or next to that part of the website, web page where the capture of data occurs, with the heading "Data Protection", and a reference to this privacy statement.

Any amendments to this policy will continue to be in accordance with the provisions of the Data Protection Act 1998.

What personal information do we collect?

We collect the personal data that you volunteer on forms be it electronic or paper, which you submit to us (including but not limited to enquiries, registration, feedback, survey, and competition forms) and in e-mails which you send to us.

The personal data we collect will in some instances will be specifically used to respond to an enquiry raised by yourself or a Professional Bodies, and in other instances (as described above) are used to allow us to develop our site in a way that will enhance the on-line experience of the greatest number of users.

Where is my personal data held?
