Brian J. Brian undergoes continuing education to maintain professional standards.

APPROACH

The goal of Hypnotherapy Here & Now, LLC is to guide each client to achieving long-lasting results through the use of hypnosis, neurolinguistic programming (NLP), meditation and other related modalities. Each session is completely individualized and only uses techniques which are mutually agreed upon by both the client and hypnotherapist.

CONFIDENTIALITY

Hypnotherapy Here & Now, LLC will not release any information to anyone without a written authorization from you except as provided for by law. You have a right to access to your own records by request.

FEES

A single session is \$100 and typically lasts anywhere between one and two hours. Session fees are due at the time of each session in the form of cash, local check or debit/credit card. There is a 24-hour cancellation policy as follows: Clients are charged for their scheduled session if they do not give at least a 24-hour notice to cancel or reschedule; a waiver may be granted for the first offense. Package deals and gift cards are paid in advance and are good for 12 months from time of purchase; after 12 months, any unused sessions are forfeited. Package deals and gift cards are non-refundable.

INSURANCE

In general, most insurance companies do not cover hypnotic services. Therefore, session fees are the sole responsibility of the client.
