Players / Parents Code of Conduct

Equipment:

Equipment including uniforms issued to each player must be properly cared for and not abused. At the end of the season the player must return all equipment to the league. The player or parent is responsible for all items lost or stolen. No awards will be granted until full restitution has been made.

Students: It is expected that all players will:

- Display appropriate behavior. The player should display good sportsmanship and exhibit mutual respect among all other players.
- Be responsible for oneself, to notify your coach as soon as possible if you are unable to attend the scheduled activity or contest. If there is a problem, discuss it with your coach or a board member at any time.
- Show commitment. The player should demonstrate commitment to their team by being on time and attending each practice and activity with a positive attitude.
- Be aware of the total benefits. The player needs to understand that taking part in an activity is a learning experience encompassing physical, mental, social, and emotional well-being. Have fun and enjoy your career in football.
- Work closely with your coach and fellow players and learn the team concept.
- Substance abuse: Respect for one health and physical development is a great part of our daily lives. Understanding this means that use of the tobacco, alcohol, marijuana, inhalants or any controlled substance will not be tolerated.
- Stress academics: The player should understand that school studies come first and that if there is a problem, the player should let the coach know. All homework must be turned in on time.

Parents / Guardians - It is expected that parents and guardians will:

- Be a role model. The parent or guardian needs to work with the player and follow appropriate standards of behavior. Yelling at referees, coaches or commissioners will not be allowed. This behavior could lead to being asked to leave the area. This is to teach the child good sportsmanship as well as respect.
- There will be no smoking or any other use of tobacco, tobacco related products, or use of drugs in the area of games and practices. (Most of these locations are schools and require this to be followed.)
- Be responsible. The parent or guardian should recognize commitment to their child's activity and schedule when planning trips
- Parents and guardians should contact their coach as soon as possible when the child will miss practice or games due to illness.
- If there is a problem and the coach will not listen, please contact a board member and address the concern with them.
- Parents should be mindful of their own conduct on the field, and if parent conduct is inappropriate parent will be asked to leave field.

Players and Parent

I the undersigned player & parent have read and understand the code of conduct for being able to participate in the football program and agree to follow the rules and code.

I also give permission for my daughter/son to participate in the football program for the 20____ season.

I as a parent understand also that sports involve risk of injury to the player which on occasion could be serious. League does have insurance, however, there is a \$100 deductible, all expenses incurred must first be submitted to the parents/guardians' primary insurance for payment and consideration. The balance if any will then be submitted to the league's insurance program for consideration. Parent will be financially responsible (**billed**) for any equipment listed below that is not turned over to the league at the end of the season or at any point in the season the child quits or leaves for any reason.
