

Summary of Annual Owners meeting 1/12/2026

Our Annual Owners meeting was held on Monday January 12th @ 7:30 pm

Our Quorum of 30% membership or Proxy for attendance was met and the meeting was opened and came to order approximately 7: 30 pm

Debra Schmeltzer, Treasurer gave our 2025 End of year financial summary report, The report was accepted, seconded and carried. Budget: Our 2026 Proposed budget was gone over a bit by our President Jim Thiessen. WE have not changed our fees from last year, so there was really not much to discuss new. President asked that the proposed budget be passed, motion was made, seconded and carried.

be very expensive and would increase fees substantially for our homeowners of Parry.
