This Privacy Policy explains Hawaii Shuttle's policies regarding how we collect and use personal information you share with us. It also tells you about your rights with regard to your personal information.

We use personal information for the sole purpose of providing services to you. By using our website, and by requesting information, you agree to our use of your personal information as described in this Privacy Policy.

Data We Collect

While using our website or our services, you may be asked to provide certain information that can be used to contact or identify you. This information may include your:

- email address
- first and last name
- phone number
- physical address

Usage Data

We do not collect any data related to your particular use of our site. Our website is only used as a tool for us to share information with you regarding the Hawaii Shuttle services.

Tracking and Cookies

How We Use Personal Data

We use Personal Data for the following purposes:

- **To provide, maintain and improve Hawaii Shuttle services**
- **To manage your relationship with Hawaii Shuttle and ensure we provide you with the best possible service**
- **To contact you**

- **To share news, special offers and general information about Hawaii Shuttle goods, services, and events**
- **To manage your requests of us**
- **Other reasons may include data analysis and usage trends to determining to evaluate and improve our services and offerings**

We only share personal information with:

- **Hawaii Shuttle business partners who provide direct flight operations and associated flight services**

Retention of Personal Data

Hawaii Shuttle will only retain your personal data for so long as is necessary to provided services described, or longer as may be needed for us to ensure compliance with our legal obligations such as to resolve disputes, and to enforce legal agreements and policies.

Transfer of Personal Data

Personal information is processed by Hawaii Shuttle at our offices in California. We will take reasonable steps to ensure that personal data is treated securely consistently with this Privacy Policy and that personal data will not be transferred to any third party unless there are adequate controls in place to protect the data.

Disclosure of Your Personal Data

Business Transactions

Personal data may be transferred in the event Hawaii Shuttle is involved in a merger, acquisition or sale. You will receive notice before personal data is transferred and will be subject to this or an updated Privacy Policy.

Law enforcement

Hawaii Shuttle may be required to disclose personal information to law enforcement or public agencies subject to a legal request. We may do so if it is necessary for us to:

- Comply with a legal obligation
- Protect and defend the rights or property of the Company
- Prevent or investigate possible wrongdoing in connection with the Service
- Protect the personal safety of Users of the Service or the public
- Protect against legal liability
