PAYMENT AND SERVICES

The service(s) provided at this time is/are; _____.

Lucky Paws Dog Walking shall be paid in the amount of \$_____ (not including GST) per service(s) agreed upon.

Lucky Paws Dog Walking accepts cash, cheque or email transfer.

Invoices will be emailed on the **15th** and **30th** of each month and be paid as soon as the invoice is received.

A **late payment** fee will be added if an invoice is outstanding for more than 3 months and will continue every 3 months until payment is received in full.

Lucky Paws Dog Walking requires a **24 hour cancellation** notice for any service. Cancellations or changes with less than 24 hours notice will be charged at the full rate.

An **NSF fee** will be charged to the client.

The Owner will ensure access is given to Lucky Paws Dog Walking to collect the dog from the agreed address or give Lucky Paws Dog Walking a key/fob/alarm code to the place where the dog is kept only for the purpose of service(s) agreed upon with the Owner. The keys/fob/alarm code will be kept safe and not copied and keys will be returned to the Owner on demand.

The Owner authorizes use of their dogs photos for social media purposes and to be shared with other dog owners.

RESPONSIBILITIES

Lucky Paws Dog Walking is contracted to perform on the agreed upon services in an attentive, caring and reliable manner and the Owner shall provide all necessary information in order to assist in this performance. Lucky Paws Dog Walking agrees to notify the Owner in the event of an emergency relating to the dogs care and well-being.

The Owner will provide suitable harness, collar and leash for their dog. If needed and necessary, the Owner will also provide a coat and muzzle.

Lucky Paws Dog Walking reserves the right to walk other compatible dogs at the same time but undertakes to limit the number of dogs walked with one person to 5.

Lucky Paws Dog Walking reserves the right to cancel all services in the event of extreme weather conditions or unforeseen events, for the safety of all dogs and employees. Clients will be informed of such closures via email or phone, as soon as possible.

EMERGENCY RELEASE

Lucky Paws Dog Walking is authorized to perform care and services as outlined in this contract. Lucky Paws Dog Walking is also authorized by signature below to seek emergency veterinary care with release from all liabilities related to transportation, treatment and expense. Should specified veterinarian be unavailable, Lucky Paws Dog Walking is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. Owner agrees to reimburse Lucky Paws Dog Walking for any expense incurred, plus additional fees for attending to this need. The Owner agrees to pay for all vet care or treatment required, in the opinion of the vet, to the amount of \$_____ (or **\$1000** if not stated).

INJURY RELEASE AND LIABILITY

If Owners pet(s) accidentally dies, becomes ill, injured or lost, the Owner waives and releases Lucky Paws Dog Walking from any claim arising from such an incident. If Owners pet(s) bites or injures employees of Lucky Paws Dog Walking, any other human or animal, the Owner will be responsible for any resulting injury and shall not hold harmless and indemnify Lucky Paws Dog Walking from any claim or suit that may be brought as a result of such an incident. In addition, the Owner shall hold harmless and indemnify Lucky Paws Dog Walking against any and all costs, expenses, losses, liabilities and claims arising out of or relating to any acts of the Owners pet(s) except for negligence or intentional misconduct on part of Lucky Paws Dog Walking.
