GENTEXT/REMARKS/1. PURPOSE. TO DIRECT THE ACTIVATION OF EOD CO 8TH ESB 2D MLG.
2. BACKGROUND. PER REF (A), THE COMMANDANT OF THE MARINE CORPS (CMC) DIRECTED
THE ESTABLISHMENT AND ACTIVATION OF EOD CO 8TH ESB 2D MLG.
A. THE ACTIVATION DATE FOR EOD CO 8TH ESB 2D MLG WILL OCCUR 1 OCTOBER 2009.
B. EOD CO 8TH ESB 2D MLG WILL BE LOCATED AT MARINE CORPS BASE (MCB) CAMP LEJEUNE,
NC.
3. GENERAL. DC CDI HAS VALIDATED THE ACTIVATION OF EOD CO 8TH ESB 2D MLG.
A. THE DOTMLPF PROCESS WAS USED TO FORMULATE A STRATEGY AND SOLUTION FOR THE
ACTIVATION OF EOD CO 8TH ESB 2D MLG:
(1) DOCTRINE: THE ACTIVATION OF THIS UNIT PROVIDES THE
MARINE CORPS BETTER SUPPORT TO DISTRIBUTED COMBAT OPERATIONS AND WILL SIMPLIFY
INTEGRATION INTO THE PLANNING PROCESS AND PERSONNEL SOURCING. FINAL APPROVAL OF
MISSION STATEMENTS FOR THE REORGANIZED AND CREATED UNITS WILL DETERMINE ANY FUTURE
DOCTRINAL IMPACT.

(2) ORGANIZATION: TABLES OF ORGANIZATION AND EQUIPMENT (TOE) HAVE BEEN APPROVED AND ARE BEING INTERGRATED INTO THE TOTAL FORCE STRUCTURE MANAGEMENT SYSTEM (TFSMS). MISSION STATEMENTS ARE PRESENTLY BEING STAFFED FOR SIGNATURE BY CMC. THERE WERE NO INCREASES OR DECREASES IN THE ESB STRUCTURE OR EQUIPMENT IDENTIFIED IN THIS ESTABLISHMENT.

(3) TRAINING: NO UNIQUE TRAINING HAS BEEN IDENTIFIED IN THE DEVELOPMENT OF THIS UNIT. THE EOD CO 8TH ESB WILL HAVE NO INCREASED TRAINING REQUIREMENTS.

(4) MATERIEL: ALTHOUGH THERE WERE NO INCREASES OR DECREASES IN EQUIPMENT REQUIREMENTS, INTERNAL ESB REDISTRIBUTION NEEDS TO BE ACCOMPLISHED TO REFLECT THE REQUIREMENTS STATED IN THE TABLES OF EQUIPMENT FOR EOD CO 8TH ESB 2D MLG CONTAINED IN TFSMS.

(5) LEADERSHIP AND EDUCATION: COMPANY COMMANDER DIRECTS AND CONTROLS COMMAND SUPPORT FUNCTIONS RELATING TO OPERATIONS, TRAINING, ADMINISTRATION AND LOGISTICS FOR THE COMPANY.

(6) PERSONNEL: STAFFING PRECEDENCE LEVEL FOR THIS UNIT HAS BEEN ESTABLISHED AS PRO-SHARE. KEY PERSONNEL ARE CURRENTLY FILLING BILLETS.

(7) FACILITIES: THERE IS NO SIGNIFICANT IMPACT TO FACILITIES BECAUSE THERE IS NO CHANGE IN PERSONNEL, EQUIPMENT OR TRAINING.

4. ACTION. DC CDI IS CHARGED WITH THE OVERALL ACTION OF ACTIVATING THIS COMPANY. THIS ACTIVATION PLAN REQUIRES CLOSE COORDINATION BETWEEN HQMC AGENCIES, DC CDI, DC I&L, DC MRA, COMMARCORSYSCOM AND COMMARCORLOGCOM.

A. COMMANDER, MARINE FORCES COMMAND (COMMARFORCOM). ACCOMPLISH THE FOLLOWING SPECIFIC ACTIONS TO ASSIST IN THE ACTIVATION OF THIS CAPABILITY.

(1) 1 OCTOBER 2009 ACTIVATE EOD CO 8TH ESB 2D MLG.

(2) OFFICIAL LONG NAME AND SHORT NAME FOR THIS UNIT HAS BEEN ESTABLISHED BELOW. COMMANDS ARE DIRECTED TO UPDATE CURRENT DATABASES WITH THE OFFICIAL LONG OR SHORT NAME TO ASSIST IN MIGRATION TO GLOBAL FORCE MANAGEMENT.

(A) UIC: M21316. UNIT LONG NAME: EXPLOSIVE ORDNANCE DISPOSAL (EOD) COMPANY 8TH ESB 2D MLG. UNIT SHORT NAME: EOD CO 8TH ESB 2D MLG.

(3) TABLE OF ORGANIZATION AND EQUIPMENT. FORCE STRUCTURE REQUIREMENTS HAVE BEEN ESTABLISHED WITHIN TFSMS TO COINCIDE WITH THE ACTIVATION OF THIS UNIT. IDENTIFY ANY ADDITIONAL REQUIREMENTS TO SUPPORT THIS ACTIVATION TO DC CDI (TFSD) WITHIN 30 DAYS OF THIS MESSAGE.

(4) FISCAL. COSTS THAT CANNOT BE ACCOMMODATED WITHIN LOCAL RESOURCES SHOULD BE ROUTED THROUGH THE CHAIN OF COMMAND TO THE COMPTROLLER AND INPUT IN THE CURRENT YEAR DEFICIENCY (CYD) DATABASE FOR FUNDING CONSIDERATION BY CMC (RPPB). IDENTIFY UNPROGRAMMED COSTS (ADDITIONAL REQUIREMENTS) FOR TRANSPORTATION OR RETROGRADE OF GROUND SUPPORT T/E ITEMS TO CMC (LFT-5). CONTACT LOCAL BASE TRAFFIC MANAGEMENT OFFICE IF COMMERCIAL TRANSPORTATION ARRANGEMENTS ARE REQUIRED. LOW OR NO COST TRANSPORTATION WILL BE USED TO THE GREATEST EXTENT POSSIBLE. PACKING, PRESERVING, STORING, AND STAGING COSTS WILL BE BORNE BY COMMARFORCOM.

(5) FACILITIES. IT IS ANTICIPATED THAT THESE ACTIONS CAN BE ACCOMPLISHED WITHIN THE SCOPE OF EXISTING FACILITIES.

(6) ENVIRONMENTAL. INITIATE ENVIRONMENTAL COMPLIANCE PLANNING AND COORDINATE WITH MCI EAST AND INSTALLATION COMMANDER TO DETERMINE THE EXTENT OF ENVIRONMENTAL REQUIREMENTS IAW REF (BB).

(7) PUBLIC AFFAIRS. MILITARY ORGANIZATION STRUCTURE CHANGES GENERATE CONSIDERABLE PUBLIC INTEREST. KEEP THE PUBLIC AND OUR MARINES INFORMED OF THIS FORCE STRUCTURE ACTION IN COORDINATION WITH HQMC PUBLIC AFFAIRS (NOTIFY HQMC PA BRANCH HEAD, DSN 224-8029).
