The maximum number of Associate Members shall not exceed 50.**

Associate Members in good standing may use the WLSA's beaches from May 1 to October 31 and attend its social functions.

Associate Members **DO NOT** have voting rights at the WLSA's Annual Meeting.

Associate Members **DO NOT** have the right to cross the WLSA's properties from November 1 to April 30 for any reason including ice fishing.

Cards to open the gate to the boat launch on Beach A are no longer issued to Associate members (effective 1/1/21).
