**Job Purpose:** Deliver the choreographic works of Calpulli Mexican Dance Company in line with its organizational mission and with the vision of the Artistic Director

### **ORGANIZATIONAL MISSION**

The Calpulli Mexican Dance Company (hereafter Calpulli or organization) is a premiere arts organization based in New York City that tours domestically and internationally with a message of honoring and celebrating Mexican people and our stories. Calpulli was founded in 2003 with the mission of celebrating the Mexican community through dance including live music. To this end, the organization produces performances via its touring company, designs arts-in-education experiences for all ages, and leads community outreach activities in the northeastern USA.

### **POSITION SUMMARY**

Dancers are bearers of the artistic voice of Calpulli Mexican Dance Company imbuing the stories and choreographic works with their unique talents and passion. The Dancer will work with the Artistic Director, fellow Dancers, and other staff at rehearsals and performances to deliver full productions, excerpts, and private events featuring Calpulli's artistic works with live and recorded music. The part-time role rehearses year-round for approximately 8-12 hours per week and performs throughout the year both locally and on tour on a project-based schedule. If the Dancer participates in performances within Arts-in-Education, a separate department within the organization, they will report to the Director of Arts-in-Education for the corresponding projects. All Dancers are employees and must be present in person in New York City.

The ideal candidate will have extensive experience with diverse subgenres of Mexican folkloric dance as well as confidence exploring dance theater and contemporary movement. They will be excellent listeners, fast learners, and a professional partner to all colleagues and collaborators with Calpulli Mexican Dance Company.

### **REQUIREMENTS**

- Attend paid rehearsals to learn and perfect dance routines for performances
- Available for all or most evening rehearsals Mondays and Wednesdays and Sunday mornings
- Punctuality and proactively communicate availability
- Excellent organizational, communication, and interpersonal skills
- Live within proximity to NYC metropolitan area or be willing to commute at own expense for rehearsals and projects

### **QUALIFICATIONS**

- Knowledge of various folkloric dance styles and techniques
- Professional understanding of musicality and movement coordination
- Experience in both contemporary and folk is a plus but NOT a requirement
- Hands-on experience in the field of Mexican folk dance is a plus
- Continuously improve skills through training at rehearsals



- Physical strength, flexibility, and endurance to execute complex dance movements, footwork and/or skirt work
- Ability to develop technical, artistic and Mexican folk dance skills
- A genuine love for the art form and Mexican Culture
- Approach their work with enthusiasm and a willingness to collaborate

### **COMPENSATION**

New York state minimum wage for rehearsals. Per project compensation can range from \$75 to \$300 per performance or daily fee. Once hired, Dancers are surveyed for availability for performances at which time compensation and other details are shared. Dancer can choose to accept or decline projects.
