## **Example Government Workflow**

### Reporting

### **Investigation Phase**

eDiscovery Teams can report on what witness sources where processed; how much was processed and what was produced. They can pull reports on the activity of each task and the overall progression of the project. Team level service level agreements can be created and managed through IS-A-TASK, holding teams accountable to increase productivity and reduce overall project spend.

IS-A-TASK maintains individual investigation case portals that are bound by specific user privileges. During a government investigation, witnesses are identified, productions are managed, records are requested, and documents are reviewed by attorneys for relevancy.

# Source Management

During a case investigation eDiscovery teams take on requests that include the receipt of productions, source media, record requests or litigation activity that needs a step through workflow process. With IS-A-TASK's Source module, each type of source can be tracked and added to downstream project activity in an organized and secure chain of custody and defensible process.

### **Work Execution**

IS-A-TASK maintains individual team portals that are bound by specific user privileges. These team portals allow you to assign tasks, perform the required work, track progress, add comments and record any post statistical information regarding the task prior to completion.



### **Records Management**

Within the Source's module check in/out process, eDiscovery teams can work closely with internal records departments to maintain chain of custody. Attorneys can make requests directly within IS-A-TASK to the Records Department. This fosters cross team collaboration and management of all recorded transactions.

# Request Initiation

The eDiscovery team, attorneys or agency staff members submits a request to IS-A-TASK. From IS-A-TASK's case portal, they create a project by selecting a predefined workflow template, fill out all project instruction details, attaches the related source information and submits the project to the operation team. Workflow templates allow for a streamlined repeatable process to ensure more accurate on-time deliverables.
