



## LIABILITY WAIVER

Baling Out Farms takes pride in caring for your pet and will endeavor to offer sound, safe, and responsible care for your dog(s). You have been told and understand the risks inherent in boarding your dog, including but not limited to interactions with other dogs and potential exposure to disease and parasites, such as but not limited to fleas. You understand that there are certain risks involved when sharing space with both familiar and unfamiliar dogs, including unpredictability of dog behavior. You understand that when dogs socialize in open areas with other dogs, the possibility of injury and illness, although slim, does exist. Further, you are and will remain responsible for the actions of your dog at all times and hereby agree to indemnify and hold harmless Baling Out Farms, and its agents, officers, subcontractors, employees, and customers, of any and all claims of injury, expense, costs, or damages caused by or arising out of the actions of your dog while under the care of Baling Out Farms. You, the pet owner, are responsible for all costs for any property damage or injury to persons or other animals by your pet. Baling Out Farms will not be held responsible for any illness, injury, loss or damage to your pet, however caused, during its stay. Boarding is entirely at the owner's risk. You recognize that Baling Out Farms is not responsible for any unintentional errors, omissions, or incorrect assertions.

All precautions are taken to limit the possibility of illness or injury to pets in our care. You agree that you have notified us of any pet medical conditions at the time of booking. We reserve the right to refuse admission if we have not been so notified. However, if your pet is ill or injured Baling Out Farms will, at its sole discretion: 1) attempt to contact you as soon as possible; 2) consult your designated veterinarian whenever possible; 3) seek care at Affiliated Emergency Veterinary Services, if needed, at times outside normal veterinary hours. **HOWEVER, AND IRRESPECTIVE OF ANYTHING TO THE CONTRARY CONTAINED HEREIN, IF YOUR PET BECOMES SERIOUSLY ILL SUCH THAT VETERINARY ASSISTANCE IS REQUIRED, YOU AGREE THAT BALING OUT FARMS MAY TRANSPORT YOUR PET FOR VETERINARY CARE. YOU AGREE THAT VETERINARY CARE MAY BE RENDERED TO YOUR PET AT YOUR SOLE COST AND EXPENSE WITHOUT PRIOR CONSULTATION. BALING OUT FARMS WILL MAKE ALL REASONABLE EFFORTS TO CONTACT YOU IF EXTRAORDINARY MEASURES ARE REQUIRED. IF YOU CANNOT BE REACHED DURING YOUR PET'S STAY, YOU AGREE TO PROVIDE WRITTEN INSTRUCTIONS FOR EXTRAORDINARY CARE.** Any incurred vet

charges are to be paid by you, the pet owner. As a condition of this contract, you authorize the release of your pet's vaccination and medical information to Baling Out Farms at any time prior to, during, or after the performance of services. When using Baling Out Farms for boarding or any other services you agree to pay for all services rendered upon completion of service. You will be expected to cover all charges incurred from abandoning or leaving a pet indefinitely. This contract shall be considered in effect each time the pet owner requires the services of Baling Out Farms for this pet or any other future pet(s).

You agree that the name and likeness of your dog may appear in print, video, or on the Baling Out Farms' social media pages, for promotional purposes.

You acknowledge that services, policies and rates are subject to change at any time, without notice.

You acknowledge that, the venue for any disputes arising out of or relating to this waiver and/or the boarding of your pet at Baling Out Farms shall be in Dickson county. In addition, Baling Out Farms shall be entitled to recover its reasonable costs and expenses, including, but not limited to, attorneys' fees and expenses, in enforcing the terms of this waiver and any other documents signed by the owner.

You certify that you are the sole owner, or agent of the owner, of the dog and that you are authorized to sign this waiver. By signing below, you are indicating that you have read, agreed to, and fully understood all terms and conditions stated within this contract.
