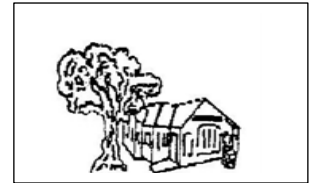


VENDOR ENTRY FORM
