LETTER TO THE NORTH DAKOTA ATTORNEY GENERAL

Although I may have a close personal connection to the Mayor of Leith nonetheless it is a travesty of justice that he is being prosecuted by the Attorney General's office for failure to control or report a dangerous fire in the City of Leith by burning down a house that Craig Cobb had deeded over to the city to get out of jail.
