EDITOR COMMENT: *COBB WAS RELEASED FROM JAIL ON 4 YEARS SUPERVISED PROBATION ON APRIL 29, 2014 BY THE NOW HUMILIATED FORMER GRANT COUNTY STATES ATTORNEY "TODD SCHWARZ".*

HIS PROBATION WILL END ON APRIL 29TH OF NEXT YEAR (2018) WHEN HE WILL BE FREE TO LEAVE NORTH DAKOTA BUT UNDER FEDERAL LAW WILL NOT BE ALLOWED TO OWN ANY FIREARM FOR LIFE.

THE STATE OF NORTH DAKOTA SHOULD HAVE TAKEN A LESSON LEARNED FROM THE PAGES OF THE CITY OF LEITH AND ITS STRUGGLE AND EVENTUAL VICTORY OVER RUNNING THE NAZIS OUT OF GRANT COUNTY WITH THE STANDING ROCK TRIBAL NATION AND THE DAPL RIOTERS AND IT WOULD NOT HAVE COST NORTH DAKOTA TAXPAYERS ALMOST \$40 MILLION.

COBB IS FOREWARNED NOT TO RETURN TO THE CITY OF LEITH NOR GRANT COUNTY AS HE WILL CERTAINLY REGRET DOING SO.

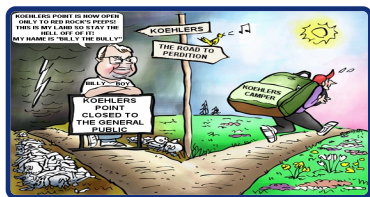
The four videos below were filmed by an RT (Russia Today Television) videographer and reported by Maria Finoshina (A War Correspondent of Russia Today Television).

Maria contacted this editor back in the fall of 2015 through the now closed Leith website and was able to track him down in Sherwood, North Dakota. Cobb was not pleased when she showed up at his house and after an exchange of a few comments Cobb invited Maria to come inside his house where his three dogs were 'yapping'.

However, she refused and the interview was on at the outside of his dilapidated fence and house.

Maria then travelled on to Nebraska and Kansas where she found and interviewed several residents who all pooled together their resources and paid the back taxes on several properties that Cobb attempted to buy for his NAZIS to come and presumably take over their town.

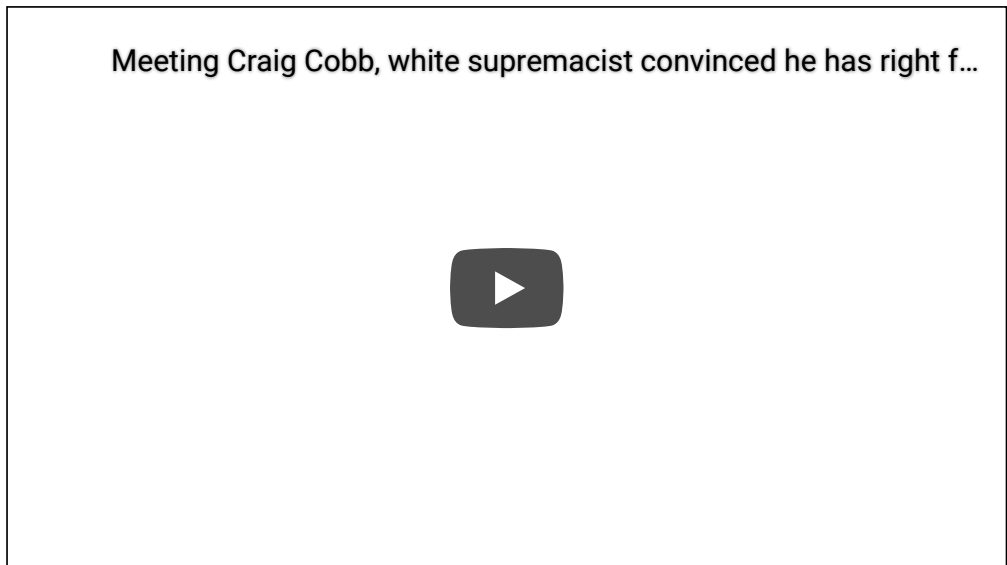
