Dear Mayor Buckhorn,

My colleagues and I were disappointed to read your quote in the May 14, 2018 edition of the Tampa Bay Times stating, "This means we've arrived," given in response to news that The Mosaic Company will be relocating its corporate headquarters to Hillsborough County. Such a statement indicates you may not be aware of the phosphate industry's toxic legacy in the Tampa Bay region, but I assure you this is not lost on the communities near the Riverview phosphogypsum stacks.

I would like to schedule a meeting with you and the city council to discuss phosphate mining impacts in person. In the meantime, I have enclosed our phosphate mining fact sheet and a report of Mosaic's environmental and workplace safety violations compiled by Good Jobs First, a research group promoting responsible economic development. I have also included more detailed reports for each of the violations occurring in Mosaic's Florida facilities for your review in the hopes that you will be more cautious with your optimism concerning the phosphate industry's increased presence in the Tampa Bay region.

# **PHOSPHATE MINING**

Phosphate strip mining has irreparably changed the face of Florida, devastating hundreds of thousands of acres of sensitive lands and waters, evicting wildlife from their natural habitats, and producing hazardous wastes that threaten water quality and public health. From mining to phosphoric acid production to use in synthetic fertilizers, industrial agriculture's addiction to Florida's phosphate reserves spells disaster for the health of the environment and the people of Florida.

To obtain phosphate ore, mining companies clear away vegetation, topsoil and wildlife from thousands of consecutive acres of rich central Florida habitat. The phosphate ore is then transported by pipeline to a nearby plant, where it is forcibly separated from sand and clay. The clay is sent to clay-settling areas, sometimes euphemistically referred to as "ponds," on mined sites; the areas are unable to revert back to normal biome, and the clay remains in perpetuity, scarring the landscape indefinitely.

The separated phosphate ore is then sent to a nearby fertilizer plant where it is treated with sulfuric acid to produce phosphoric acid, which is predominantly used in synthetic fertilizer. This process creates phosphogypsum, a radioactive, hazardous byproduct that is stored in mountainous "stacks" that are hundreds of acres wide and hundreds of feet tall. More than 1 billion tons of the radioactive waste has already been stored in 25 stacks scattered throughout Florida, perched precariously atop the Floridan aquifer — which supplies drinking water for 10 million people.

The devastating and costly phosphate extraction process is driven by unsustainable industrial

agricultural practices that leave soils nutrient-deficient. As a result the industrial food system has become reliant on adding phosphorus to soils in the form of synthetic phosphate fertilizers, much of which is wasted in application and lost in runoff that pollutes our drinking water and irrevocably harms our air and freshwater ecosystems. Nutrient loading from agricultural runoff is a key factor in the creation of harmful algal blooms, large-scale fish kills, and public-health emergencies.

# Florida's Frightening Phosphate Problem

The phosphate industry has a dark history of polluting Florida's environment, including irresponsibly keeping the public in the dark about leaking radioactive and acidic waste from phosphogypsum stacks into the state's groundwater resources. Despite these alarming events, the industry has not offered any meaningful methods for managing and disposing of the hazardous wastes

this process produces or for restoring ecological or wildlife functions to stripped and mined lands. Yet it now intends to strip and process an additional 50,000 acres of irreplaceable central Florida habitat.<sup>5</sup>

# How is U.S. phosphate rock used?

About 90 percent of the phosphate rock we extract in the United States goes to synthetic fertilizer production. The United States is also the leading importer of phosphate rock — the majority of which is turned into synthetic fertilizer. These fertilizers are used in large part on crops such as corn and soybeans that go toward animal feed to support industrial meat and dairy operations. The remaining 10 percent of U.S.-produced phosphate rock goes to creating animal feed supplements (about 5 percent), generating detergents and fire suppressants, and producing elemental phosphorus.<sup>1</sup>

The United States' dependence on phosphate rock could be drastically cut by improving the efficiency of how the rock is used and by finding such alternatives to synthetic fertilizer as treated and composted waste.

That's why the Center and partners launched a <u>lawsuit</u> against the U.S. Army Corps of Engineers and U.S. Fish and Wildlife Service for authorizing the further destruction of Florida's natural heritage through phosphate mining. We are working to prevent irretrievable damage to imperiled endangered species habitat, water quality and Florida's unique landscape.

Summary Nr: 202311239 Event: 11/26/2000 Employee Is Killed When He Falls From An Elevation

On November 26, 2000, a four-member crew was cleaning out a vessel called a Lump Breaker. The Lump Breaker, located on the DAP-2 side of the fertilizer plant, is an enclosed space that has two access doors, one at the top of the space, and one at the bottom. The cleaning process requires two men to enter the chamber to remove lumps of material that have created a blockage to the flow of material through the chamber. Air hammers are used to loosen the material. Two men work out side of the chamber as attendants. The lumps of material are removed and discharged through an access door in the bottom. The floor opening is created by removing a 15-inch by 40-inch section of the metal floor. At the time of the accident, the employees had completed the cleaning process. As one employee exited the bottom door in the Lump Breaker, he closed the door and stepped back. He then fell through the opening in the floor of the supporting platform. The employee died from a concussion.

# Case Summary

This case is part of the Mining and Mineral Processing National Priority. On December 9, 2003, an unannounced EPA lead compliance evaluation inspection (CEI) was conducted at the facility to determine the facility's compliance status with the applicable RCRA regulations. Following a discussion of the facility's operations, a walk-through inspection of the facility's sulfuric acid production operations was performed. While certain waste waters produced from the production of phosphoric acid are exempt from being a hazardous waste pursuant to 40 C.F.R. ? 261.4(b)(7)(ii)(P), inspectors determined that non-Bevill exempt waste waters were being generated. These included waste waters generated from within the sulfuric acid plant areas as well as discharges from cation and anion water demineralization units. These units are used to demineralize water for use in the production of the sulfuric acid. These spills/discharges are initially managed within a concrete ditch which channels the waste waters beneath an equipment cleaning area and a metal walkway before going through a spillway. This spillway discharges to an earthen ditch and an unlined earthen surface impoundment called the Stormwater Retention Pond or A11 Pond. A pH meter was attached to the walk-way over the concrete ditch. A solid waste with a pH of less than or equal to 2 is a corrosive hazardous waste and has the EPA Hazardous Waste Number of D002. At the inspection, the spillway was in its closed position, yet a significant amount of waste water was flowing beneath the spill gate. The facility's Elementary Neutralization Unit (ENU) was in a dilapidated condition. The ENU is designed to neutralize acidic wastes. The ENU was rusted, in disrepair, and thus not functional and out of service. If the ENU was in service, it would have treated low pH waste water prior to the spillway. The ditch prior to the spillway has a sump that would have pumped low pH waste water to the ENU for treatment. After treatment, the ENU would discharge non-hazardous waste water into the earthen ditch and the

unlined Stormwater Retention Pond. Instead of being captured and pumped to the ENU, the waste water went to the spillway. The waste water should have backed up at the spillway because the sump to the ENU was not in service. Instead, the untreated hazardous waste waste water flowed under the spillway into the earthen ditch and the unlined Stormwater Retention Pond. The inspectors reviewed the hourly pH meter records of the demineralization operator's log to determine how many days waste water with a pH of two or less was discharged from the spillway. The records showed that waste water with a pH of two or less was discharged from the spillway. Pursuant to 40 C.F.R. ? 261.22, a solid waste exhibits the characteristic of corrosivity, and is therefore a hazardous waste (D002), if a representative sample of the waste is aqueous and has a pH which is equal to or less than 2. Pursuant to 40 C.F.R. ? 268.37(a), hazardous wastes specified in 40 C.F.R. ? 261.22 as D002 that are managed in systems other than those whose discharges are regulated under the Clean Water Act (CWA) or that inject in Class I deep wells regulated under the Safe Drinking Water Act (SDWA) are prohibited from land disposal. IMC New Wales has violated 40 C.F.R. ? 268.7 (FAC Chapter 62-730-183) and 40 C.F.R. ? 268.9 (FAC Chapter 62-730-183) by disposing of a liquid hazardous waste having a pH of less than or equal to two (2.0) in an earthen ditch and surface impoundment, without determining the applicable treatment standard; by disposing before the treatment standards were met; and, by failing to comply with other notice, certification, and waste analysis requirements in these sections. IMC New Wales has also violated Section 3005 of RCRA by disposing and treating a D002 characteristic hazardous waste in an earthen ditch and surface impoundmen



# Phosphate giant Mosaic agrees to pay nearly \$2 billion over mishandling of hazardous waste

Mosaic Fertilizer, the world's largest phosphate mining company, has agreed to pay nearly \$2 billion to settle a federal lawsuit over hazardous waste and to clean up operations at six Florida sites and two in Louisiana, the Environmental Protection Agency announced Thursday.

"The 60 billion pounds of hazardous waste addressed in this case is the largest amount ever covered by a federal or state . . . settlement and will ensure that wastewater at Mosaic's facilities is properly managed and does not pose a threat to groundwater resources," the EPA said.

The EPA had accused Mosaic of improper storage and disposal of waste from the production of phosphoric and sulfuric acids, key components of fertilizers, at Mosaic's facilities in Bartow, New Wales, Mulberry, Riverview, South Pierce and Green Bay in Florida, as well as two sites in Louisiana.

The EPA said it had discovered Mosaic employees were mixing highly corrosive substances from its fertilizer operations with the solid waste and wastewater from mineral processing, in violation of federal and state hazardous waste laws.

"This case is a major victory for clean water, public health and communities across Florida and Louisiana," said Cynthia Giles, assistant administrator for EPA's Office of Enforcement and Compliance Assurance.

Mosaic CEO Joc O'Rourke said the company is "pleased to be bringing this matter to a close" and pledged to be a good environmental steward. The Minnesota-based company was formed in 2004 by a merger of IMC Global with the crop nutrition division of Cargill.

Mosaic officials in Florida said the EPA investigation and negotiations for a settlement have been going on for eight years over practices that everyone in the phosphate industry was doing as well.

The settlement with the EPA, the Justice Department, the Florida Department of Environmental Protection and the Louisiana Department of Environmental Quality will have no impact on Mosaic's continued employment or on its future mining expansion plans in DeSoto, Hardee and Manatee counties, they said.

Thursday's settlement will become final upon approval by the court. The first step in this process is a 30-day public comment period, which is now open, said Julia Valentine, an EPA spokeswoman.

First discovered by an Army Corps of Engineers captain in 1881, Florida's phosphate deposits today are the basis of an \$85 billion industry that supplies three-fourths of the phosphate used in the United States. Although phosphate mining provides a major financial boon to the small communities in which the mines are located, it also leaves behind a major environmental mess.

The miners use a dragline with a bucket the size of a truck to scoop up the top 30 feet of earth and dump it to the side of the mine. Then the dragline scoops out the underlying section of earth, which contains phosphate rocks mixed with clay and sand.

The bucket dumps this in a pit where high-pressure water guns create a slurry that can be pumped to a plant up to 10 miles away.

At the plant, the phosphate is separated from the sand and clay. The clay slurry is pumped to a settling pond, and the phosphate is sent to a chemical processing plant where it is converted for use in fertilizer and other products. The sand is sent back to the mine site to fill in the hole after all the phosphate is removed.

A byproduct, called phosphogypsum, is slightly radioactive so it cannot be easily disposed. The only thing the miners can do with it is stack it into mountainous piles next to the plant. Florida is such a flat state that the 150-foot-tall "gyp stacks" are usually the highest point in the landscape for miles around. They contain large pools of highly acidic wastewater on top.

"Mining and mineral processing facilities generate more toxic and hazardous waste than any other industrial sector," Giles said. "Reducing environmental impacts from large fertilizer manufacturers operations is a national priority for EPA."

Mosaic's production of pollution is so great that in 2012, the Southwest Florida Water Management District granted the company a permit to pump up to 70 million gallons of water a day out of the ground for the next 20 years. Mosaic is using some of that water to dilute the pollution it dumps into area creeks and streams so it won't violate state regulations.

The EPA investigation was prompted by a 2003 incident in which the Piney Point phosphate plant, near the southern end of the Sunshine Skyway bridge, leaked some of waste from atop its gyp stack into the edge of Tampa Bay after its owners walked away.

That prompted EPA to launch a national review of phosphate mining facilities, Valentine said. That's how inspectors found workers were mixing the corrosive substances from the fertilizer operations with the phosphogypsum and wastewater from the mineral processing, she said.

That mixing was something everyone in the industry did, according to Richard Ghent of Mosaic's Florida operations. The EPA said that violated both state and federal law and put groundwater at risk. It has previously gotten settlements from two other companies, one of which, CF Industries, has since been taken over by Mosaic.

Despite the mishandling of the waste, Debra Waters, Mosaic's director of environmental regulatory affairs in Florida, said the company has seen no change in the area's groundwater, which EPA officials said was correct.

The fact that the negotiations have been going on for so many years, Waters said, "should indicate that there's no imminent threat."

The company will invest at least \$170 million at its fertilizer manufacturing facilities to keep those substances separate from now on. Mosaic will also put money aside for the safe future closure of the gypsum stacks using a \$630 million trust fund it is creating under the settlement. That money will be invested until it reaches \$1.8 billion, which will pay for the closures.

The South Pierce and Green Bay plants, both in Polk County, will soon shut down, with the closure of the gyp stacks already underway, Waters said.

Mosaic will also pay a \$5 million civil penalty to the federal government, a \$1.55 million penalty to the state of Louisiana and \$1.45 million to Florida, and it will be required to spend \$2.2 million on local environmental projects to make up for what it has done.

Mosaic, which runs television ads touting its importance in growing crops to feed the world, has donated to both the Florida Republican and Democratic parties, and to state lawmakers such as Rep. Dana Young, Rep. Jake Raburn and Rep. Ben Albritton.

The company has previously run afoul of the EPA on its air pollution standards. Meanwhile, though, it was rated one of the top 50 employers in America based on salary and job satisfaction. Mosaic employs about 1,200 people in Hillsborough County alone.

On January 12, 2006, Employee #1 was working alone at night, greasing fittings on a loading platform that was 11 feet above the ground. The loading platform consisted of an adjustable ladder leading to a guardrail system, which lowers to the top of a tanker truck when loading. The guardrails become fall protection for employees, when they are opening the valves on the top of the truck. When there are no trucks at the loading platform, the adjustable ladder assembly is kept in the raised, stored position. An automatic foot locks the clips into place over a "pin" or "bolt" to keep the assembly from descending inadvertently. It is believed that Employee #1 leaned against the adjustable ladder assembly while greasing fittings on the platform and the assembly descended unexpectedly, causing him to lose his balance and fall to the ground, striking his head on the concrete pad area, resulting in his death. The accident was not witnessed. Inspection of the ladder assembly revealed that the "pin" or "bolt" part of the foot lock was missing.






