1. <u>CALL TO ORDER, ROLL CALL, and QUORUM</u>: The meeting was called to order at 6:34 p.m. by Chair Brad Pierce. The following were in attendance, and a quorum was present:

**SPECIAL PRESENTATION:** Will Rummel, Training Support Manager with ATP Flight School reviewed the history of ATP, which is nationwide and is the largest such flight school in the nation. Founded in 1984, ATP has been at Centennial Airport since 2012. It focuses on flight training for commercial purposes, and is set up to address problems directly with those involved, through a system of data collection and staff monitoring. Training includes an emphasis on noise abatement.

Night training flights are restricted to only those required by the FAA. Maneuvers are to be done at 1,500 feet above ground level unless something lower is required by the FAA; if necessary, every effort is made to do so over uncongested areas. All instructors are aware of where our communities are. The southeast training boxes tend to be used more than those in the southwest.

Mr. Rummel provided more specific information and answers to questions, noted he would be leaving ATP soon and introduced John Herman who would be taking his place. Both were thanked and invited to return at any time.

### 2. PUBLIC COMMENT:

A. <u>VIRTUAL/IN-PERSON MEETING ATTENDEES</u> – Randy Johnson of Louviers provided statistics from his tracking of flights over his area, which he called airplanes of interest; he has been keeping a journal for quite some time. Interestingly, his dog can seem to recognize training flights and barks at them. This morning, there were seven flights circling over his residence, mostly in an east/west pattern. His journal showed such things as 39 in June, 104 in July, and 12 so far in August. He had been able to identify the school involved for all of these. Question was asked if it would be possible to put a portable noise monitor at his location. One had been placed there previously, but the dog's barks registered on the monitor and affected the readings. Johnson and airport staff would work to see if some solution might be found for the area.

Kimberly Hellweg from the Elizabeth area, close to the Douglas County line, noted there is a problem in her area around 5:30 - 6:00 a.m. many mornings. She has been able to identify flights from ATP are usually not problematic, but those from other flight schools, not so much. She wondered if the schools could coordinate their use of the practice boxes, as one would be waiting to practice and circling for about 45 minutes, to be immediately followed by another for a similar amount of time as soon as a box became free. This seemed to go on for 2.5 - 3 hours at a time.

Mike Fronapfel indicated this could be one of the items to be explored during a meeting with the flight schools, and identified the three areas used the most, with cross over happening at times. It was noted that neither CACNR or the airport can regulate

what training aircraft do, but the schools need to hear what we hear from the public and all need to work together to assure good neighborliness.

Donna Johnston reporting for Greenwood Village noted much activity lately, with as many as 24 passes in a 1.5 hour morning period. At another time, it seemed the same plane was overhead for five hours. At another, there were two planes passing over, one right after the other for a lengthy time. She asked for them to be identified and contacted to request a change in that kind of activity. Observation was made that some of this may be the result of flights in the pattern which air traffic control has to manage to avoid another mid-air collision here. When the new manager at the tower arrives, he/she will be invited to attend a CACNR meeting where these types of concerns can be shared. Whether or not the flight schools might use another airport was also mentioned.

In June, 38 responses were requested from 502 noise complaints, with 18 of those requests made by email (47%), and 20 made by telephone (53%).

In June, 468 complaints were made about daytime flights (7:00 a.m. - 9:59 p.m.) - 91% 44 complaints were made about **nighttime flights** (10:00 p.m. - 6:59 a.m.) - 9%

In June, props accounted for 66% of the complaints by aircraft type; jets accounted for 33% of the complaints; and 1% was about helicopters.

In June, departures were responsible for 53% of the complaints. Arrivals were responsible for 27% of the complaints, and Training was responsible for 20% of the complaints.

- Cherry Hills Village

The Year to Date complaint maps were not provided with this report, and a Radar Track Density Map was also not available. Staff continues to work to provide this information.

### 4. ITEMS REMOVED FROM CONSENT AGENDA: None

### 5. COMMITTEE REPORTS:

A. **EXECUTIVE /WORK PLAN COMMITTEES** – Representatives were reminded to get any suggested revisions to the Noise Abatement Guidelines to Samantha Blymyer. Representatives who will not be able to attend a CACNR meeting were also asked to see if their Alternate Representatives can attend, so their Member jurisdiction will always be represented. It was agreed the attendance record would be sent out monthly; the roster will be sent twice a year. The status of follow-up items was briefly reviewed.

B. <u>COMMUNITY OUTREACH</u> – Mike Anderson indicated the committee had not met again, but he anticipated there would be progress soon with Trish Coberly about the website.

C. <u>FLY QUIET</u> –Don Kuskie reported the committee had not met. However, a Fly Quiet message had been put up on the electronic sign on Peoria. The plan is to create other messages for placement there, so there will frequently be something new to catch the attention of the public as well as pilots. The Committee and airport staff were thanked for making this happen.

It was suggested this might help educate the community about what CACNR does. Question was asked how we talk about the work of CACNR to the community, Response was mostly through the website which unfortunately was not being kept up to date as thought. The use of social media has been on the list to be explored. Suggestion was made that CACNR reach out to Colorado Community Media, the various "Villagers," and other local newspapers. Question was asked who was responsible for following through with contacting the media. Mike Anderson indicated the Community Outreach Committee would be meeting with the airport's Manager of Communications/PIO, Chris Thompson, about the use of social media, the website with Trish Coberly, etc. The idea of having a media focus night was mentioned, with more discussion of the idea in September for a possible such event in October. It was noted that with more visibility for CACNR, more complaints might be expected.

D. <u>NOISE MONITORS</u> – Candace Moon indicated the committee had met, and there were two requests First was for the portable noise monitor to be replaced in Highland Ranch for at least 2-3 months if at all possible. Following that, there should be exploration of placing a permanent monitor in the southwest area where the population has grown dramatically since the monitors were originally installed. Second was to resume the staff education sessions about the noise monitors and their capabilities, ambient noise levels for each, etc. Mike Fronapfel noted the ambient noise levels are checked every year and revised as needed, and this had just been done within the last month. That information would be provided to CACNR.

The committee would like to close the loop between complaints and the available data, increase CACNR's knowledge of what is done with complaints and how they are or are not linked with offending aircraft, what might be done about communicating with offending aircraft so pilots can know if they are causing problems for those on the ground, are complainers 'satisfied' when they have asked for a response to their complaints, etc., and can there be more specific information provided to CACNR comparing complaints with the location involved. Moon indicated she would try to meet with Bill Wasmund, as the committees have some similar identified areas of interest.

Mike Fronapfel said that currently, every complaint for which a response is requested gets investigated and the complainer receives a detailed reply He suggested perhaps a case study might be presented by staff every month. That idea was welcomed. In addition, the portable monitor was available to be returned to the Highlands Ranch area, and Andy Jones indicated the location was still available.

### 7. OTHER REGULAR MONTHLY REPORTS:

A. <u>ACPAA</u> – There had been no ACPAA meeting in July. Reports from both this meeting and the August meeting would be provided to ACPAA in August; they would be prepared by Brad Pierce and Alison Biggs and presented by John Hirshman representing CACNR.

#### B. AIRPORT DIRECTOR'S REPORT -

1. Airport Activity: Mike Fronapfel reported sales of both avgas and jet fuel had increased in June, with both almost 15% higher than in 2021. Traffic was up in July. The hotel matter had been closed and it would be refurbished and reopened as a Sheraton in about a year.

The solar batteries had been stolen from noise monitor #1, so two months of data had been lost. The monitor is near some residential construction, so it may have been an attractive target, but there is little chance of locating the thief.

2. Legislative – Fronapfel indicated the airport had received the \$9 million grant which would be used for the touch and go runway. Construction will begin in late August and should be completed in late September. With that runway closed, the remaining runways would assume more traffic, probably resulting in more noise particularly for those to the north of the airport. Those neighborhoods should be informed of that possibility. Request was made for specific construction dates when they are available.

3. Other – The airport will be adding two new charging station for electric cars.

### 8. OLD BUSINESS:

A. **TO REPRESENT CACNR AT 2022 ACPAA MEETINGS** – John Hirshman would handle the August 11 meeting. Paul Krier volunteered to do the September date. Still to be filled were October 13, November 10, and December 8.

B. CONGRESSIONAL QUIET SKIES CAUCUS - Brad Pierce will soon address this topic with Jason Crow's staff.

### 9. NEW BUSINESS:

A. **INFORMATION SHARING** – Candace Moon indicated the airport was doing a tour for representatives from Centennial and Lone Tree, and requested a similar one for CACNR Representatives. Mike Fronapfel suggested this could be done before the September meeting, which met with appreciation. The airport' bus accommodates 14.

Andy Jones reported the Douglas County School District had told him about the possibility of opening an aviation program in the 23/24 school year. It was hoping to find an old plane – one that will likely never fly again – for use with that program, and asked for help locating one. Mike Fronapfel reported a Douglas County member of ACPAA had already asked him for similar help, and he will be passing along the request as appropriate.

**A-weighted Sound Level** – A measure of sound level with weighted frequency characteristics that correspond to human subjective response to noise.

Arrival – The act of an aircraft approaching and landing at an airport.

**Ambient Noise Level** – The level of noise that is all-encompassing within a given environment for which a single source cannot be determined. It is usually a composite of sounds from many and varied sources near to and far from the noise monitor.

**Community Noise Event Level (CNEL)** – The average sound level over a 24-hour period, with a penalty of 10dB for nighttime hours between 10:00 PM and 7:00 AM.

**Day Night Average Sound Level (DNL)** – A measure of the average noise level over a 24-hour day. It is the 24-hour, logarithmic (or energy) average, A-weighted sound pressure level with a 10-decibel penalty applied to the nighttime event levels that occur between 10:00 PM and 7:00 AM.

**Decibel (dB)** – A logarithmic quantity reflecting the ratio of the sound pressure of the source to a reference pressure. This results in a sound pressure level of about 0 dB for the quietest sounds that we can detect and sound pressure levels of about 120 dB for the loudest sounds that can be heard without pain.

Departure – The act of an aircraft taking flight and leaving the airport.

**Energy-Averaged Sound Pressure Level (Leq)** – The value or level of a steady, non-fluctuating sound that represents the same sound energy as the actual time-varying sound evaluated over the same time period.

Flight Track – The path along the ground followed by an aircraft in flight.

**Instrument Flight Rules (IFR)** Rules and regulations established by the FAA to govern flight under conditions in which flight by outside visual reference is not safe. IFR flight depends upon flying by reference to instruments, and navigation is accomplished by reference to electronic signals. It is also a term used by pilots and controllers to indicate the type of flight plan an aircraft is flying, such as an IFR or VFR flight plan.

**Local Operations** – Operations in the local traffic pattern or within sight of the airport; flight in local practice areas within a 20 mile radius; execute simulated instrument approaches or low airport passes.

Maximum Noise Level (L<sub>max)</sub> – The peak noise level for a single noise event.

Noise Exposure – The cumulative sound energy affecting a person over a specified period of time.

**Overflight** – Aircraft flight originating and terminating outside the area that transits the airspace without landing.

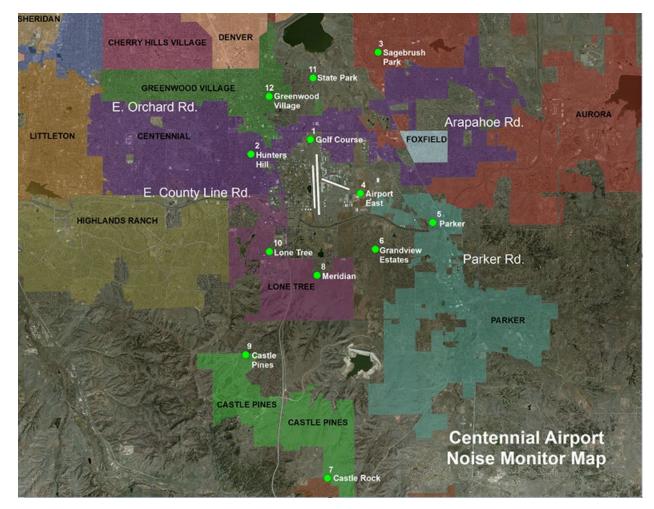
**Visual Flight Rules (VFR)** – A set of regulations under which a pilot operates an aircraft in weather conditions generally clear enough to allow the pilot to see where the aircraft is going. A flight plan is not required when the pilot is operating under Visual Flight Rules.

**Sound Exposure Level (SEL)** – The total energy in the A-weighted sound level measured during a transient noise event. SEL accounts for both the duration and the loudness of a noise event.


# **3** ABOUT APA'S NOISE MONITORING PROGRAM

Centennial Airport's (KAPA) Noise and Operations Monitoring System (ANOMS) is a new state of the art system that enables the Arapahoe County Public Airport Authority to monitor and better understand aircraft noise in the vicinity of Centennial Airport. This system is comprised of 12 fixed noise monitoring terminals in the community, as well as 2 portable monitors that are available for short term monitoring anywhere in the community.



# 4 ABOUT WEBTRAK<sup>™</sup>

As part of an ongoing program, Centennial Airport now offers an online tracking system for the movement of flights and air traffic patterns within the Denver Metro area. **WebTrak** Flight Tracking and Noise Information System allows concerned individuals to research data about flights to and from Centennial Airport, Denver International Airport, Rocky Mountain Metropolitan Airport, Front Range Airport and Buckley Air Force Base, as well as any transitional air traffic through the region.

# Definitions

**Air Taxi** – A company that operates aircraft that carry cargo or mail, or passengers on an on demand or charter basis.

**General Aviation (G.A.)** – All civil aviation operations other than scheduled air services and non-scheduled air transport operations for remuneration or hire.

**Local** – Operations are performed by aircraft which operate in the local traffic pattern or within sight of the airport; flight in local practice areas located within a 20-mile radius of the airport; execute simulated instrument approaches or low passes at the airport.

IFR Itinerant – Operations other than local operations conducted under Instrument Flight Rules.

VFR Itinerant – Operations other than local operations conducted under Visual Flight Rules.

**Overflight** – Operation performed by aircraft that transit the area and did not originate or did not terminate within the airspace.

# **6** NOISE MONITOR REPORTS

The following data displays the amount and associated decibel level of aircraft noise events at a given monitor. An aircraft noise event must contain the following characteristics:

First, the noise event must exceed the ambient noise level. This number varies at every monitor but is generally greater than 50-55db. Secondly, the noise event must last longer than 5 seconds. Lastly, using radar data, the system must correlate an aircraft with the noise event. This ensures that the sound is not associated with a 'community noise event' such as a lawn mowers or emergency sirens.






# **Current 12 Month Trend**



# **Previous Year 13 Month Trend**



Hi Samantha,

Below is the feedback and suggestions received from the Fly Quiet Committee relating to the Voluntary Noise Abatement Guidelines.

- Revisions / additions to the Noise Sensitive Areas in dark green are in order. Since the Noise Abatement Guidelines were published in 2015, there are new areas of development in Lone Tree, Castle Rock and others. The Commissioners or their representatives for their jurisdictions should review the Voluntary Noise Abatement Guidelines and add any current noise sensitive areas.
- 2. Re-double our efforts to distribute the brochure by going to the FBOs & Flight Schools. We have not done that for a few years.
- 3. Publish the brochure electronically.
- 4. Consider adding additional routings for training aircraft to and from the practice areas to the Voluntary Noise Abatement Guidelines. Rather than the one route defined today, develop several additional routings that could be used randomly. The caller from Elizabeth states that all S.E. practice area training aircraft come down highway 83/86 and then turn over her house.
- 5. Distribution of the guidelines has always been a problem. Getting them into individuals who occasionally use the airport or uploading onto aviation information sites is still an issue. Investigate other avenues of distribution of the Voluntary Noise Abatement Guidelines in addition to Whispertrack.

6. **TAKEOFF UP, NOT OVER** — Gain altitude as quickly as possible without compromising safety and begin takeoffs at the start of a runway, not at an intersection.

- 7. **REDUCE POWER SETTING WHEN FLYING LOW OR LANDING** Consider using a reduced power setting if the flight is low or when approaching the airport. Practice descent to the runway at low power settings and with as few power changes as possible.
- 8. **AVOID ENGINE RUN-UPS NEAR HOMES** Avoid performing engine run-ups at the ends of runways near housing developments.
- 9. **RETRACT LANDING GEAR ASAP** Retract landing gear as soon as the aircraft achieves a positive rate of climb.
- 10. **KEEP FLIGHT PATTERNS TIGHT** Fly a tight landing pattern to keep noise as close to the airport as possible.
- 11. **USE THE TOOLS** If a PAPI or other visual approach guidance system is available, use it. These devices will indicate a safe glidepath and allow a smooth, quiet descent to the runway.
- 12. **ADJUSTING PROPELLERS IS LOUD** If possible, do not adjust the propeller control for flat pitch on the downwind leg; instead, wait until short final.
- 13. **AVOID LOW-LEVEL/HIGH-POWER APPROACHES** It creates high noise impacts and limits options in the event of engine failure.
- 14. **AVOID FLYING WHEN HUMANS ARE SLEEPING** Between 10 p.m. and 7 a.m. Most aircraft noise complaints are registered by residents whose sleep has been disturbed by noisy, low-flying aircraft.

After reviewing the noise abatement guidelines, I would suggest that we consider noise sensitive areas to include those areas that have the highest number of resident complaints about aircraft noise. These could be from our top complaint areas in Centennial, Greenwood Village, Castle Pines and other areas. This might be considered overlapping to some extent. However, it would help pilots to remember that they are flying over areas that are very noise sensitive and the pilots could make adjustments with safe procedures in mind.
