Following are maladies of which CORIZON HEALTH INC. and MDOC STAFF have been told for years but have deliberately ignored and often refuse to enter into my medical record:

- 1. "UTILIZATION REVIEW suggested that one eye could have cataract surgery by DR. GAGO at DWH" (Chronic Care Visit, 10 JUN 2016). I was supposed to return to Kresge Eye Institute in 2016. Why has follow-up care and cataract surgery not been done?
- 2. Minutes to hours of blindness in right eye after being in sunlight and sometimes haze in both eyes. This began on 23 AUGUST 2015 with an originally red but now black floating WEISS RING in the right side of my right eye after being in bright sunlight for 2-hours. As of 20 OCTOBER 2018, a NEW NON-FLOATING BLACK SPOT appeared in center of my right eye and is GETTING LARGER. This is due to sunlight drying out my vitreous humor and OCCLUSIVE CAROTID DISEASE. On 04 FEB 2018, Optometrist Charles Lindsey of DWH said, "Guidelines for tinted lenses changed because some State employees wanted to see prisoners' eyes. You no longer qualify for tinted lenses under the new rules". Why no referral to a Specialist for treatment?
- *3. Daily ever-increasing severe angina pain in right chest that radiates to right neck and temple from OCCLUDED RIGHT CAROTID ARTERY like pain of my original heart attacks in JANUARY to JUNE of 2016. Stress test was given on 29 JAN 2019 at HENRY FORD

ALLEGIANCE in Jackson that shows one wall of my heart not working. ULTRASOUND test done on 26 FEB 2019 at LCF said my right carotid is okay.

- 4. Daily dizziness, nausea, ears ringing at 2,637 and 3,322 Hertz around 75-decibels and substantial hearing loss. Why is "dizziness" in my Chronic Problems not called Menieres Disease? Why no diagnostics or referral to a Specialist for treatment?
- 5. At 0500 to 0700 hours on most days: my pulse drops from about 60 BPM to between 23 to 40 BPM, blood pressure drops to between 50/40 to 70/40 mmHg with dyspnea, profuse sweating, and muscles in my jaw and neck become severely tired. This is sometimes followed by loss of vision, syncope, then loss of consciousness, and my appendages, face, throat and tongue often swell. This often occurs about 15-minutes after eating peanut butter or bologna sandwiches on an empty stomach. In my 01 JUNE 2015 and 19 to 26 JANUARY 2016 Medical Record. It may be postprandial hypotension. Why no testing or referral to a Specialist for treatment?
- 6. I get hives, purple skin, severe hypotension, profuse sweating, with swelling of appendages, throat and tongue upon eating an unknown food or food additive. Why NO PATCH TEST nor referral to Specialist to determine cause since 2005?
- *7. Claudication and partial paralysis of my left leg, severe sharp pains on top of the left foot, on left rear of ankle, and in left front of lower leg. Aforesaid daily causes my left leg to collapse. DIAGNOSED AS POLYNEUROPATHY on 26 DEC 2018. Why is nothing done for the claudication?
- 8. On 30 JUNE 2014, Acting CMO DO WILLIAM C. BORGERDING issued permanent SPECIAL ACCOMMODATION for DEEP TOE BOX shoes with no expiration date (MDOC BCHS, MSAC GUIDELINE #1, 22 JUN 2011). Why did NP TAMMY J. KELLEY change this to a MEDICAL DETAIL on 11 JULY 2018 with expiration date of 11 JULY 2019 for the permanent condition?
- *9. Cancer on top of my head and left face about 13-years. Topical CHEMOTHERAPY BEGAN on 13 DEC 2018 & appears to be clear on 13 FEB 2019.

On 26 MARCH 2019, my blood pressure was 220/101 mmHg when seen by Dr. Ralles & she ordered follow-up blood pressure check at 1830 hours that was not done. I normally would not be seen by Telemed because of complexity of my problems but Medical Staff at LCF are overloaded.

On 27 MARCH 2029, my blood pressure finally dropped after taking extra antihypertensives on 26 MARCH 2019.

This morning at 0400, I noticed the left side of my face is sagging. My right eye is blurry & appears shriveled & dehydrated; it will not focus.
