Dear Judge Kobayashi,

My name is Sherri Kane. I am a journalist, and former FOX NEWS writer. I have known Mr. Williams since 2013 and testified at his trial.

In my personal experience with him I found him to be a very sincere man of God, who stands firm on the principles that he believes in. Mr. Williams did everything to help anyone who sought his assistance including my spouse and I.

I have witnessed time and time again the injustices that have been committed against Mr. Williams.

Mr. Williams is not the type of man that would scam anyone. He was always forthcoming. He told us right from the start, that he is not a licensed attorney, but a Private Attorney General. He asked us to research what a Private Attorney General is. He did not lie to us, nor anyone we know, about how he could assist us, including educate us on our rights.

We even personally witnessed him go through the TSA with his Private Attorney General ID, after it was wrongfully denied the day before, by another airport.

It is appalling that the real criminals are free and not paying for their crimes, and Mr. Williams has sat in jail almost 4 years, for crimes he did not commit.

As a journalist I have done tremendous research, and personally have been a victim of fraud and theft by Big Island Attorney Paul J. Sulla, Jr. Documented evidence was provided to prosecutors in Hawaii, who chose to do absolutely nothing for many years. Eventually Mr. Sulla was indicted for one forgery, even though he forged at least 6 documents in our case.

And as another example, I was assaulted and bruised by two large sheriffs, just for filming a public First Circuit Court hearing, as a journalist, after filing an application for extended coverage. The judge told the sheriff's to remove me from the court and they did it violently,

I was bruised, in pain and crying, and the sheriff's whom assaulted me, walked over to me and told me to remember they did not lay a hand on me, and told me to leave the courthouse immediately. When someone called the ambulance, the EMTs' advised that I go to the hospital (after checking my blood pressure.) The sheriff's supervisor, told me that if I went to the hospital, they would arrest me, which they did. I was scared. I had never been arrested before. At the hospital, the police made the doctor inject me with meds via IV to lower my blood pressure, against me will, causing me more bruises. Fast forward, to the arraignment, I found they had disappeared my case, and my attorney at the time, Myles Breiner was actually

attempting to resurrect the case, in order to keep his full retainer, which he refused to return any portion of afterwards. And I never got any justice.

So to sit and watch what these prosecutors and FBI have done to Mr. Williams, knowing that he has not committed fraud against anyone, and then for them to be willfully blind to the real fraud that was presented to them, with documented evidence, makes me lose all faith in this criminal justice system.

If the government can wrongfully incarcerate a man that was helping everybody, such as Mr. Williams, then no citizen is safe from being illegally imprisoned.

The people who have scammed and defrauded people here in Hawaii such are Edna Franco, Henry Malinay, Anabel Cabebe and Hep Guinn. They have never been held accountable for all the money they stole, and lives they have ruined.

Anyone that knows Mr. Williams knows what kind of character he has, and that he would not do anything to defraud, nor deceive anyone. This is why he documented everything he did, with video recordings. My spouse and I have also documented evidence, which was placed on our video/film channel, Revolution Television.net.

Mr. Williams has my full support, and it is my hope that this court chooses to do the right thing, and set Mr. Williams free, so that he can continue to help educate the people who can't afford a bar attorney or who don't trust attorneys because they have taken so much money from people without positive results, and they have nowhere else to turn.

It is my sincere hope and prayer that you take heed to the truth that Mr. Williams is an honest man, who doesn't back down from the truth, even if it costs him his freedom, which it has. He still holds on to the truth and will not compromise the truth and we need more men like that in the judicial system, law enforcement and politics.
