DEEP STATE COUP D'ETAT#27; ENSLAVING NON-MARXISTS (07 OCT 2021):

A. MARXIST TACTICS

*** The MARXIST MANIFESTO calls for CREATING a "FAKE PROBLEM" AND preplanned LATER "FAKE CURE" TO CAUSE INTENDED TOTALITARIAN ENSLAVEMENT OF EVERYONE NOT of the rich MARXIST ELITISTS. This "FAKE PROBLEM" AND "FAKE CURE" are used AGAINST the economically SELF-SUFFICIENT who are the greatest threat to MARXIST TOTALITARIAN CONTROL, BECAUSE the POOR are mostly CONTROLLED ON the "FAKE CURE" of ENSLAVEMENT TO the government WELFARE PLANTATION. Presently, for example: MARXISTS FALSELY ACCUSE the SELF-SUFFICIENT, including Blacks and Hispanics, OF BEING "RACISTS" and "WHITE SUPREMACISTS", intending to incite various hostilities and physical violence against the SELF-SUFFICIENT (MARXISTS are RACISTS who falsely accuse others of what MARXISTS do). Such MARXIST LIES are used to take CONSTITUTIONAL RIGHTS FROM and ENFORCING TOTALITARIAN CONTROL on all not of them. This involves an "EQUITY MANDATE" of rich ELITIST MARXISTS plan for all NON-MARXISTS to be equally more destitute and impoverished than prior conditions of the most poor with intent to force all NON-MARXISTS onto the Government Welfare PLANTATION so THEY can be micromanaged or starve to death (Deep State #25, § C), like in Cuba and Venezuela. Rev. 13:17.

B. EVER-MORE BURDENSOME TAXATION ON EVERYTHING

- *** On 30 SEPTEMBER 2021, Treasury Secretary Janet YELLEN testified the \$3.5-trillion BIDEN/DEMONRAT HOUSE BILL:
- ** (1) Mandates REPORTING to the IRS of PERSONAL SPENDING events OVER \$600 "so the IRS knows if People cheat on taxes" and doubles present number of IRS Agents (U.S. Congress, 16 & 30 SEP 2021);
- ** (2) Banks must REPORT ALL SAVINGS accounts OVER \$600 to the IRS, which is to further tax People, when banks already report interest over \$10;
- ** (3) People should be taxed on income they don't earn, such as: If their home increased in value by \$10,000 in a year, they must add \$10,000 to their yearly income tax return and pay about \$5,000 in taxes on it;
- ** (4) This means persons must be taxed on money not earned and pay money they don't have or lose everything to hostile IRS agents, then be enslaved in a micromanaged life on the MARXIST Welfare PLANTATION or starve to death (Deep State #25, § C), like in Cuba and Venezuela. Rev. 13:17; and

** (5) This is to control how much you eat and own like in the former U.S.S.R.

C. MANDATES CLOSING MILLIONS OF SMALL BUSINESSES

*** Page 100 of the 2022 Federal Budget Bill mandates all businesses with non-vaccinated workers to pay a \$700,000 IRS fine for each such event. 50-percent of all employed in the U.S. work for small businesses (U.S. Dept. of Labor, AUG 2021). This mandate may force over 47% of all businesses to close and raise real unemployment to near 55% (U.S. Dept. of Labor, SEP 2021), forcing about 180-million persons to become homeless or micromanaged on the Government Welfare PLANTATION, like in Cuba and Venezuela.

D. DESTRUCTION OF MIDDLE CLASS BY VACCINE MANDATE

*** Uncle JOE, on 29 SEPTEMBER 2021, signed an Executive Order mandating millions of employed persons who are not vaccinated to be fired. Added to Section C herein, this would bankrupt most wage-earners and raise real unemployment to 60% (calculated from Dept. of Labor reports), making about 200-million persons homeless or forced into micromanaged lives on the Government Welfare PLANTATION, like in Cuba and Venezuela.

E. CREATING COVID-19 TIME BOMBS

*** ILLEGAL IMMIGRANTS are being used as human viral time bombs to infect U.S. Citizens (FNC, Judge Jeanine, 25 SEP 2021). 20 to 30 percent of ILLEGAL IMMIGRANTS have tested to have COVID-19 and 20 percent have other unknown diseases (CBP & NGO testing). ILLEGAL IMMIGRANTS are being transported to secret locations all over the United States, then their children mysteriously appear in schools near the secret locations after which the local populations have COVID-19 OUTBREAKS (NGO tracking illegals). This increases employee firings of Section D.

F. BASIC MINIMUM INCOME & WAGE

*** Uncle JOE'S planned permanent welfare for all unemployed to receive a basic income of \$1,000 a month, and a minimum wage of \$15 an hour for the employed, are MARXIST incentives to keep persons out of work. A wage floor of \$15 an hour creates a situation where unskilled persons cannot get a job because many employers cannot afford to train beginners at that wage, in which case the minimum wage is zero dollars per hour. As said in DEEP STATES #20 #21 and herein, MARXISTS are deceitfully destroying the U.S. economy and personal finances. This is intended to leave We the People destitute with little or nothing to counter predatory oppression, violence and ever-burdensome taxation by MARXIST-BIDEN; ABBADON incarnate.
