FYI ONLY, because it could endanger you if public. This explains the POMafia of which I've written:

- \* 1. On 08 & 09 JANUARY 1987, a retired Detroit Mafia enforcer attempted to murder me after I saw him pay a \$2,000 bribe to Chief Prosecutor Frey, then later testified falsely at my Conspiracy trial (1 & 2 of 5). Judge Michael J. Talbot & my 2 late Prosecutors were affiliated with Detroit Mafia, as are most Monroe County judiciary.
- \* 2. On 18 AUGUST 1988 at Jackson Prison (SPSM), a Police Informant attempted to stab me with a knife (3 of 5). I pushed his face into a wall, then he ran out of 8-Block and across the Yard to the Control Center when prisoners were not allowed on the Yard (I never saw him before or after). This was 2 weeks after I filed the Attorney Grievance Complaint that permanently disbarred Prosecutor William D. Frey on 17 NOVEMBER 1999, GRIEVANCE ADMINISTRATOR v FREY, Atty. Discipline Board No. 92-184-GA. Special Prosecutor JAMES ROSTASH (23 Washington, Monroe, MI) was suspended for a \$30,000 unlawful payment with FREY during my case, G.A. v ROSTASH, 457 Mich 289 (1999), of which I told Monroe County Sheriff Walter O. Trowbridge where to find the evidence. The attack was incited by the Detroit Mafia.
- \* 3. On 16 FEBRUARY 1990, 3 DEPUTY MONROE SHERIFF'S BEAT ME UP AND TRIED TO BREAK MY NECK. I sued; they lost (4 of 5).
- \* 3. Circa JANUARY to APRIL 1992: (a) C/O Gilbert, a regular JCF E-Unit officer, was arrested for drug trafficking involving JCF to ARF and LCF. (b) Circa FEBRUARY 1992, "Shorty" MAYS #\_\_\_\_\_ was prosecuted for involvement with the trafficking, then transferred from JCF to ARF, and put into Level 4.

\* 4. On 24 JUNE 1996, ARF Informant TOLBERT #218704 attempted to MURDER ME (5 of 5). Tolbert said, "I'm going to kill you (pause), so I can get out of prison." I got a 1.5-inch gash on my forehead, 2 fractured vertebrae and COPD as a result. Informant DENNIS POLLARD was involved. Deputy Warden ALLEN GARY HAIGH took a Mafia bribe to set up this hit, then was arrested & lost his job.

\* 5. In FEBRUARY 2000 when I was at SRF, I intercepted a SW message between two persons about transporting illegal drugs from Phoenix to Detroit, intended for a local group in Detroit that had casual affiliations with the Detroit Mafia. I reported this to either Michigan State Police and/or federal agent(s) of whom I had contact info (DEA office was at Strohs ???). In AUGUST 2000 at ARF, I saw on WXYZ, TV-7 where the group was caught in Bloomfield Hills with a semi-truck carrying drugs. I had reported that one White and one Black State Police Officer were involved (for unknown reasons) in the drug trafficking but it turned out, that maybe, a White and a Hispanic officer were involved.

\* 6. Circa AUGUST 2004, Curtis Smith in Jackson asked me how to secure his communications. I sent him a message regarding digitally encoded communications. He allegedly had stumbled across Government officials in Jackson running a drug ring. Curtis knew something about drugs being smuggled into Jackson prisons by staff. On 05 FEBRUARY 2005, I saw on TV that Curtis had been murdered, and at the same time heard on local radio that a State Police Officer named Compagne was forced to resign (who I assumed was affiliated with the group of paragraph 5). I assumed Compagne's job was to see relevant semi-trucks carrying illegal drugs got through the Jackson area of Michigan (from the media news facts). Curtis owned Smith Construction Company and was going to help me and give me a job when I got out. Before he was killed, Curtis had been visited by "two suits" (?Detroit Mafia?) who asked, "Why are you helping Northington?" "Two suits" visited 2 other friends helping me who had "accidents" years apart and asked the same question of them.

\* 7. In 2013 to 2016, illegal drugs were being found at MRF in quarter to half pound at a time. The drugs appeared to be transported inside store bags from the Jackson Warehouse to MRF. My experience circa 2015 was: (a) when I got my store bag a hole was in it but nothing appeared wrong with contents except an end being opened on a ream of paper. (b) When police

dogs came in for a practice exercise, a police dog went straight to the ream of paper at the opened end. (c) I told ARUS Klimowicz about this. MRF had a substantially high incidence of store bags having holes in them, which I am told still happens at JCF.

\* 8. For this to happen, the person receiving drugs at MRF had to have a CODE for knowing which store bags had the illegal drugs in them and which bag and where in each bag before leaving the Jackson Warehouse, or en-route, if that is what occurred.

\* 9. In 2018 at JCF my cellmate, a Level 2 prisoner BROGAN was taking hundreds of dollars of coffee to Level 1 every week to exchange for drugs coming in through Level 1, and brought back what seemed to be pounds of drugs per month.

\* 10. In 2020 to 2024, my cellmates who were dealing illegal drugs always had lots of stolen Chow Hall food, and were doing money transfers to pay for drugs. This resulted in some prisoners getting NOI hearings to pay back \$6,000 to persons sending funds.

\* 11. In JANUARY through MAY of 2025, the Dreadlock Gang members stealing food out of the Chow Hall were mostly the same as involved in selling drugs at JCF. I learned stolen food was fueling the drug trade when I had some cellmates who were drug addicts and/or drug dealers. I wrote ADW Martin McCALLUM about this.

\* 12. I believe illegal drugs may have been brought through the Chow Hall by delivery trucks, according to comments made to me by Food Service prisoner workers. I cannot verify anything but being asked to carry drugs out of the Chow Hall.

\* 13. I believe most aforesaid involved the Detroit Mafia.
