This ↑ is looking up between two Giant Red Wood trees. Amazing. The Lord created them and they grow from a tiny seed that looks like a little oat flake. Their roots interconnect so they're very resistant to storms and their bark keeps them safe in forest fires. How beautiful! [It's the only picture I could get for now. But it sure is something!]

My appeal to the UNIVERSAL SUPREME COURT OF THE TSILHQT'IN, International Aboriginal Court was heard and answered in my favor. This is a UN recognized Court and has power and authority superior over the so-called U.S. DISTRICT COURTS (bankruptcy tribunals) That falsely imprison "The People" for breach of their "corporate" statutes which are not applicable for people and not legitimately about crimes - FRAUD - NOT Law.

3 The Court Ordered that I am "to be released on his [my] own recognizance forthwith." And [I am] "exonerated of all charges and his [my] case[s] dismissed." Sent 3 April they were delivered 11 April; Then I prepared notice for the Int'l Aboriginal Court showing actions already taken; ^(above) the dishonor, to date; and call for the Court's follow up enforcement, mailed "Special Diplomatic [non domestic] Mail" 17 April; and on 18 April I was moved; then 19 April an attempt was made for having me "sign" for "return" of the Court's mail. It had the stamps defaced with black marker and a plain label stuck ~~of~~ over the Court's address with a RED stamp "RETURNED" [FRAUD!] No way it would be RETURNED; nor in only 2 days could it have been sent to the Court and RETURNED — FRAUD; LIES; OBSTRUCTION OF JUSTICE; theft of non domestic mail and more felonies. The matter cannot be so easily, criminally dishonored and obstructed. Pray for justice!

I love your sharing about moose; did you mention Caribou? I've heard moose are very good. Bison are good. I've ate them but never took one in their cull hunts.


In considering all of this, I consider such as Mark 13: 9-13.
