

In support of Schaeffer Cox #18 August 20, 2017

As I sat in the Appellate Courtroom (August 16, 2017), I positioned myself to best see the faces of those speaking. I wanted to see the demeanor of those talking.

All involved were excellent in presenting their side. Michael Filipovic presenting the truth and Steven E. Skrocki presenting the lies. I wanted to be in court to see the faces of those speaking. I was amazed on the ability of Skrocki to look the appellate judges in the face and continue his distortion of the truth.
