

In Support of Schaeffer Cox # 22 September 28, 2017

I was led to believe Schaeffer's conviction revolved around two separate incidents. One dealing with the solicitation during his interview at KJNP radio station and the other dealing with a conspiracy during another time period. I was in error. Schaeffer's conviction dealt with a single event at KJNP radio station. But all I hear about is Bill Fulton. Nothing more than a loudmouth braggart. As if he had anything to do with Schaeffer's conviction. As he told me,

“ I was a witness called by the defense ....so the whole key government witness thing is bull as for the book being fiction no [sic] everything about Mr Cox the hows and why's the trial is all true the only fiction in the book was changing names and condensing multiple events into one or two for story line cohesion your taking a conversation I had with ----- (name redacted) and twisting it please don't.”

Too much time has been spent discussing this blowhard Fulton. When the fact remains Schaeffer was convicted of solicitation dealing with the event at KJNP in North Pole Alaska (which was thrown out because the government hit team did not exist). The other conviction was the alleged conspiracy to murder this same government hit team (that did not exist) if they attempted to kill Schaeffer during this same time period at the local radio station in North Pole Alaska.

And how many were convicted in this grand conspiracy to kill federal thugs? A grand total of two. Schaeffer Cox and Lonnie Vernon. Was it during some active offensive behavior? NO, it was going to be in response if and when the government hit team came to KJNP radio station to kill Schaeffer Cox. The government prosecution, through Skrocki, acknowledged the hit team never existed and the average American would never believe a government hit team could exist in America.

Skrocki's entire case revolved around the plan to kill federal officers at KJNP radio station and Lonnie Vernon would be involved along with Cox. The only two who were ever charged and convicted of conspiracy. (More on this in my next post.)

The Ninth Circuit Court of Appeal ruled unanimously Schaeffer could not have solicited Vernon with murdering this government hit team because it never existed. But yet they maintained the conspiracy that Vernon and Cox had an intentional agreement to violate federal law and they committed some over act in the furtherance of of their agreement.

How can it be against any federal law to defend yourself or others?

But the current legal question presented by Schaeffer's attorney, Michael Filipovic, is the question of the day.

**IF THERE WAS NO GOVERNMENT HIT TEAM GOING TO KJNP RADIO STATION WHO WERE THE FEDERAL OFFICIALS SCHAEFFER AND LONNIE VERNON CONSPIRING TO KILL?**

Steven E. Skrocki knew how weak his case was. But he had the depth and economic power of the entire federal DEPARTMENT OF JUSTICE and media attention to create the corrupt conviction.

All he had to do was keep exculpatory evidence from the jury and make sure the media reported anything that would demonize Schaeffer. To make sure he had the jury in his pocket he presented witnesses after witness who talked about the militia hit list and all the objectionable things ever spoken by those in the militia. Words really. First Amendment behavior.

Steven E. Skrocki could never prove a conspiracy outside of Lonnie Vernon and Schaeffer Cox at KJNP. Because there never was one as defined by law. Free speech only.

And the grand conspiracy theory created by Skrocki was actually nothing more than community members preparing to protect Schaeffer if and when a government hit team came to kill him.

This case is clear in my mind. Even without the exculpatory evidence being exposed this conviction should never been accepted by the District Court.

Now the question remains will it continue to be upheld by the Ninth Circuit Court of Appeals in a rehearing asked for by Filipovic?

Justice can best be served by setting Schaeffer free. Steven E. Skrocki can always spend more of the peoples' money by attempting prosecution again on some other Conspiracy theory.

Perhaps Bill Fulton could be the primary witness for Skrocki's grand conspiracy theory.
