Texas Terry,

I am obliged to start this correspondence with an expression of my gratitude for your hardihood in coming forward with the truth, so justice at least has a chance to prevail. I know the anxiety that the enemy's wicked ways play on a candid mind such as you maintain, therefore I thank you for having the mettle to do the right thing, simply because it is right.

Having no faith at all in the courts, through first hand experience, I know the odds are not in my favor to obtain relief from the unjust circumstances I am suffering. I am currently waiting on the enemy's response to the habeas corpus petition I submitted, which is due next week, but I expect an extension for time to be granted to the enemy, probably another 60 days. I have also submitted other affidavits of witnesses who were also denied an unfettered decision whether to testify or not, by the enemy's threatening and intimidating actions. Furthermore, the trial attorney who assisted me has submitted an affidavit stating he did no preparation for trial. My most substantial claim, besides the enemy stealing the evidence I personally obtained, threatening my witnesses and the refusal of the court to issue me any subpoenas, is the fact the court disallowed my 100% lawful and plausible trial defense: a good faith self-defense against imminent unlawful excessive force.

My effort to obtain justice for the violation of my rights, that occurred when the enemy's hirelings attempted to murder me, is currently waiting a court ruling on whether I submitted enough evidence to warrant a trial. If I clear this hurdle, I expect a trial to occur sometime in late summer or early autumn. Moreover, I want to direct your attention to another malicious violation of my sacred rights by the appointed instruments of oppression: the enemy's mercenaries stole all my liberty tools without cause. Being that they could not connect my liberty tools to any unlawful activity during the trial, unbeknownst to me, the enemy initiated a civil forfeiture proceeding, separate and distinct from the criminal proceedings, and my tools were forfeited to the enemy by default because I never answered the complaint. About 18 months later, I became privy to this forfeiture, thus filed a claim to reopen the proceedings, since I was never afforded notice of the proceeding. The enemy put forward postal documents: a certified mail receipt and the return receipt with the signature of the attorney who assisted me in the criminal trial, as proof this notice was provided in accordance to the supplemental rules of forfeiture. The courts, both district and appeals, relied on these postal documents to deny my claim. Upon further investigation on my part, I discovered, after mailing a copy of these postal documents, which were an exhibit in the case, to the attorney who had supposedly received and signed for the notice, only to have this attorney enlighten me to the fact that he never received such notice, and that his signature on the return receipt was a forgery. I am now in the process of filing a lawsuit, seeking justice for this blatant violation of my unalienable rights. Upon closer scrutiny of the postal documents, I realized the certified mail receipt was missing the circular postmark, and the return receipt was missing the processing tic marks, and the post office has no record of the certified mail number.

When I reflect on how the theft of my property, by the enemy, has played out so far, a scripture comes to my mind:

Behold the wicked brings forth iniquity; yes he conceives trouble and brings forth falsehood. He made a pit and dug it out, and has fallen into the ditch which he made. His trouble shall return upon his own head, and his violent dealing shall come down on his own crown. [Psalm 7] The scriptures are never wrong.

I feel the disposition to present to my reader a candid discussion on why

the national government is illegitimate, exercising our unalienable right to speak freely. The keystone to the claim I make, is that the national government has unlawfully surrendered the Peoples' sovereignty to a private foreign entity that is bent on destroying the liberty bequeathed to us by our venerable forefathers. The entity I speak of is the fountain from which all corruption and immorality flows-the federal reserve system.

The federal reserve is one of many central banks throughout the world. Like the others, each central bank takes on the likeness of a parasite, slowly destroying its host, as itself becomes stronger and more formidable. All these central banks are under the direction and control of an aristocratic cabal of international bankers, who believe it is their right to dominate and enslave us. Their most potent weapon that they use against the People to dominate them, are irredeemable bills of credit, aka federal reserve notes, which have been foisted unto an unsuspecting public by the national government, via unlawful legal tender laws. Paper money is a pestilence which inflicts nothing but destruction.

If any individual would endeavor by sound circumspection and honest reflection to look at the role the federal reserve plays in the national government, they will soon come to the unimpeachable conclusion, that it controls the government, regardless to what faction is conceivably holding a majority; and this goes for the courts as well. Metaphorically speaking, if I control your wallet or purse, meaning I control how much money goes into and out of it, don't I control your actions, your standard of living, and the means by which you survive? The enemy's bank has this control over the national government, thus its the enemy's government, not the Peoples', to state otherwise would be a canard. The enemy's bank and government have a mutually beneficial relationship. The bankers get filthy rich by robbing their beast of burden-the People; and they maintain the lion's share of power and control over the host country. The politicians, i.e. Congress, gets to deficit spend without the public knowing it is being taxed, via inflation.

Let's talk about inflation for a moment. What exactly is it? It is when the quantity of money in the market place is increased, without a harmonizing increase in goods. The effect is a reduction in the purchasing power of each monetary unit. For example: let's consider the board game of monopoly. Their is a fixed number of items (property, railroads, etc.) to purchase and a fixed amount of money in the market place (the money the players have plus whatever is in the bank). The banker decides to double the amount of money by placing all the money from a second unused monopoly game into the bank of the active monopoly game. Mathematics tells us, that as this money flows into the market place, the prices of all the items will eventually double, reacting in direct proportion to the increase in money. The winner of such a scenario, is the person who gets to spend the new money first before the effects of inflation take hold. The losers are all the people who now have to pay double because of the loss of the purchasing power of the money they hold, seeing that only a select few can be the ones to spend the new money into the market. The losers, not knowing they have been surreptitiously robbed, try and remedy their loss by working harder and longer, like a SLAVE!

The enemy's federal reserve is a thief, that constantly is robbing the American Peoples' labor, wealth and purchasing power. The purchasing power that is stolen from each monetary unit doesn't vanish, it is transferred into the new money, to give it life so to speak. The national government is the first to spend the new money, most of the time, on things and programs to complete the enemy's system of despotism over the Peoples' sacred rights and liberties. The People are left to cope and struggle under the never ending theft of their purchasing power, as a police state is being foisted upon them. Now, my reader should have a firm understanding why both the husband and wife have to work fifty hours each per week, or why an individual has to work two jobs, just to make ends meet; and why back in the day we had penny candy that now costs 50 cents.

Listen and listen good, so you get this important fact into your psyche, if

there is only one principle or fact you learn from this correspondence, let it be: inflation is tantamount to taxation without representation. Inflation is theft, plain and simple. Inflation is an inescapable direct tax, on anyone who uses a federal reserve note. A tax that is not debated, not in law, and doesn't have to be collected. It is the masterstroke of all the taxes a tyrant seeks to impose.

The enemy's pensioners and placemen in government tell the People that the rising cost of health care, or the rising cost of this or that, needs to be controlled, therefore a massive health care (or whatever) bureaucracy must be put in place, when the enemy's government and central bank are the culprits that caused the costs to rise in the first place, through their iniquitous system of inflation. Americans are lamenting the rising cost of gasoline-not enough supply, too much demand, lack of refining capacity-whoever told you that-deceived you. That may be a part of the reason, but you should also consider that the price of the gasoline did not just go up, the value of your money went down too-you've been the victim of the enemy's theft by way of inflation. We, the People, as one, are being plundered by inflation, which could not happen, if our sovereignty had not been placed into subjection to a foreign power, i.e. the international banker's federal reserve system, with its paper currency.

The People have been placed under a power, by our trustees, without our consent, knowing such power aims to destroy us. The Peoples' ordinance or constitution, which is suppose to limit the national government and promote individual liberty, does not grant the authority for such an absolute power to be used against us. The desire of the aristocratic cabal of internationalists is to have us in their absolute power; and to be able to compel us by force if necessary, which is against our right to freedom, to make us slaves. To be free from such unlawful force is the only security to our self-preservation. Reason bids us to look at this symbiotic partnership between the government and the central bank as making them our enemy, who are conspirators of a well orchestrated plan to take away our liberties, thereby

putting themselves into a state of war with the People.

To render this point perfectly self-evident, I believe an example from the pre-revolution era will suffice: after patriots had taken back John Hancock's sloop, Liberty, from customs, and ran the custom collectors out of Boston, Governor Bernard sent two ships to go get troops and had the beacon on Beacon Hill destroyed. A town meeting was called at Faneuil Hall in September 1768, to address the concern of the forthcoming military force, where an old man stated the following to a packed crowd, as denoted in the public record:

"Liberty is as precious as life, and if a man attempts to take my life, I have a right to take his, therefore, if a man attempts to take my liberty, I have a right to take his life, also when the Peoples' liberties are threatened, they are in a state of war, and have a right to defend themselves."

At this same town meeting, 400 of the Peoples' muskets were taken out of storage, were cleaned, and positioned throughout the hall.

The national government's trustees have violated the trust; and once the trust has been violated, authority no longer has a right to our obedience. It is generally clear as it is true, that we are under no moral obligation to submit to any power that aims to destroy us. The national government has dissolved itself, through its own actions-by delivering the People over to a foreign power, to be oppressed and plundered. As the Declaration of Independence let's us know, the People have a right to revolution. Since any government exists to nourish and insure freedom and equality under the law, and indeed has no other higher purpose, when it has betrayed these obligations, it lost its legitimate authority and in a sense annulled itself, leaving the People free to replace it. The right to revolution in fact, was inseparable from the instance the government was formed. Far from being an absolute or divine institution recognizing no superior authority, was in fact subordinate to certain purposes and principles, which those being governed

could discern and judge for themselves, if a divergence between the acts of government and the purposes and principles the government was originally formed for, required that the government be changed or abolished.

The People do not hastily revolt, nor do they revolt over trivial violations or transient causes; and history has shown us that mankind are disposed to suffer under evil, instead of righting it by abolishing the forms they are accustomed to. But, as here, the People have been forced to suffer for so long the theft of their labor and natural rights, under an evident system designed for the objective to reduce them under absolute despotism, it is their right, it is their duty to throw off such a government. By no means is our task an easy one, but be assured it is anchored on the mature an dignified taste for freedom, and not some ill-defined cause. Our cause has not contracted an alliance with the turbulent passions of anarchy, but its course is marked, on the contrary, by an attachment to whatever is lawful and

With each act injurious to freedom, once it has been done, and the People bear it, the repetition of such act is more likely to be met with submission; and at some future time the present submission will be plead as a precedent. I hope and believe I live in a country, where the People are too intelligent and too brave to submit to tyrants. It would be beyond measure, astonishing, that a free People could see the miseries of such a despotic state approaching to them with large and hasty strides, and suffer themselves to be deluded by the artful insinuations of the enemy's sychophants in the mass media, into a full persuasion that their liberties are not in danger, when in reality, it has been conclusively demonstrated beyond any credible debate, we

are incrementally being enslaved.

orderly.

The government has erected its own interest separate from the governed; it has become independent of the People and is bent on enslaving them. Right now we are being subjected to arbitrary power: theft of our labor by way of inflation, onerous taxation, oppressive regulations and the licensing of our guaranteed rights, where the constitution has become a dead letter, especially the Bill of Rights. The enemy's national government is in a peaceful conquest without opposition or molestation, of the States and People, because we do not fight back with the necessary force.

We know the enemy's government was complicit in the assassinations of J.F. Kennedy; M.L. King; R.F. Kennedy. We know it was complicit in the Oklahoma City Bombing and 9-1-1. We know it attacked The Weavers at Ruby Ridge, the Davidians at Waco, and the Browns at New Hampshire. These are just a few of the atrocities that let us know what the design the enemy has for every American who shall not surrender their sacred rights and liberties into the hands of the internationalists. Now, therefore is the time when all should be united in opposition to this violation of the liberties of all. I cannot emphasize enough the vast importance of union. I ask a single question, whether my reader considers, people like myself, who are now suffering in the common cause; and do you sensibly feel and resent the injury and insult inflicted on us? If you do, and we cannot believe otherwise, may we not, from the approval of our former conduct in defense of American liberty, rely on you to stop cooperating with the enemy, but instead take the fight to the enemy, as is your duty and lawful right? Your opposition to tyranny by the government must grow into a system. The events of such a glorious struggle in the common cause for liberty has often proven fatal to tyrants, who in our particular struggle need to be reminded that we reserve the fire of resistance to tyranny in our hearts. We must be united in our sentiments and opposition to the enemy's unlawful federal reserve system with its pernicious systemic inflation, which is the root cause that is imposing tyranny. They have encroached far too long upon our liberties, which is only getting worse. It is every American man and woman's duty to defend and restore our

liberties, not only for ourselves, but also for our posterity.

I advise persisting in our glorious struggle for liberty until either liberty is restored and God beholds with pleasure that just vengeance as the

guilty mortals perish, or every liberty loving American who dreads death much less than servitude, perishes. I say this knowing, as it was revealed by nature, that if 999 were to perish, and only one of a 1,000 to survive and retain liberty, one such freeman would possess more virtue and enjoy more happiness than a 1,000 slaves; and let him propagate his likeness, and transmit to them what he has so nobly preserved. The public's liberty must be preserved at the expense of many lives, indeed this will be a great sacrifice, but by comparison, where would you be if the generation of 1775, our renowned ancestors, had not laid down their lives for our liberty.

Although I fear I have put your patience to the trial, I cannot withstand a strong inclination to communicate a little more on my mind to you. The honest part of mankind, the people who enrich themselves by none other than honest means, who live a virtuous lifestyle and have an inherent unquenchable love for truth and justice, are the ones who must speak out and let our wicked enemy (with its hirelings, placemen, pensioners, jobbers, and the like, who now swarm us like locust and caterpillars, who have prostituted the honor of their profession, prostituted the law whenever their masters should require it of them and have prostituted their very conscience, to oppress and plague the People they were bound to protect), know they are willing to defend their unalienable rights, and if necessary, drive of like chaff, their wicked underlings.

We live in an important period, and have a post to maintain, to desert it would be an unpardonable crime, and would entail us the solemn curse of posterity. Duty and self-sacrifice is all that stands between liberty and total enslavement. Our goal is to reestablish true freedom of the individual and forever end fiat irredeemable bills of credit as currency by tossing them all into the dustbin of history, never to set foot in America ever again.

The liberties of our country, the freedom contained in our Bill of Rights are worth defending at all hazards; and it is our duty to defend them against all attacks. We have received them as a fair inheritance from our worthy ancestors, who purchased them for us with great toil and danger and expense of treasure and blood; transmitted them to us with care and diligence. It would bring an everlasting mark of infamy on the present generation, enlightened as it is, if we should suffer them to be snatched from us by violence without a struggle, or be cheated out of them by the artifices of false and designing men. Let us consider our forefathers and posterity; and resolve to maintain the rights bequeathed to us from the former, for the sake of the latter. Instead of sitting down satisfied with the efforts we have already made, which is the wish of our enemies, the necessity of the times, more than ever, calls for our utmost circumspection, deliberation, fortitude and perseverance. Let us remember, that if we suffer tamely a lawless attack upon our liberties, we encourage it. Thus every such attack, must be met with force, lawful force that is.

The enemy has a wicked tendency to steal my mail, and seeing the enemy vindictively has deprived me of email until May 18th, I have no way of knowing if this correspondence made it to your hands, unless you write me back or let my brother know you received it, so please let me know.

Texas Terry, I most humbly implore you to post this correspondence online, being that it will do no good collecting dust after you are done with it. I exhort you to get as many people as possible to read it. Feel free to redact what you may, even though it will sink my heart. I have written other correspondences, to other patriots, who posted them in an effort to prepare the public's mind. Our mutual female friend in Indiana is to link all my letters together, so our fellow countrymen can be educated and enlightened. Please contact her, so as many patriots as possible can read these truth grenades. This will also affect our unity, and strengthen our cause for liberty. I know you are an honorable man, so I am comforted that this simple task will get done.

Well I believe I have gone a little overboard, so out of respect for my reader, I will end it here, waiting patiently to hear you have received this.
