Warm Christian greetings, I've been
meaning to write you for some time now.
I've heard some great things about you.
Decided since I am gonna be in some very
serious need of expert help in the
legal field, wanted to introduce my self
to you. Share a little of my self,
Fast speed up to why I am on this
major de-tour of death row. That this
temporary stay close to over with. Soon
to re-start my life over some where.

First - best wishes for a safe, healthy,
merry holiday season - Greatest event in
my life is Christ Jesus accepting me and
by God Almighty love and grace. Sweiving
me, Adopting me into His family of the
beloved, Redeempted people. Hallelujah -

My name is Dennis Morgan Hicks.
 Born in Mobile, ALA. in August First
 1958, Old mobile Infirmary, Last of
 10 kids, 6 sisters, 3 Brothers. Dad
 Amrose Travis Hicks Sr. born in Cluehill
 ALA, mother Marie Minnie Morgan
 born in Selma ALA.

After over 2 dozen yrs of marriage,
 when I was small. My folks decided
 to divorced. Worst thing happen to me as a
 kid. As a child I had a heart condition
 Born with what is cause a tumor, (hole
 inside my heart, Also it was enlarged
 and several specialist believed I'll die
 before my teen yrs. But God Almighty
 had other plans, was under doctor care
 for half a dozen yrs. Release at
 about 12 to do normal children activities
 in playing and such. Allow to do sports.

During my parent years of divorced.
 mother would carry the 4 little ones
 to church. True, some time we'll be the
 late, last to get there. But mother had
 a lot on her plate with 4 children
 back in the 1960's I learn of Christ Jesus
 as a child, from mother, church and
 many others in my family, uncle, grand
 daddy was preacher for over 50 yrs. each.

I accept Christ Jesus. And even though I was kinda an emotional child. I begin getting into things. Didn't listen well to my teaching, had to repeat the second grade in school due to not being able (are so I thought) learn my ABC letters.

Well through the natural progress of life, Cotton well and Mother re-married yrs. later. Dad re-married. I seem to be the only child that the divorced effected in a real (emotional) damaging way. Cause extra problems, seem like now, but at the time, truly just wanted attention, so much was going on, was 12 at 1970, a lot of America dealing with Richard Nixon, President George ~~W. Bush~~ ^{W. Bush} as Gov. The war in Vietnam all the killing, Also John F. Kennedy, Martin Luther ^{King} Jr., so many assassinated, the south going or coming out of the jim crow era, Racial junk in the south. lots of confusion.

Still, as a teenager, I sought to live in the side show attraction of the night street life. ~~Spending~~ ^{Spending} out on week end, going to pool halls and such. Due to my disability, of not being able to read until later high school yrs. I did not stay in Dad's word.

Even though I was told and show to.
 I went with sight and accepted the
 world views on things, Pitiful really,
 but from about 14 to 21 was colorful
 yrs for me. Had dozen encounter with
 the law. Arrested for breaking into
 schools, begin smoking, then marijuana,
 pills at 15, shooting drugs at 16.
 Off and on by 21, I did most every
 thing in the neighborhoods. Drop out of
 high school in the 11th to go to work.
 Went to jail, then prison, on a
 youthful offender order. Purchase under
 the table, P.A., 2,000, Judge Charles
 Gaddick, judge 3000 Elwood ^{Hop} Did about a
 yr, cases drugs, pay damages, got out
 went to live in S.C. with older brother.
 Hurricane Fiddick hit in 1979. Come
 back to help mother, fix up property
 from the storm, go to work. Got in trouble.
 Got into a double homicide, a
 homosexual couple tried to rape my nephew.
 During the conflict, I shoot both of
 them. I admitted my wrong, refused all
 deals by the court, was sentence to
 2 life sentence, manager claim I could of
 gotten manslaughter, gotten out in 5-10 yrs.
 but I had turn my focus attention back

to God. Gotten into His word. And my
faith He gave me. Begin to grow.

So, I confessed and was sentenced to
2 1/2 year sentence. Haven't smoked,
or did drugs, since, plus a lot
I use to do, I don't now. I
live by faith, not sight or govern
my life with feeling. A lot of
wonderful blessings God gave me over
the next 25 1/2 yrs of my life.
Great jobs inside the prison, further
my educational advancement. From 21 to
46. Was in MS. prison. Was parole
in 2005, Feb. After 7 appearance.
Was living with my wife Christy in
Corinth MS. Doing construction work,
Member of First Presbyterian of Corinth.
Mother involved of 30 yrs. passed on in
April. Sibling wanted to put mother in a
rest home. 82 yrs. old. She summoned
me home to be her full time care giver.
wife day time. For about a year, then
day and night took care for her. She passed
on in Sept. 6, 2006. We was member of The
Worship Center Power of God, small church.
From 2006 to 2011. I had the green
light to go back to my uncle or any
where else, but was involved with my
church, had family members. So. I stayed

But falsely accused of a haul-utility
trailer theft. I purchased it. Produce
a sign bill of sale, with the man's
signature before witnesses to the
court. But his grand mother claim he
had stole it from her and that
I did too. Well, was bound over,
and got out on bond. Several
months later. The guy, 23 yr. old,
was found dead. A year and a
half later. I was issued a secret
in dict note. Claiming I did it.
Was jail for close to 5 yrs. From
2011 to 2016. My lawyer only work
on my case for like 3, 4 months. I
was fired 3, but lost 2 was the
worst and they lied to me. Most of
my witnesses was left outside the
court room. Show up to testify for
me, but lawyer did not call from.
Call none of the expert they promise
to. None. Well, they help DA, and
judge find me guilty by false, manufacture
evidence and sentence me to death row.
Been here since April of 2016. I
was lead to some Christian lawyer at
Equal Justice Initiative law firm. They
did my appeal. All is under review
now. Can expect to hear a favorable
reversal ruling any time starting next

year. I believe God's truth gonna make clear to the higher court, how the lower court was blinded, confused, lost the mark on the case and frame me for it due to my history in MS. which they got my parole revoked. Had dual parole for MS. Ala. Case 13 39 yrs. old now.

I attend Kairos City of Hope. Catholic church services here on death row, plus others volunteer and come in to fellowship.

I read, study, try to keep busy on little project I create. I hope to write some books. Ask God to give me a spirit of invention and creativity and I believe He has so, I can help God's church with some insightful, meaningful help.

I believe, I'll get this disgraceful shameful corrupt verdict off my record next year. Be able to go back to MS. Receive a pardon and re start my life over. Get a pardon from Ala. Gov. too.

Mail pile up was just call. I will write some more when I hear from you. I do offer my friendship and ask for yours. Beginning with

prayers, could use some help, and heard that you some time put offender on wet sight. never had one. But would be interested in getting on. Maybe get some folks to write me. So many of my family and so call friend walk out of my life. Believing the lies the police call. But if you contact my lawyer, Mrs. Rachel Judge at the E.I.I. Law Firm, she'll give you the detail of my case, and show you that my innocence was over take by the lower court.
