Greetings to my brothers and sisters in arms. I hope this letter finds you in good health and spirits. First, I want to thank everyone for continuing to write. It lifts my spirits to know that I've not been forgotten. I can be lonely within the confines of steel and concrete.

I am writing this as an update to the situation that I've found myself in. The last few years have done much to destroy my faith in the so-called justice system. After years of screaming from the rooftops concerning how the State of Oklahoma has trampled my rights and years of the court system turning its back on me, I can say it's difficult not to become a little jaded.

After a couple years of fighting, I have exhausted my state appeal rights at this point. I appealed at all levels and showed clearly that the law demands my release as there is no evidence to sustain a conviction, not to mention nearly 50 counts of provable perjury that the state used against me. The State of Oklahoma failed to answer a large portion of my claims and could present no evidence whatsoever to corroborate their allegations nor explanations for the perjury they used. However, being that I am a Pro Se litigant without the privilege of an attorney to fight for me, the courts never even gave my case a cursory glance. Instead, simply crumpling my papers up, throwing them in the trash and issued a cookie cutter denial; sentencing me to spend virtually the rest of my life in prison without so much as an explanation of how my legal assertions are incorrect.

Therefore, I have since filed a Habeas Corpus appeal to the federal courts. This was filed in August 2016. Due to the fact that it's a very complex case, in the legal sense, it could take years to be resolved. And, once again, I find myself Pro Se because I cannot afford an attorney. Common sense would also lead me to the conclusion that my case will be denied on just this fact alone. When no one is looking, our government will, and has, enacted grave injustices. But when the public is watching, justice seems to find a way of creeping in. This is the reason I have asked anyone willing to respectfully write the judge reviewing my case. This lets the judge know that people will, in fact, know if he discards or disregards the appeal without proper consideration. It is this reason that I humbly ask that anyone willing, continue writing the judge until a decision is made.

I sincerely hope that none of you find yourself on this side of the walls of a prison because I can assure you, getting out, is next to impossible. Once a government entity has its fangs in you, it will not let go easily. My only hope at this juncture is that the federal courts will pry Oklahoma's jaws from my neck. It... Is my last hope... That hope, is non-existent without your aid. For anyone interested in seeing the federal appeals documents that have been filed in my case, I have requested that they be made readily available for no cost to the public, which my family has done. Also, they have released the address as well as sample letters to the judge involved in the case. If there is any specific piece of evidence or a court document that isn't presented that you might wish to see, I will do my best, to make that available if feasible or allowable. I want nothing to be hidden so that the people can see the injustice and that truth be allowed to prevail under the scrutiny of light.

For those of you that stand with me, I offer my love and respect. For those of you that call me enemy, I also offer my love and wish no harm to come you. For those of you that fail to stand due to apathy, I offer these words: "All that is necessary for evil to triumph is for good men to do nothing" ~ Edmond

Burke. I ask you not to make this mistake. I am in need of your help and fear that I will not prevail without it. I fear that evil will overwhelmingly destroy me if men and women of good character do not lend aide.

I humbly and respectfully thank you all for your taking the time to listen to my words and I additionally thank you for caring about your countrymen. As a great man once said: "We must, indeed, all hang together or, most assuredly, we shall all hang separately." - Benjamin Franklin
