Comes now Defendant/Victim acting without competent, effective assistance of counsel. Objecting to the non written waiver of Counsel! Defendant/Victim is not knowingly or intentionally waiving right to competent and effective assistance of counsel in the above titled action. Let this serve as a demand of the same. *Article 1 Section 18a Missouri Constitution* Defendant/Victim is severely disadvantaged being held on an outrageous bond despite the fact that he has never missed a court date. Thus he ^Shas not able to shop for effective and competent Counsel. Defendant/Victim had incompetent Counsel at beginning of this case ineffective to say the least. Once it was apparent that previous Counsel was working against interest of Defendant the conflict severed our relationship. Since then Defendant/Victim has acted on his own behalf by force of arm,

stumbling, rumbling and bumbling around the Courtroom. Defendant/Victim not being able to produce an income or be able to make calls that are not cost prohibitive or even timely, Defendant/Victim has not been able to even buy a phone call since before last hearing March 19th. While locked in jail over the last 5 months Defendant/Victim has not been able to work and has spent well over \$1,000 on phone calls attempting to secure Counsel.

Defendant/Victim has not been able to even get any Officer of the Court to visit. Equal rights and opportunity **Article 1 Section 2 Missouri Constitution** have not been afforded Defendant/Victim in preparing his defense. It is a miracle that a Computer has been made available. Though no secured cost effective phone, internet access or ~~even a printer~~ has been afforded defendant, once again Defendant/Victim is extremely disadvantaged.

Motion to Dismiss in light of Discovery

Upon review and in light of discovery, Defendant/Victim believes this whole matter to be nothing more than a tactic to deny Defendant/Victim his right to be compensated for

the excess use of force, attempted murder of Defendant/Victim. Even though

Defendant/Victim has no formal law education and is not a member of the BAR it is clear to anyone who can read and has ears to hear that the STATE case against

Defendant/Victim is lacking essential elements that Defendant/Victim committed any crime! Trooper Folsom, Mertens and their co-conspirator PA Parks, are acting in Concert

to convict Defendant/Victim of crimes that he could not have possibly committed. Once convicted of the crimes as to which Defendant/Victim has been accused it will in effect save the STATE OF MISSOURI millions of dollars. Thus Depriving Defendant/Victim of his liberty and pursuit of happiness, the gains of his industry as well as just and rightful compensation which should be afforded any victim of such caviler and excess force. **Article 1 Section, 2 Missouri Constitution.** When the victim is shot and then charged with assault and armed criminal action etc, obviously our government has failed it's chief design.

Defendant/Victim while in jail is now getting divorced has not seen his children in over 200 days and cannot attend to his publication of this last 17 years. **Article 1 Section 8 Missouri Constitution** Defendant/Victim was shot four times at point blank range on 9-11-12, in an attempt to take Defendant/Victim life. By the grace of Almighty JAH and the Blood of His Son **Jesus Christ** Defendant/Victim is recovering, despite being denied his treatment, medication and therapy while in the Custody of the FRANKLIN COUNTY SHERIFF STATE of MISSOURI. Defendant/Victim furthermore believes that the Chief Executive of the STATE OF MISSOURI along with the MISSOURI SUPREME COURT and the MISSOURI HIGHWAY PATROL are conspiring to cover up crimes committed by their agents. **Article 1 Section, 10 Missouri Constitution.**

Defendant/Victim at the time of his attempted murder was the Democratic Nominee for the office of Coroner in Crawford County. While running for the office of Coroner, Defendant/Victim made it known that he would be looking into murders that had been committed by law enforcement. Thus a motive for the attempt on his life as well as the fact Defendant/Victim believes **that unless there is an injured party there can be no crime**. Why would Defendant/Victim attempt to draw his holstered unconcealed weapon, when he was there to pick up his computers? Trooper Folsom assured Defendant/Victim that his only intention of the meeting was to return Defendant/Victim property, see motion to Quash. Who drew their weapons and discharged them six times? Certainly not the Defendant/Victim! How can Defendant/Victim be charged with resisting arrest when he was not told that he was

under arrest and arrived at the meeting with the assurance by the shooters that this meeting was not an attempt to arrest Defendant/Victim? It was to return his Computers. Another LIE! Imagine that, Listen to the Folsom Interview! Missouri Highway Patrol Supplement #17. My God this man is on Fantasy Island. You can't believe anything he says. **He was a murderer from the beginning and abode not in the truth, because there is no truth in him. When he speaketh a lie, he speaketh a lie, he speaketh of his own for he is a liar and the father of it. John 8:44 KJV.**

Defendant/Victim acting without competent, effective assistance of counsel therefore request that these charges be dismissed based on the facts of this matter and of law. How can Defendant/Victim be charged with two counts of Attempted Assault of Law Enforcement Officer? Even according to the perjured testimony of both so called law enforcement officers, who did attempt to kill and cause serious physical injury, Defendant/Victim never even allegedly got his firearm out of the holster. Thus there is no way that defendant could have attempted to kill or cause serious injury by shooting them. Of course the only ones who maintain that Defendant/Victim even tried to draw were Folsom and Mertens. Sgt Folsom and Cpr. Mertens testimony of the event does not even remotely coincide with the audio recording of the event, made by Defendant/Victim, Folsom basically writes a novel as to what happened in less than 12 seconds. Folsom claims in audio interviews of the event conducted by the Missouri Highway Patrol, that Folsom stated to defendant/victim ***"Jeff, I got your computers right here. Yea I Got the papers right here"***, Folsom Interview Missouri Highway

Patrol Supplement #17 13:44. ***“Jeff, Get your hand off gun”*** 20:23, before the shots were fired. Folsom further in the interview makes this statement when asked how much time past from Defendant/Victim pulled into the parking lot until shots fired ***“12 to 15 seconds, just long enough to say what are you doing with that gun”***. You can find that at 27:57 into his interview. Thus contradicting his previous statement about the papers and getting hand off the gun. By the way Folsom admits this is his second Patrol shooting. To the best of Defendants knowledge that victim did not survive. Mertens Interview MHP Supplement #13 also contends that Folsom stated that ***“Got papers right here”*** 10:33. None of these statements are on audio recording of event Valarie Weinhaus MHP Supplement #16 :20-:34. Furthermore Mertens admits that Weinhaus ***“never even turned toward me, never looked at me, never said anything to me”*** Mertens Interview MHP Supplement #13, 14:55. So much for the who, what, why and how of the alleged crime of Attempt Assault 1st Degree on Law Enforcement Officer. ***Equal Protection under the Law Article 1 Section 2 Missouri Constitution*** The police are more equal than others! As well as the Armed Criminal Action! The only ones who could even attempt to testify that Defendant/Victim attempted to kill or cause serious injury by shooting are Folsom and Mertens the ones **who did** attempt to kill or cause serious injury by shooting Defendant/Victim . It has been proven throughout their interviews that they are lying. In light of the fact (s) That both FBI Special Agents who were on the scene and witnessed the events have testified to the Highway Patrol Investigators 12 261 015 -012 Special Agent Patrick D. Cunningham ***“ When Weinhaus stopped, he was standing in a bladed position with his right side exposed to***

Agent Cunningham's view. (that would be the gun side where the weapon was holstered)
Agent Cunningham saw Weinhaus position his hands to his front waistband and at the same time observed Sgt Folsom saying something to Weinhaus but he could not hear what Sgt. Folsom was saying . He then observed Sgt Folsom raise his right hand in the air and drew his handgun with his left hand and stepped backwards . He then heard several gunshots and witnessed Weinhaus fall to the ground." 12 261 015-015

Special Agent Mike Maruschak 3 said *"he observed Weinhaus reach to his front waistband and at the same time he observed Sgt. Folsom raise his right hand and take a side step . At that point he observed Weinhaus falling to the ground."* Six other people who were on the scene September 11 2012 will testify that when

Defendant/Victim fell to the ground after the six shots fired at point black range, two hitting Defendants head and two hitting Defendant/Victim chest, Defendant/Victim **hands were empty.** How can Defendant/Victim be charged when everyone other than the ones who tried to kill him and have been to say the least less than truthful are the only ones who allege Weinhaus attempted to "draw"? As brought up in the motion to Quash it has been proven to this Court that Folsom lied to the Grand Jury, concerning the resisting arrest charge. As to the Count of Tampering the only video of the Bulletinman

Broadcast entered into evidence by the prosecution in this matter does not even mention Judge Kelly Parker. As to the Morphine Charge, pills are not even on the search warrant that was initiated absent any probable cause *Article 1 Section 15 Missouri Constitution* and was of course defective via RSMO 043.200 which has been raised before the court. Furthermore there are three very important elements essential for the crime to have been

committed. One is "mens re" (actual intent), two is "actus reus" (the actual criminal act) three "corpus dilecti" (the body of the crime) an aggrieved party, someone who was actually injured, suffered loss or who was harmed. None of the evidence even remotely constitute a crime. In this gross miscarriage of justice, Defendant/Victim acting without competent, effective assistance of counsel, has been adversely effected and to say the least prejudiced by this Prosecutors unethical and egregious behavior. ***Justice shall not be for sale denial or delay Article 1 Section 14 Missouri Constitution.***

Therefore for good cause being shown over and over again. For lack of an injured party or any element to constitute a commission of a crime by Defendant. The Court now lacking subject matter jurisdiction has no choice but to dismiss this most malicious matter. All Defendant/Victim Weinhaus did was quote the Missouri Constitution which did not constitute a threat. For that he got his computers and cameras stolen and shot four times. The United States Supreme Court (with equal justice for all on the front) has ruled that cursing public servants is a right and forms no basis for a criminal complaint or any adverse police action. Furthermore the only business protected by the United States Constitution is the Free Press. Defendant/Victim Weinhaus still acting without competent, effective assistance of counsel, concludes this matter with this thought. I have suffered the loss of my home, marriage, six pints of blood, the computers, printing press which I made a living, 180 days of my life all because of a couple of lying attempted murdering cops and a prosecutor who may be experienced but is less than professional. How I pray for them all and this Court as well. This is a

travesty of Justice. PA Parks is making a mockery of this Court and the entire justice system in Missouri. His actions rise to the level of willful misconduct in office of public officers. *Article 1 Section 16 Missouri Constitution*, He is a menace to society and should be the one on trial for allowing these troopers to so far get away with their crime against Defendant/Victim and the Citizens of this State!




