Dear Brother & Sister Davis,

It was so nice to receive your letter, thank-you! Please share my letter with others as you will. It was such a blessing to read brother Schaeffer Cox's words of encouragement, thank-you! May the Lord bless each and every soul you sent me photos of who are suffering for the truth's sake!

It was for people like these, the (USCT) Universal Supreme Court of the Tsilhqot'in was created; a court of correction & a court of finality. Under the power & the authority of the Constitution of the Tsilhqot'in Nation, my colleague, ACTJ Parsons & I can overturn every bogus & wrongful conviction of these Political Prisoners, they just have to attorn their cases to us & we will take jurisdiction as the highest court in North America & beyond. The Universal Supreme Court is the 1st international aboriginal court, administering true justice in accordance with God's word.

Although Mike Parsons, ACTJ & I, USCT Chief Justice are both being held right now in jail as political prisoners ourselves, I have nevertheless adjudicated cases while held as a hostage.

The current legal systems feel very threatened by the existence of the Universal Supreme Court and are doing everything they can to attack and discredit the USCT and the new country of the Chilcotin. For example, I served my 2015 acquittal signed by our Grand Chief Stanley Stump Sr. on the 'jail' today at which time one of the guards told me I was ~~here~~ "held on outstanding charges"! →

"Fear thou not, for I am with thee, be not dismayed for I am thy God: I will strengthen thee, yea I will help thee, yea I will uphold thee with the right hand of my righteousness." Isaiah 41:10
"All those who will live Godly in Christ Jesus shall suffer persecution". 2 Timothy 3:12
Last time I checked, that was called hostage taking or kidnapping. At least USCT arrest warrants are legitimate!

Another BC judge ordered me back to a psychiatric hospital for assessment after reading USCT orders for my release. This is now the 2nd time they are torturing me like this. The 1st time the doctor found me to be fine psychologically. They are trying desperately to discredit me and our court as well as our nation. They do not have a court of competent jurisdiction to determine the legitimacy of the new country of the Chilcotin or our court.

Yet they continue to assault those who are standing against the beast of Revelation 17. They tried to murder me several times by giving me high concentrations of ^{lead} poisoned water to drink. I now have a cyst on my right kidney and both my kidneys are compromised since incarcerated. I have been denied life saving antibiotics for my kidney infections for months, but praise the Lord He has somehow kept me alive! A nurse practitioner once told me that if I had not been so healthy prior to being in custody & had I not been drinking profuse amounts of water with the raging kidney infections "you would have had a very different outcome," she said.

Please try to reach Secretary Ben Carson for me and let him know we can help President Trump, as well as that I am a Seventh-Day Adventist too. I told Mike & Pat I am willing to testify on their behalf regarding their innocence. God bless you all! Suzanne
