Subject: A Brief Write up About Me and my Case

In 1988, I first attempted to make some health food supplement products for the sole purpose of paying for airtime while doing a talk show; as it was costing me \$10,000 per month to be on the WWCR (World Wide Christian Radio Network). I interviewed a lot of interesting people live on the air, who all expressed truth about many things including government corruption, and this probably made some enemies. But, these health supplements ended up taking on a life of their own, as I really found a new low cost treatment to remove all Viruses and Parasites (Non Toxic Copper drink), using a mineral that is normally toxic if made wrong.

In the past, I Joined the U.S. Navy when I was 17 years old, as was guaranteed a specific job/rating, as I scored 99% in aptitude for electronics and mechanics. I studied a lot of chemistry over the years; became a licensed Real Estate Broker, Insurance Broker, but I had no formal training in medicine.

So, late in the game I studied medicine, right after I discovered that I had Cancer in 1988. I was able to 100% make my Cancer go away, and then I got a degree in Naturapathe; as I wanted to do some clinical studies overseas. I wanted to be able to work with or for the Doctors Without Boarders as a volunteer. But, I found out that the U.S. is not a friendly environment towards natural medicine; and I learned that most of the non NATO Counties were much more receptive to my new concepts and ideas. So I ended up in part, working in Russia, South Africa and the Dominican Republic (over 10 different countries all). I in fact spend so much time in Russia, that I had an annual Visa (\$400) as I stayed there almost full time in 2001 and 2002.

I was never motivated by money or greed, as it was the concepts that I chased, just the concepts. Many times, I was in complete disagreement even with other Doctors in the field of Natuapathe, as I stated my opinion the way I see it. For example, I was the first Doctor of Natuapathe to lecture against consuming Calcium Carbonate as a supplement (Tums and Calcium Pills are Calcium Supplements made from Calcium Carbonate), as all of these products in my opinion actually cause Kidney Stones, Arthritis and Alzheimer's; as this product is not used by the human body to harden bones.

So, I was very careful not to make medical claims in the U.S., and therefore my marketing approach here, was done by handing out ten of thousands of free samples bottles and literature, and then collecting thousands of testimonials; and if someone wanted to buy some of these products they could just order it from one of my secretaries at WaterOz. For example, I discovered that I could remove any Virus and/or all Parasites (Malaria, River Blindness, Brain Eating Ameba and AID's), in about two hours. I never charged a single dime to diagnose or treat any person anywhere, as I gave out free samples everywhere I went, even overseas.

In the past I never had a criminal record, not even a parking ticket, never cheated and/or lied to anyone. In fact I have only one problem, and that is I do not like asking anybody for money, so my secretaries would take care of that for me. So overall this made it very difficult for the federal investigators to find anything negative to say about me; but they tried and tried for many years. So, they started out just accusing me of hateful things that were unsubstantiated. For instance, they conducted many star chamber Grand Juries against me, as they accused me of being head of two militias (I have never been to a single meeting); have followers who will kill for me (just customers who I helped); I think that I'm God (as, I was really helping people); that I live in a compound (its was a 340 acre farm) that I murdered Art Bell (note that Art Bell is my friend and he is not dead). It would seem that there was no end to what they can accuse someone of once they get started. Even after being a political prisoner for 10 full years, they again attacked me, as they came into the Atwater Prison and tried to get 20 different inmates to say that I had hired them to all be my hit men, and again no one would cooperate to lie against me. They in fact contacted any prisoner who had ever taken a picture with me, and even an person who had lived in a cell with me. Then they traveled to the late Bob Sandbergs home to meet with Bob, and then they traveled all the way to Ouray Colorado to meet with my father (Roland). It did not matter that everyone told them they were stupid and crazy as they just kept attempting to get someone new to lie against me.

So, now a person who has never spoken a single word against anyone, has been accused of endless amounts of murder for hire (160). The theory of there case is that every where I go and every meeting I ever had was just this subject of murder, as, it only took me 5 minutes to start trying to hire someone to go out and murder someone (see James Harding's testimony).

The CIA has molars, that can be put into your mouth that can record what is said; but they could never get a recording or even a phone call of me saying anything negative about anyone, let alone trying to have someone killed. It is my understanding that I have a personality that helps and cares for others, as that is what I have

spent my life doing. Now they say that I'm delusional, but I have never in the past been accused of any of this when they were all standing around being jealous of my success. The Federal Agents who have attacked me, it seemed all wanted to steal my success and cash flow for themselves; as they said I was not deserving of any of it. At the trial I overheard one USA saying: "why is he so successful, who does he think he is? He is a friend of Roger Hunt (Federal Judge in Las Vegas)?. In fact when they came to grab me at my home, I saw an appraisal of my properties (that were never owned by me), that they thought I owned on the dash board of Agent Longs vehicle (FBI Agent).

I knew that the FDA was investigating me for over five years as they even came by the factory to visit and

inspect. One FDA Agent had talked to my son Mathew and told him that he needed to put some labels on the Ozone Machine; so he sent my son labels; and these labels said that the machine made 1 gram of Ozone per hour. This was done so that they could say that my machine was a medical device. This was a set up. It would seem that then the FDA got to the IRS Involved and they brought in the FBI so that all of their buddies could get something. But all of these idiots could not do a real investigation in the real world as it is always easier to just find liars. For example when I was first arrested I was told that my house keeper a Marian Raff and her brothers from Mexico had all been hired by me to be hit men. The only thing that I knew about them is that Marian had met her new husband, on his mission for the Mormon Church and that all of these people were

When I finally came back from Russia with Roman at my side, Roman had gone over to drop of samples of all 20 of the WaterOz mineral products to Swisher's Northwest Laboratory. While there Swisher had told Roman how he had just died on the operating table two weeks before. Roman noted that the Laboratory was in Joe's garage and it was very unprofessional. Roman then went back to Swisher's home about three days later and picked up these samples, that were going to tested in Russia, and we both flew to Minneapolis and then to New York as I had some speaking engagements and Roman wanted to see me in action. At this time Roman flew back to Moscow and I flew back to Idaho. Then about 5 days later on November 12th 2002; I got an email from Roman saying that all of these samples were filed with what looked like tap water. Roman accused Mr. Swisher of sabotaging his samples (see affidavit of Roman Ponomarenko). We ended up wasting over \$1,000 for these tests. This is when I really concluded that Mr. Swisher was a federal rat.

The first arrest was based on the accusation that my labels were more than 10% misquoted. As I knew that the Northwest Laboratory was owned by Mr. Swisher (liar rat), I knew again that Mr. Swisher behind this. So can you imagine my surprise when Mr. Swisher called me up on November 23rd saying that he had heard I had been raided. I then at this time accused Mr. Swisher of this label testing fraud, and he assured me that he was innocent. Of course he blamed my employee named Chris John Patriot (his real name was Carl Waterman), of being a confidential rat; and he further stated that Mr. Patriot had sent him the samples using UPS, as he had not traveled out the the WaterOz Factory all that whole year (2002), as he had no drivers license, was to sick to travel and had been in the hospital for the last 5 months in a coma. So at this time I stated to Mr. Swisher, that if he would give me an affidavit that would be very helpful. But I still thought Mr. Swisher was up to no good; as I knew that it was really Swisher's Laboratory that had done all of the testing and he seemed to me, to be a liar. So getting this affidavit was good.

So, I never heard back from Joe for the whole month of December, and I stayed very busy fixing the labels and I even purchased an ICP (Intercoupled Plasma) Machine to do my own testing in the future; as I knew that we did not trust Mr. Swisher or his Laboratory to do any future testing.

So, on the 3rd of January, 2003, my secretary Geri Gray said that I had a call on the phone from a Mr. Swisher. I took this call in my home and Joe informed me that he had mailed me his affidavit. I thanked him for this. Then he said he had something to ask me and he went on to say that If I would give him \$500,000 in cash and 50% of my WaterOz business making him my partner, he would not go to Boise and lie against me. He stated that he was going to say that I was selling and shipping Sodium Cyanide in my Potassium Bottles. I hung the phone up on him and told all of my secretaries to no longer take any calls from him ever again. But, I felt secure in the fact that I had his signed affidavit saying that he had tested the products and they were perfect, and I again had confirmation that this man was no good.

Then about two weeks later, I took a call from the Kellogg Testing Laboratory in Kellogg Idaho, and at this time they accused me of mailing them in the US Mail a 16 oz Bottle, full of pure Sodium Cyanide, as the bottle in question had a WaterOz Potassium Label on it. I stated I did not send it, and I asked about the return address on the box, and I was then told by them, that it was the Northwest Laboratory in Cottonwood Idaho (Mr. Swisher Laboratory). With the evidence I can and have always been able to prove that Mr. Swisher was attempting to

blackmailing me on January 3rd 2002.

I was sitting in the Jail in Boise Idaho, I had a visit by my attorney Wesley Hoyt. Mr. Hoyt handed me an indictment that stated that I had hired someone name J.S. to be a hit man on or about July of 2002. Hoyt then told me that J.S. was Joseph Swisher. I told him at that time, that I knew that Mr. Swisher was in a Coma in the VA hospital the month of July; and that I was not in Idaho, and had traveled all over the world during this period of time; and that I also had Joe's affidavit. I informed him that I knew all of this as my office manger Geri Gray had been checking on his progress in the hospital as we needed to have some of our products tested for the label compliance. Thereafter, two days later the USA's superseded the indictment and now added December and January as the times that I had committed these so called crimes.

I knew that it was provable that I could not have trusted Mr. Swisher after November 22nd as he was the person who was doing the actual testing for the FDA counts. Now Mr. Swisher testifies that we are best of friends in January. Yet in his Grand Jury Testimony he had stated that I would not take his calls after the first of January. So now in all reality we have the Kellogg Testing Laboratory tests to prove that Mr. Swisher was in fact Black Mailing me.

If you read all of the Grand Jury and Trial Transcripts you will note that Mr. Swisher has told so many different stories that all conflict; as he actually a sociopathic liar.
