PLEASE TAKE IMMEDIATE NOTICE RE: Shyla Billy (foster child)

That on April 09, 2014 while in the care of Playtime Childcare Centers at the Kwaleen Daycare and After School Program facility on a drop-in basis, Shyla Billy divulged during the course of the day several acts and occurrences of abuse perpetrated on her and possibly other children while in the care of the Batke/Shaw family which I hereafter report as is my duty as a licensed Early Childhood Educator.

Background: Shyla Billy and siblings Cassius Billy and Matias Halverson have been attending Playtime Childcare Center's Kwaleen After School/ Out-of-School Program since October 2012 up until or about October 2013 at which time they discontinued attending unannounced. Ms. Heather Batke, foster mother, informed Subsidy of the discontinuance while at the same time not informing Playtime.

At all times material during providing care to said children, I, Suzanne Hegedus have never had a problem with said children, have never found Shyla to lie or exaggerate or make up stories, have never found Shyla to be aggressive toward staff or other children nor have I found Shyla to be a difficult child. On the contrary I have found Shyla to be a very pleasant student who cares deeply about others, eager and willing to help out when she can and rational, reasonable and a joy to be around not only by teachers but by other children alike.

Incident 1: Shyla said that Tom Batke, foster dad, grabbed Shyla by the throat and demanded she tell her what was wrong with her.

Incident 2: Shyla said that Heather Batke, foster mother told Shyla on the day she was moving to her foster grandmother's house, Ruth Shaw, of the Child Development Center that, "I could have beaten you up".

Incident 3: Shyla said regarding Ruth Shaw that, "You don't want to hear that woman yelling at you!"

Incident 4: Shyla stated that, "Everytime I tell someone about what they do to me they say they [Batke/Shaw] had never said that or they have never touched me and they believe them, not me."

Incident 5: Shyla said that, "They blame me for breaking up the family but I just can't take it anymore."

Incident 6: Shyla said that the Batkes told her that, "If someone would try to take the children away from them anytime then either Angela Batke, or the aunt would adopt them."

Incident 7: Shyla told me that, "I wish I could stay with you," and "You are the first person who believes me." I told Shyla that she and her brothers are always welcome to stay with me and I can take them on respite care immediately.

Incident 8: Shyla said that the Batkes screened birthing mom's calls and would not answer the phone at times, other times she was only allowed to speak to her birthing mother on speaker phone with the Batkes listening to the conversation. Shyla stated that a letter sent from her birthing mom was ripped up and never given to her, along with photographs.

Incident 9: Shyla said she was forced against her will by the Batkes to change schools in September 2013 whereat the new school she was sexually abused.

Incident 10: Shyla said that she wanted to commit suicide to get away from the Batke/Shaw family and that, "If I ran away, they [MCF] would just bring me back."

Incident 11: Shyla said that, "Sometimes I do bad things just to see if they would even notice, they just don't care about me."

Incident 12: Shyla said, "They [Batke/Shaw] call me a liar."

Incident 13: Ruth Shaw phoned me at 9:30pm, April 9, 2014 and said that, "Shyla is a very troubled little girl. She lies about everything." I told her that that is a very broad statement. Ms Shaw stated, "She is a typical FAS child".

Incident 14: During the aforesaid call Ms. Shaw angrily demanded to know why I let Shyla speak to a birthing relative on the phone and demanded to know what was said. Ms. Shaw also said that Shyla was not permitted to ever speak with any birthing relatives. I then informed Ms. Shaw I have never been told of or had documentation regarding such an order. I also informed Ms. Shaw that a parent called me regarding their child whom Shyla recognized as her birthing relative and wished to say hello. I also informed Ms. Shaw that visitors/parents speak with other children at our center on a regular basis.

Incident 15: Shyla said that Batkes are really angry that, "We believe in God and want us to believe in evolution like they do."

Incident 16: Shyla said that her foster grandmother, Ruth Shaw had left 4 other children in Shyla's care ranging from under 1 yr, 2 yrs, 4 yrs and 6 yrs while Ms. Shaw went to town. [These children also attend Playtime Childcare Centers and parent has been so informed.] [It is Ms. Shaw who believes Shyla "to be a troubled little girl" with "FAS".]

Incident 17: Shyla said she had always thought that the locks outside the children's doors at the Shaw residence were there just to scare the children but she said, "They actually use them." "Once Damian (6yrs) was locked up for 2 hours crying and saying he needed to pee but was not let out so he peed himself and then got into trouble for that."

Incident 18: Shyla said that she was bullied at her 2nd new school this school year, Marie Sharpe, after the other children found out about her recent sexual abuse. She also told me she was removed from the same school for a week (which is why Ms. Shaw brought her back to Playtime Childcare Centers on a drop-in basis) because she was cutting herself with a razor. In Shyla's words, "They [Shaw] brought me here [Playtime Childcare Centers] to 'punish' me for cutting myself."

Incident 19: When I asked her how Mr. Shaw was treating her Shyla responded by saying, "He dropped me off this morning without saying a word."

Incident 20: Shyla said she told the Batkes, "Am I just a pay check to you?"

I, Suzanne Hegedus, head manager for Playtime Childcare Centers do hereby offer my home/daycare on a respite basis to take in Shyla Billy and possible foster siblings, Cassius Billy and Matias Halverson effective immediately.

Please be advised that Playtime Childcare Centers hereby requests and expects immediate action to be taken on behalf of Shyla Billy for her physical, psychological and emotional protection, and Playtime Childcare Centers be informed of the action taken. The RCMP will be contacted later today.

ORDER

This is an appeal from a false and malicious prosecution matter from the Provincial Criminal Court of British Columbia against the appellant on sovereign Tsilhqot'in Territory whereat the Province of British Columbia has no jurisdiction or authority and whereat the sovereign Tsilhqot'in people have deemed the actions of the appellant to be heroic, not criminal:

THIS ABORIGINAL COURT ORDERS that:

- On March 15, 2015, the appellant was appointed as the Chief Justice of the Universal Supreme Court of the Tsilhqot'in at which time the foreign court of British Columbia lost jurisdiction over the appellant dignitary and erred by refusing to transfer matter 33443 to the Tsilhqot'in Nation for determination, in accordance with the protocols of the Vienna Convention on Diplomatic Relations
- 2. The appellant is exonerated of all charges, including "breach of undertaking or recognizance, contrary to section 145(3) Criminal Code," "Section 281 of the Criminal Code," and "Section 215(2)(b) of the Criminal Code," as the appellant rescued Shyla Billy from the Ministry of Children and Family Development of British Columbia who were drugging, caging and abusing her.
- The appeal is granted and all proceedings against the appellant dismissed.
- Reasons for Judgment are to follow; deposit of \$250 shall be returned to the appellant within 14 days of this order and the appellant is entitled to sue for damages.

Re: Declaration of a New Country Called the "Chilcotin" Upon Sovereign Tsilhqot in Territory

Dear Secretary General Ban Ki-moon and the General Assembly of the United Nations:

We, the collective sovereign Tsilhqot'in Nation via the government of the Chilcotin National Congress and I, Grand Chief Stanley Stump Senior, do hereby bring to the attention of, the Secretary General and all the members of the General Assembly, that we, the collective sovereign Tsilhqot'in Nation hereby assert our rights to declare ourselves, our people, our children, our land, and all that is upon our land the independent country of the "Chilcotin." [Please see attached map for boundries for the country of the Chilcotin.]

Therefore, we, the collective sovereign Tsilhqot'in Nation of the country of the Chilcotin do claim the right of independence from Canada and from the Province of British Columbia; we claim the right to self-government and autonomy, without the interference from British Columbia and Canada or any other nation, government or country[see attached *Constitution of the Tsilhqot'in Nation*, ratified on March 15, 2015] We the collective sovereign Tsilhqot'in Nation of the country of the Chilcotin, claim the right to our own law enforcement/national security, our own national-international judicial system entitled the Universal Supreme Court of the Tsilhqot'in [see attached *Universal Supreme Court Act*], our own economic system, our own health care system, our own inter-governmental relations, our own departments of welfare, agriculture, environment, child protection, transportation, citizenship, fisheries, wildlife, forestry, mining, hydro, natural resources, statistics, travel/tourism, education, revenue/taxation, without the interference from British Columbia and Canada or any other nation, government or country.

Further, we, the country of the Chilcotin do hereby come in peace before all the members of the General Assembly of the United Nations, inviting (yet not depending on) recognition and peaceful relations with other countries of the world as per our *Constitution of the Tsilhqot'in Nation*. We, the country of the Chilcotin want to inform the General Assembly of the United Nations that according to the 1933 Montevideo Convention on the Rights and Duties of States, the country of the Chilcotin is a de jure and de facto state, which a) has a permanent population, b)a defined territory, c) a government called the Chilcotin National Congress constituting both hereditary and non-hereditary officials, d) has the capacity to enter into relations with other states, including claims to diplomatic immunity and International Protected Persons status. The country of the Chilcotin hereby relies upon and adopts articles 1-16 of the

stated Convention on the Rights and Duses of States. The country of the Chiloptin particularly emphasizes article 8 & 11 which say,

8)"No state has the right to interpene in the internal or external affairs of another."

and,

ril) The contracting states definitely establish as the rule of their conduct the precise obligation not to recognize terribrial acquisitions of special advantages which have been obtained by force whether this consists in the employment of arms, in threstening diplomatic representations, or in any other effective operative measure. The territory of a state is inviolable and may not be the object of military occupation nor of other measures of force imposed by another state directly or indirectly or for any motive whatever even temporarily."

By accession and by vote, I am the Grand Chief of the country of the Chileoth on Tailingotin Territory, rightful spokesperson for the Tailingotin below and constituent to the United Nations, welcoming all people around the world, admonishing them to live in peace and copperation according to our Creator's example and design.
