ADDED COMMENTARY

OFFICIAL POLICE REPORT, PAGE 12:

SHOWS POLICE OFFICER MEYER PARAFIN-TESTED LAZOR'S HANDS AND BOOKED THE RESULTS INTO EVIDENCE. THE RESULTS SHOWED LAZOR'S HANDS SATURATED IN GUNPOWDER RESIDUE FROM THE FIRED GUN, WHICH PROVED HE COULD NOT HAVE HANDLED THE BLOODY TOWEL BECAUSE THERE WAS NO BLOOD ON HIS HANDS. (THE PROSECUTION ADMITS THIS). THESE PARAFIN TEST RESULTS WERE CONCEALED FROM THE JURY, AND THE DOCUMENTS OF THE OFFICIAL RESULTS WHICH LAZOR HAD FOR YEARS, HAVE DISAPPEARED FROM HIS FILES KEPT IN PRISON, WHILE PREPARING THIS PLEADING
