




## **DECLARATION**

First, being duly deposed, I declare as follows:

- 1. During the summer of 2000 A.D., we picked up some boxes of items belonging to our son, PF Lazor, stored by his sister, Betty Brykell, in Michigan. Betty had stored the boxes for many years for PF while he's been in prison in California (prison # C-73842).
- 2. Betty was moving from Michigan to another state and could no longer keep the boxes. It was a hectic, rushed move. Betty specifically told us of a doorknob PF always told her and us was vital to a court hearing as evidence to help prove his innocence. Betty told us the doorknob was in a shoebox inside a bag within the boxes of items we picked up.
- 3. After searching the boxes of items thoroughly at a later time, we discovered the doorknob is nowhere to be found. Some of Betty's important belongings were accidentally left behind in her house, during the rush of her move, and disposed of. It now appears to be quite certain that the doorknob was probably left in with those items that were inadvertently thrown away.

First, being duly deposed, I declare as follows:

- 1. This declaration concerns PF Lazor, a prisoner in California for the past 17 years (#C-73842). For many of those years, being his sister, I had stored his legal property until my recent relocation out of Michigan in the summer of 2000 A.D.
- 2. One of the items I'd kept carefully stored for many years, after obtaining it from PF's friends who retrieved it from his attorney, Wes Schroeder, was a doorknob. PF always emphasized the importance of keeping the doorknob in its same condition until he could present it in a court hearing to help prove his innocence. Attorney Schroeder verified to me that this doorknob was on PF's door when John Allred bashed the door open, and that police removed it.
- 3. When I moved from Michigan, I had the doorknob within boxes of items I thought were all picked up out of my home by our mother and step-father, Helen and Phil Schultz. I've since been informed by them that the doorknob is not within those boxes of items, and may have somehow been left behind in my old residence and thereafter accidentally disposed of (thrown out).
