

- 2) ARTICLE ONE SECTION TWENTY THREE MISSOURI CONSTITUTION SAYS MY RIGHT TO OWN A FIREARM SHALL NOT BE QUESTIONED. THE FIRST THING SGT. FOLSOM DOES IS QUESTION MY RIGHT TO MY LAWFULLY CARRIED LEGALLY OWNED HOLSTERED (IN A RETENTION HOLSTER) NINE MILLIMETER. IN ADDITION "THEY" VIOLATED MY FIRST, SECOND, FOURTH, FIFTH, SIXTH, EIGHTH AND FOURTEENTH AMENDMENT RIGHTS
YOUR FRIEND "JASH HAWLEY" IS ARGUING I'M OUT OF TIME ON MY JOB. HE WON'T ARGUE THE FACTS THAT I'M SETTING FORTH IN THIS APPEAL TO YOU.
- 3) SGT. HENRY FOLSOM AND CAPT. SCOTT MERTENS ARE PROVEN DOCUMENTED LIARS. GO TO LONESTAR1776.COM AND LISTEN TO THE DAY AFTER 9-12-12 AUDIO INTERVIEWS OF THE BOTH OF THEM. SGT. FOLSOM IS SO DECEPTIVE IT TAKES OVER 2 HOURS TO COVER 45 MINUTES OF LIES. BOTH CLAIM I WAS ORDERED TO REMOVE MY HAND OFF THE GUN WHICH IS NOT ON THE VIDEO OR AUDIO OF THE SHOOTING. HANDS empty. He too never saw a gun, simply because my holster was on my left side. See still shot 1/29TH of a second that reflects my green holster in the black tailgate of my Subaru on my left hip. The jury never heard from the FBI agents, nor the audio account of Marty Leach who gives a very vivid account of the Troopers actions on 9/11/12. You can find Mr. Leach's account on lonestar1776.com as well search Weinhaus February Leach. Nor did they see the still shot of my holster on my left side. The Troopers claimed in their initial reports, depositions and at trial over twenty times that my holster was on my right side. The fact that my holster is on the opposite side speaks volumes to my innocence.

- 4) The trial was so biased. Judge Sutherland sustained over 80% of the prosecution's objections. Sheriff Toebe was prohibited from testifying that the original search warrant was in violation of 043.200 ICsMO thus was unlawful and illegal. The jury saw the party's over video then the judge acquitted me and never instructed the jury to disregard it. There should have been a mistrial on that point alone. The jury was not allowed to hear about Sgt. Folsom murdering another suspect in 2001. My ineffective on purpose counsel failed to introduce any exhibits including the still shots which the jury was not allowed to see. Failed to call the FBI agents who were taken off the P.D. witness list after depositions revealed that they did not see any attempt to draw or any weapon for that matter. The bottom line is I was shot down in cold blood and the state of Missouri was colluded with the killers for the last 2000 days to keep my locked away from my family and friends.
