(U//<del>LES)</del> Develop a CHS within the AP and APM community to collect intelligence on the operational plans of the remaining militia members.

(U//<del>LES)</del> Identify any militia members who could be capable to formulate a plan to attack identified Alaskan courthouses.

(U//<del>FOUO)</del> FBI Anchorage should provide outreach to United States Marshalls Service regarding possible militia activity near the Federal Courthouse in Fairbanks, AK.

(U/FOUO) FBI Anchorage should provide outreach regarding possible militia activity to security members responsible for guarding the Alaska state courthouse in Fairbanks, AK.

(U//FOUO) Increase security within the Fairbanks State/Federal courthouses.

(U//<del>FOUO)</del> Increase security for the transporation of captured members.
