This is my 4th email about the PUBLIC OFFICE MAFIA: the crime families of judges and prosecutors of the De Facto Government, the "Deep State" of SE Michigan. These bureauRATS serve Mammon (Matthew 6:24), NOT Jesus in Monroe County, MI, often at the expense of innocent human life. The following is about their Communistic reach into MI prisons in abusive attempts to silence and reeducate us wrongfully imprisoned who stand for Right and oppose them:

I previously mentioned the 2 DEEP STATE attempts to murder me before imprisonment. They used Dursban 4E poison the 1st time, then apparently knocked me out and layed me in a pool of water with an electrical cord on my chest the 2nd time. I was instantly repelled by the caustic taste of the poison so only a small amount was swallowed. Only days earlier, I had "accidentally" put in a GFI outlet where the assailant had plugged in the electric cord so water tripped the GFI circuit breaker. Both times, God protected me.

In late 1990, two jailhouse informants named Jammer and Porter told me a member of my family would be killed if I testified at retrial. No prisoners knew of my impending retrial so this message was from the bribe-taking Prosecutor Frey and Judge Michael J. Talbot. Two weeks after retrial, someone attempted to put a bullet in my brother's head on 02 JANUARY 1991.

In prison after MARCH 1988, I survived three (3) OVERT attempts to murder me incited by the satanic PUBLIC OFFICE MAFIA with only minor injuries like broken ribs done by three 250-pound Deputy Sheriffs (2nd time), and fractured vertebrae (D7-D9) done by a jailhouse informant (3rd time). Chief Prosecutor William D. Frey lost his job and BAR license over the 1st incident, about seven (7) Deputy Sheriffs lost their jobs over the 2nd incident, and Deputy Warden Allen G. Haigh lost his job and part of his retirement (with criminal conviction) over the 3rd incident. The 3rd incident ended OVERT attempts to murder me by the MONROE COUNTY PUBLIC OFFICE MAFIA.

However, since the 3rd OVERT attempt in 1996 there have been many COVERT attempts to seriously injure or murder me coming from this "DEEP STATE" MAFIA. These COVERT attempts to harm often used denial of medical care for which CORIZON HEALTH, Inc. doctors took unlawful payments to cause me injury:

(1) On 17 MARCH 1997, a jailhouse informant put a Deer Tick on the back of my right knee as I slept. I saw MDOC Prison Guard Cleveland come out of Health Service with a brown pill bottle and give it to my cellmate. Hours later, I observed the bottle in my cellmate's desk with a small bug in the bottom of it, next to the usual bump. A few hours later, I awoke to a pinprick like a mosquito bite on the back of my right knee and saw my cellmate jump back with pinched fingers like he had held something small. I saw a smaller-than-a-ladybug type bug that was dark-brown and black on back of my right knee and immediately brushed it off. Hours later, I was moved to another cell without explanation. Three weeks later when I had a 103.6 fever and joint pains all over my body I put these prior events together.

When I went to Health Service in APRIL 1997, Dr. Franklin Messany told me, "You have a circular rash and fever but we don't care as long as you can walk to chow". I later measured my temperature at 103.6 with disposable thermometers snatched from the Health Service storage box. This fever recurred every 2.5 to 3-weeks for a year. In APRIL 1998, Dr. Jesus Neri finally prescribed Doxycycline antibiotics after telling me, "I'm leaving for a higher paying job in (sic) so I don't care what they do. It's unethical to not treat you for this".

In MAY to JULY 1998, Dr. Timothy Stallman gave me various antibiotics for 3-months to finally get rid of the repeated fevers, pneumonia-like symptoms and joint pains. That was a year of severe suffering and pain caused by Dr. Messany's initial refusal to treat Lyme Disease in APRIL 1997. This was a COVERT attempt to murder me by at least one DOCTOR of the now CORIZON HEALTH, Inc. wherein at least Dr. Messany took unlawful payments to cause me serious injury or death.

Regarding events around this denial treatment: I had been helping a lady from Connecticut save her children from the pedophile Satanists of the secret Society I'd investigated in the mid-1970s. Lyme Disease began when Russian bear furs were transported to Lyme, Connecticut. Based on the satanists' way of thinking and using their connection with the MI PUBLIC OFFICE MAFIA, they delusionally thought Lyme Disease would deter me from legal help I gave to the lady.

(2) From OCTOBER 1997 to APRIL 1998, Deputy Warden Allen Haigh had me transferred 3-times. I became very ill from this and Lyme.

(3) On 08 APRIL 2008, I was checked by Nurse Practitioner Susan H. Wilson (of the now CORIZON HEALTH, Inc.) during a scheduled Chronic-Care-Checkup. I told Wilson, "I have the beginning of strep throat" (had it many times before). Wilson said, "You'll be okay" and put "sore throat" in my record. That evening, I had a temperature of 103.6 and requested to see Health Service for fever and Strep Pneumonia. MDOC Health Unit Manager Tanya Cunningham responded to my 08 APRIL request on 15 APRIL 2008, and said I did not deserve to be treated for the fever and pneumonia because I had been to Health Service at 0800 hours on 08 APRIL. The fever went away a week later, but I kept having difficulty breathing. I instantly went from running 10-miles a day and 6-minute miles to barely being able to walk because of breathing problems. On 20 JUNE 2008, Nurse Practitioner Susan H. Wilson again saw me for the breathing problems and immediately ordered Levaquin antibiotics from a local pharmacy because I was in such bad shape that the normal ordering procedure from a St. Louis, MO pharmacy was too slow. I had been suffering from Walking Pneumonia for about 6-weeks with no treatment.
